General Description:
This bill recreates the Veterans Reintegration Task Force.
Highlighted Provisions:
This bill:
<ul> <li>recreates the Veterans Reintegration Task Force and limits its composition to not</li> </ul>
more than 21 members;
<ul> <li>requires the task force to further study the difficulties encountered by returning</li> </ul>
servicemembers after deployments and creates a statewide action plan for assisting
with:
reintegration into communities;
finding employment;
• pursuing education; and
<ul> <li>locating services for veterans;</li> </ul>
<ul> <li>charges the task force with creating a statewide action plan for collaborating,</li> </ul>
assisting, and coordinating with reintegration; and

42	Be it enacted by the Legislature of the state of Utah:
43	Section 1. Veterans Reintegration Task Force Creation Membership
44	Quorum Compensation Staff.
45	(1) There is created the Veterans Reintegration Task Force consisting of no more than
46	21 members, including the following:
47	(a) two members of the Senate appointed by the president of the Senate, no more than
48	one of whom may be from the same political party;
49	(b) three members of the House of Representatives appointed by the speaker of the
50	House of Representatives, no more than two of whom may be from the same political party;
51	(c) the executive director of the Department of Veterans and Military Affairs or the
52	director's designee;
53	(d) the executive director of the Department of Workforce Services or the director's
54	designee;
55	(e) the executive director of the Department of Health or the director's designee;
56	(f) the executive director of the Department of Human Services or the director's
57	designee;
58	(g) the director of the Division of Occupational and Professional Licensing or the

60	(h) a representative from the Administrative Office of the Courts who is
61	knowledgeable in court services and availability, appointed by the Judicial Council;
62	(i) a representative from the Utah National Guard appointed by the adjutant general;

64	Guard and Reserve;
65	(k) a representative from the Board of Regents;
66	(1) a representative from the League of Cities and Towns;
67	(m) members added to the task force by the members during the 2012 interim; and
68	(n) any other representatives of agencies or organizations the task force considers
69	necessary to complete its charge.
70	(2) (a) The president of the Senate shall designate a member of the Senate appointed
71	under Subsection (1)(a) as a cochair of the task force.
72	(b) The speaker of the House of Representatives shall designate a member of the House
73	of Representatives appointed under Subsection (1)(b) as a cochair of the task force.
74	(3) A majority of the members of the task force constitutes a quorum. The action of a
75	majority of a quorum constitutes the action of the task force.
76	(4) (a) Salaries and expenses of the members of the task force who are legislators shall
77	be paid in accordance with Section <u>36-2-2</u> and Legislative Joint Rules, Title 5, Chapter 3,
78	Legislator Compensation.
79	(b) A member of the task force who is not a legislator may not receive compensation
80	for their work associated with the task force, but may receive per diem and reimbursement for
81	travel expenses incurred as a member of the task force at the rates established by the Division
82	of Finance under Sections 63A-3-106 and 63A-3-107.
83	(5) The Office of Legislative Research and General Counsel shall provide staff support
84	to the task force.
85	Section 2. Duties Interim report.
86	(1) The task force shall review and make recommendations on the following issues:
87	(a) difficulties encountered by servicemembers returning from deployments or veterans
88	who have been separated from military service, including:

90	(ii) managing finances;
91	(iii) suicide prevention; and
92	(iv) obtaining assistance with deployment and service related health issues;
93	(b) creation of a statewide action plan for returning servicemembers, veterans, and their
94	families; and
95	(c) coordination of resources across state and local governments to assist
96	servicemembers, veterans, and their families.
97	(2) A final report, including any proposed legislation, shall be presented to the
98	Government Operations Interim Committee before November 30, 2014.
99	Section 3. Appropriation.
100	Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures Act, the
101	following sums of money are appropriated from resources not otherwise appropriated, or
102	reduced from amounts previously appropriated, out of the funds or accounts indicated for the
103	fiscal year beginning July 1, 2013, and ending June 30, 2014. These are additions to any
104	amounts previously appropriated for fiscal year 2014.
