Madam Speaker:

The Retirement and Independent Entities Committee reports a favorable recommendation on **H.B. 426**, RETIREMENT PARTICIPATION MODIFICATIONS, by Representative D. Ipson, with the following amendments and recommends it be placed on the Consent Calendar.

- 1. Page 1, Lines 14 through 16:
 - 14 allows a withdrawing entity to make an election of continued participation or
 - 15 withdrawal in a Utah retirement system or plan for future employees beginning on a
 - date, no later than January 1, $\{\frac{2015}{}\}$ and $\frac{2017}{}$, determined by the withdrawing entity;
- 2. *Page 2, Lines 41 through 47:*
 - 41 (1) As used in this section, "withdrawing entity" means an entity that:
 - 42 (a) participates in a system or plan under this title prior to July 1, 2014;
 - 43 (b) provides mental health and substance abuse services for a county under Section
 - 44 <u>17-50-318;</u> {<u>and</u>}
 - 45 (c) after beginning participation with a system or plan under this title, has modified its
 - 46 federal tax status to a nonprofit organization that qualifies under Section 501(c)(3) of the
 - 47 <u>Internal Revenue Code</u> { ; and
 - (d) is not a state institution of higher education as described in Section 53B-2-101.
- 3. Page 2, Lines 50 through 53:
 - (a) the withdrawing entity shall determine a date that is no later than January 1, {2015}
 - 51 on which the withdrawing entity shall make an election under Subsection (3); and
 - 52 (b) the withdrawing entity shall pay to the office any administrative costs reasonable actuarial and

- 53 determined by the office to have arisen out of an election made under this section.
- 4. *Page 4, Lines 93 through 95:*
 - 93 (g) an employee who is employed with a withdrawing entity that has elected, prior to
 - 94 <u>January 1</u>, {2015} <u>2017</u>, to exclude new employees from participation in this system under Subsection
 - 95 49-11-623(3).
- 5. Page 6, Lines 166 through 168:
 - 166 (g) an employee who is employed with a withdrawing entity that has elected, prior to
 - 167 <u>January 1</u>, {2015} <u>2017</u>, to exclude new employees from participation in this system under Subsection
 - 168 49-11-623(3).
- 6. Page 8, Lines 233 through 235:
 - (e) an employee who is employed with a withdrawing entity that has elected, prior to
 - 234 <u>January 1</u>, { <u>2015</u>} <u>2017</u>, to exclude new employees from participation in this system under Subsection
 - 235 <u>49-11-623(3).</u>
