MOTION: Rep. Briscoe moved to approve the minutes of February 20, 2014. The motion passed unanimously with Rep. Brown, Rep. Froerer, Rep. Gibson, Rep. Hutchings, Rep. McIff, and Rep. Sagers absent for the vote.

H.B. 55 *Income Tax Credit for Purchase of Transit Pass (Rep. M. Poulson)*

Rep. Poulson explained the bill to the committee with the assistance of Bruce Jones, Utah Transit Authority.

Spoke for the bill: Ingrid Griffee, Utah Moms for Clean Air

MOTION: Rep. Briscoe moved to pass the bill out favorably as amended on February 14, 2014. The motion passed with Rep. Anderegg and Rep. Stanard voting in opposition and Rep. Froerer and Rep. Hutchings absent for the vote.

H.B. 349 Repeal of Transportation Related Funds (*Rep. M. Brown*)

Rep. Brown explained the bill to the committee.

MOTION: Rep. Cosgrove moved to pass the bill out favorably. The motion passed unanimously with Rep. Froerer and Rep. Hutchings absent for the vote.

MOTION: Rep. Eliason moved to place HB349 on the Consent Calendar. The motion passed unanimously with Rep. Froerer and Rep. Hutchings absent for the vote.

H.B. 123 Property Tax Lien Amendments (*Rep. M. Wheatley*)

S.B. 50 Transition for Repealed Navajo Trust Fund Act (*Sen. D. Hinkins*)
