**LONG TITLE**

**General Description:**

This bill amends provisions related to the Teacher Salary Supplement Program.

**Highlighted Provisions:**

This bill:

- ▶ amends the definition of an eligible teacher;
- ▶ changes the amount of the salary supplement for eligible teachers;
- ▶ changes the entity that distributes money for the Teacher Salary Supplement Program; and
- ▶ makes technical and conforming and changes.

This bill provides a special effective date.

*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **53A-17a-156** is amended to read:



- 28           **53A-17a-156. Teacher Salary Supplement Program -- Appeal process.**  
29           (1) As used in this section:  
30           (a) "Board" means the State Board of Education.  
31           (b) "Eligible teacher" means a teacher who:  
32           (i) has an assignment to teach:  
33           (A) a secondary school level mathematics course;  
34           (B) integrated science in grade seven or eight;  
35           (C) chemistry; [or]  
36           (D) physics;  
37           (E) computer science; or  
38           (F) special education.  
39           (ii) holds the appropriate endorsement for the assigned course;  
40           (iii) has qualifying educational background; and  
41           (iv) (A) is a new employee; or  
42           (B) received a satisfactory rating or above on the teacher's most recent evaluation.  
43           (c) "Qualifying educational background" means:  
44           (i) for a teacher who is assigned a secondary school level mathematics course:  
45           (A) a bachelor's degree major, master's degree, or doctoral degree in mathematics; or  
46           (B) a bachelor's degree major, master's degree, or doctoral degree that has course  
47 requirements that are substantially equivalent to the course requirements for a bachelor's degree  
48 major, master's degree, or doctoral degree in mathematics; and  
49           (ii) for a teacher who is assigned a grade seven or eight integrated science course,  
50 chemistry course, [or] physics course, computer science course, or special education course, a  
51 bachelor's degree major, master's degree, or doctoral degree in:  
52           (A) integrated science;  
53           (B) chemistry;  
54           (C) physics;  
55           (D) physical science;  
56           (E) computer science;  
57           (F) special education;  
58           [~~(E)~~] (G) general science; or

59           ~~[(F)]~~ (H) a bachelor's degree major, master's degree, or doctoral degree that has course  
60 requirements that are substantially equivalent to the course requirements of those required for a  
61 degree listed in Subsections (1)(c)(ii)(A) through ~~[(E)]~~ (G).

62           (2) (a) Subject to future budget constraints, the Legislature shall annually appropriate  
63 money to the Teacher Salary Supplement Restricted Account established in Section  
64 53A-17a-157 to fund the Teacher Salary Supplement Program.

65           (b) Money appropriated for the Teacher Salary Supplement Program shall include  
66 money for the following employer-paid benefits:

- 67           (i) retirement;
- 68           (ii) workers' compensation;
- 69           (iii) Social Security; and
- 70           (iv) Medicare.

71           ~~[(3)(a) Beginning in fiscal year 2008-09, the annual salary supplement is \$4,100 for an~~

77           (3) (a) The annual salary supplement for an eligible teacher who is assigned full time to  
78 teach one or more courses listed in Subsections (1)(b)(i)(A) through (F) is:

- 79           (i) \$5,100 for fiscal year 2016;
- 80           (ii) \$6,100 for fiscal year 2017;
- 81           (iii) \$7,100 for fiscal year 2018;
- 82           (iv) \$8,100 for fiscal year 2019;
- 83           (v) \$9,100 for fiscal year 2020; and
- 84           (vi) \$10,000 for fiscal year 2021 and each fiscal year thereafter.

85           (b) An eligible teacher who has a part-time assignment to teach one or more courses  
86 listed in Subsections (1)(b)(i)(A) through ~~[(D)]~~ (F) shall receive a partial salary supplement  
87 based on the number of hours worked in a course assignment that meets the requirements of  
88 Subsections (1)(b)(ii) and (iii).

89           (4) The board shall:

90 (a) create an online application system for a teacher to apply to receive a salary  
91 supplement through the Teacher Salary Supplement Program;

92 (b) determine if a teacher:

93 (i) is an eligible teacher; and

94 (ii) has a course assignment as listed in Subsections (1)(b)(i)(A) through ~~[(F)]~~ (F); and

95 (c) verify, as needed, the determinations made under Subsection (4)(b) with school  
96 district and school administrators~~;~~ and].

97 ~~[(d) certify a list of eligible teachers and the amount of their salary supplement, sorted  
98 by school district and charter school, to the Division of Finance.]~~

99 (5) (a) An eligible teacher shall apply with the board before the conclusion of a school  
100 year to receive the salary supplement authorized in this section.

101 (b) An eligible teacher may apply with the board, after verification that the  
102 requirements under this section have been satisfied, to receive a salary supplement after the  
103 completion of:

104 (i) the school year as an annual award; or

105 (ii) a semester or trimester as a partial award based on the portion of the school year  
106 that has been completed.

107 (6) (a) The board shall establish and administer an appeal process for a teacher to  
108 follow if the teacher applies for the salary supplement and is not certified under Subsection  
109 (4)(d).

110 (b) (i) The appeal process established in Subsection (6)(a) shall allow a teacher to  
111 appeal on the basis that the teacher has a degree or degree major with course requirements that  
112 are substantially equivalent to the course requirements for a degree listed in Subsection  
113 (1)(c)(i)(A) or Subsections (1)(c)(ii)(A) through ~~[(E)]~~ (G).

114 (ii) A teacher shall provide transcripts and other documentation to the board in order  
115 for the board to determine if the teacher has a degree or degree major with course requirements  
116 that are substantially equivalent to the course requirements for a degree listed in Subsection  
117 (1)(c)(i)(A) or Subsections (1)(c)(ii)(A) through ~~[(E)]~~ (G).

118 (7) (a) The ~~[Division of Finance]~~ board shall distribute money from the Teacher Salary  
119 Supplement Restricted Account to school districts and charter schools for the Teacher Salary  
120 Supplement Program in accordance with the provisions of this section.

121 (b) The board shall include the employer-paid benefits described under Subsection  
122 (2)(b) in the amount of each salary supplement [~~certified to the Division of Finance~~].

123 (c) The employer-paid benefits described under Subsection (2)(b) are an addition to the  
124 salary supplement limits described under Subsection (3).

125 (8) (a) Money received from the Teacher Salary Supplement Restricted Account shall  
126 be used by a school district or charter school to provide a salary supplement equal to the  
127 amount specified in Subsection (3) for each eligible teacher.

128 (b) The salary supplement is part of the teacher's base pay, subject to the teacher's  
129 qualification as an eligible teacher every year, semester, or trimester.

130 (9) Notwithstanding the provisions of this section, if the appropriation for the program  
131 is insufficient to cover the costs associated with salary supplements, the board may limit or  
132 reduce the salary supplements.

133 Section 2. Section **53A-17a-157** is amended to read:

134 **53A-17a-157. Teacher Salary Supplement Restricted Account.**

135 (1) There is created within the Uniform School Fund a restricted account known as the  
136 "Teacher Salary Supplement Restricted Account."

137 (2) The account shall be funded from appropriations made to the account by the  
138 Legislature.

139 (3) The account shall be used to fund teacher salary supplements for school districts  
140 and charter schools as provided in Section **53A-17a-156**.

141 (4) The [~~Division of Finance~~] State Board of Education shall distribute account money  
142 to school districts and charter schools for the Teacher Salary Supplement Program as provided  
143 in Section **53A-17a-156**.

144 Section 3. **Effective date.**

145 This bill takes effect on July 1, 2015.
