**LONG TITLE**

**General Description:**

This bill modifies the Motor Vehicles code by amending provisions relating to vintage vehicles.

**Highlighted Provisions:**

This bill:

- ▶ includes a motorcycle that meets certain requirements in the definition of a vintage vehicle; and
- ▶ makes technical and conforming changes.

*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **41-21-1** is amended to read:

**41-21-1. Street rod, vintage vehicle, and vintage travel trailer defined.**

(1) (a) "Street rod" means a motor vehicle or motorcycle that:



- 28 (i) (A) was manufactured in 1948 or before; or
- 29 (B) (I) was manufactured after 1948 to resemble a vehicle that was manufactured in
- 30 1948 or before; and
- 31 (II) (Aa) has been altered from the manufacturer's original design; or
- 32 (Bb) has a body constructed from non-original materials; and
- 33 (ii) is primarily a collector's item that is used for:
- 34 (A) club activities;
- 35 (B) exhibitions;
- 36 (C) tours;
- 37 (D) parades;
- 38 (E) occasional transportation; and
- 39 (F) other similar uses.
- 40 (b) "Street rod" does not include a motor vehicle or motorcycle that is used for general,
- 41 daily transportation.
- 42 (2) (a) "Vintage travel trailer" means a travel trailer, camping trailer, or fifth wheel
- 43 trailer that is:
- 44 (i) 30 years old or older, from the current year; and
- 45 (ii) primarily a collector's item that is used for:
- 46 (A) participation in club activities;
- 47 (B) exhibitions;
- 48 (C) tours;
- 49 (D) parades;
- 50 (E) occasional recreational or vacation use; and
- 51 (F) other similar uses.
- 52 (b) "Vintage travel trailer" does not include a travel trailer, camping trailer, or fifth
- 53 wheel trailer that is used for the general, daily transportation of persons or property.
- 54 (3) (a) "Vintage vehicle" means a motor vehicle or motorcycle that:
- 55 (i) is 30 years old or older from the current year;
- 56 (ii) displays a unique vehicle type special group license plate issued in accordance
- 57 with Section [41-1a-418](#); and
- 58 (iii) is primarily a collector's item that is used for:

- 59 (A) participation in club activities;
- 60 (B) exhibitions;
- 61 (C) tours;
- 62 (D) parades;
- 63 (E) occasional transportation; and
- 64 (F) other similar uses.
- 65 (b) "Vintage vehicle" does not include a motor vehicle or motorcycle that is used for
- 66 general, daily transportation.
- 67 (c) "Vintage vehicle" includes a:
  - 68 (i) street rod; and
  - 69 (ii) vintage travel trailer.
