- ▶ requires the Division of Parks and Recreation to develop plans and ~~maintain an inventory of~~recommendations regarding historic trails within the state; and
- ▶ requires the division to report ~~on the inventory and include~~ recommendations and cost estimates to maintain and improve historic trails ~~and make recommended improvements~~.

Be it enacted by the Legislature of the state of Utah:

Section 1. Section **79-5-104** is enacted to read:

79-5-104. Historic trails -- Inventory -- Development of historic trail system --

Report.

(1) (a) As used in this section, "historic trail" means a ~~roadway, path, or~~ trail in the state that pioneers followed while immigrating to the Salt Lake Valley and other areas of the state during the mid-nineteenth century.

(b) "Historic trail" may include a recreational trail.

~~{ (2) The division shall develop and maintain an inventory of historic trails within the state.~~

~~_____ (a) mapping of the historic trails;~~
