LONG TITLE

General Description:

This bill amends provisions of the Election Code relating to inactive voters.

Highlighted Provisions:

This bill:

- ▶ repeals provisions relating to the Nominating and Recruiting Committee for the office of State Board of Education member;

- ▶ provides that candidates for the office of State Board of Education member participate in a nonpartisan primary election to narrow the number of candidates who participate in the general election;

- ▶ permits a county clerk to list a voter as inactive if the county clerk receives a returned voter identification card, determines that there was no clerical error causing the card to be returned, and has no further information to contact the voter;

- ▶ repeals the authority of a county clerk to remove a voter described in the preceding paragraph from the official register; and

- ▶ makes technical and conforming changes.

40 Section 1. Section **20A-1-102** is amended to read:

41 **20A-1-102. Definitions.**

42 As used in this title:

43 (1) "Active voter" means a registered voter who has not been classified as an inactive
44 voter by the county clerk.

45 (2) "Automatic tabulating equipment" means apparatus that automatically examines
46 and counts votes recorded on paper ballots or ballot sheets and tabulates the results.

47 (3) (a) "Ballot" means the storage medium, whether paper, mechanical, or electronic,
48 upon which a voter records the voter's votes.

49 (b) "Ballot" includes ballot sheets, paper ballots, electronic ballots, and secrecy
50 envelopes.

51 (4) "Ballot label" means the cards, papers, booklet, pages, or other materials that:

52 (a) contain the names of offices and candidates and statements of ballot propositions to
53 be voted on; and

54 (b) are used in conjunction with ballot sheets that do not display that information.

55 (5) "Ballot proposition" means a question, issue, or proposal that is submitted to voters
56 on the ballot for their approval or rejection including:

- 57 (a) an opinion question specifically authorized by the Legislature;
- 58 (b) a constitutional amendment;
- 59 (c) an initiative;
- 60 (d) a referendum;
- 61 (e) a bond proposition;
- 62 (f) a judicial retention question;
- 63 (g) an incorporation of a city or town; or
- 64 (h) any other ballot question specifically authorized by the Legislature.
- 65 (6) "Ballot sheet":
- 66 (a) means a ballot that:
- 67 (i) consists of paper or a card where the voter's votes are marked or recorded; and
- 68 (ii) can be counted using automatic tabulating equipment; and
- 69 (b) includes punch card ballots and other ballots that are machine-countable.
- 70 (7) "Bind," "binding," or "bound" means securing more than one piece of paper
- 71 together with a staple or stitch in at least three places across the top of the paper in the blank
- 72 space reserved for securing the paper.
- 73 (8) "Board of canvassers" means the entities established by Sections [20A-4-301](#) and
- 74 [20A-4-306](#) to canvass election returns.
- 75 (9) "Bond election" means an election held for the purpose of approving or rejecting
- 76 the proposed issuance of bonds by a government entity.
- 77 (10) "Book voter registration form" means voter registration forms contained in a
- 78 bound book that are used by election officers and registration agents to register persons to vote.
- 79 (11) "Business reply mail envelope" means an envelope that may be mailed free of
- 80 charge by the sender.
- 81 (12) "By-mail voter registration form" means a voter registration form designed to be
- 82 completed by the voter and mailed to the election officer.
- 83 (13) "Canvass" means the review of election returns and the official declaration of
- 84 election results by the board of canvassers.
- 85 (14) "Canvassing judge" means a poll worker designated to assist in counting ballots at
- 86 the canvass.
- 87 (15) "Contracting election officer" means an election officer who enters into a contract

88 or interlocal agreement with a provider election officer.

89 (16) "Convention" means the political party convention at which party officers and
90 delegates are selected.

91 (17) "Counting center" means one or more locations selected by the election officer in
92 charge of the election for the automatic counting of ballots.

93 (18) "Counting judge" means a poll worker designated to count the ballots during
94 election day.

95 (19) "Counting poll watcher" means a person selected as provided in Section
96 20A-3-201 to witness the counting of ballots.

97 (20) "Counting room" means a suitable and convenient private place or room,
98 immediately adjoining the place where the election is being held, for use by the poll workers
99 and counting judges to count ballots during election day.

100 (21) "County officers" means those county officers that are required by law to be
101 elected.

102 (22) "Date of the election" or "election day" or "day of the election":

103 (a) means the day that is specified in the calendar year as the day that the election
104 occurs; and

105 (b) does not include:

106 (i) deadlines established for absentee voting; or

107 (ii) any early voting or early voting period as provided under Chapter 3, Part 6, Early
108 Voting.

109 (23) "Elected official" means:

110 (a) a person elected to an office under Section 20A-1-303;

111 (b) a person who is considered to be elected to a municipal office in accordance with
112 Subsection 20A-1-206(1)(c)(ii); or

113 (c) a person who is considered to be elected to a local district office in accordance with
114 Subsection 20A-1-206(3)(c)(ii).

115 (24) "Election" means a regular general election, a municipal general election, a
116 statewide special election, a local special election, a regular primary election, a municipal
117 primary election, and a local district election.

118 (25) "Election Assistance Commission" means the commission established by [Public

119 ~~Law 107-252,~~] the Help America Vote Act of 2002, Pub. L. No. 107-252.

120 (26) "Election cycle" means the period beginning on the first day persons are eligible to
121 file declarations of candidacy and ending when the canvass is completed.

122 (27) "Election judge" means a poll worker that is assigned to:

- 123 (a) preside over other poll workers at a polling place;
124 (b) act as the presiding election judge; or
125 (c) serve as a canvassing judge, counting judge, or receiving judge.

126 (28) "Election officer" means:

- 127 (a) the lieutenant governor, for all statewide ballots and elections;
128 (b) the county clerk for:
129 (i) a county ballot and election; and
130 (ii) a ballot and election as a provider election officer as provided in Section

131 [20A-5-400.1](#) or [20A-5-400.5](#);

132 (c) the municipal clerk for:

- 133 (i) a municipal ballot and election; and
134 (ii) a ballot and election as a provider election officer as provided in Section

135 [20A-5-400.1](#) or [20A-5-400.5](#);

136 (d) the local district clerk or chief executive officer for:

- 137 (i) a local district ballot and election; and
138 (ii) a ballot and election as a provider election officer as provided in Section

139 [20A-5-400.1](#) or [20A-5-400.5](#); or

140 (e) the business administrator or superintendent of a school district for:

- 141 (i) a school district ballot and election; and
142 (ii) a ballot and election as a provider election officer as provided in Section

143 [20A-5-400.1](#) or [20A-5-400.5](#).

144 (29) "Election official" means any election officer, election judge, or poll worker.

145 (30) "Election results" means:

146 (a) for an election other than a bond election, the count of votes cast in the election and
147 the election returns requested by the board of canvassers; or

148 (b) for bond elections, the count of those votes cast for and against the bond
149 proposition plus any or all of the election returns that the board of canvassers may request.

150 (31) "Election returns" includes the pollbook, the military and overseas absentee voter
151 registration and voting certificates, one of the tally sheets, any unprocessed absentee ballots, all
152 counted ballots, all excess ballots, all unused ballots, all spoiled ballots, the ballot disposition
153 form, and the total votes cast form.

154 (32) "Electronic ballot" means a ballot that is recorded using a direct electronic voting
155 device or other voting device that records and stores ballot information by electronic means.

156 (33) "Electronic signature" means an electronic sound, symbol, or process attached to
157 or logically associated with a record and executed or adopted by a person with the intent to sign
158 the record.

159 (34) (a) "Electronic voting device" means a voting device that uses electronic ballots.

160 (b) "Electronic voting device" includes a direct recording electronic voting device.

161 (35) "Inactive voter" means a registered voter who [~~has: (a) been sent the notice~~
162 ~~required by Section 20A-2-306; and (b) failed to respond to that notice.~~] is listed as inactive by
163 a county clerk under Subsection 20A-2-306(4)(c)(i) or (ii).

164 (36) "Inspecting poll watcher" means a person selected as provided in this title to
165 witness the receipt and safe deposit of voted and counted ballots.

166 (37) "Judicial office" means the office filled by any judicial officer.

167 (38) "Judicial officer" means any justice or judge of a court of record or any county
168 court judge.

169 (39) "Local district" means a local government entity under Title 17B, Limited Purpose
170 Local Government Entities - Local Districts, and includes a special service district under Title
171 17D, Chapter 1, Special Service District Act.

172 (40) "Local district officers" means those local district board members that are required
173 by law to be elected.

174 (41) "Local election" means a regular county election, a regular municipal election, a
175 municipal primary election, a local special election, a local district election, and a bond
176 election.

177 (42) "Local political subdivision" means a county, a municipality, a local district, or a
178 local school district.

179 (43) "Local special election" means a special election called by the governing body of a
180 local political subdivision in which all registered voters of the local political subdivision may

181 vote.

182 (44) "Municipal executive" means:

183 (a) the mayor in the council-mayor form of government defined in Section 10-3b-102;

184 (b) the mayor in the council-manager form of government defined in Subsection

185 10-3b-103(7); or

186 (c) the chair of a metro township form of government defined in Section 10-3b-102.

187 (45) "Municipal general election" means the election held in municipalities and, as

188 applicable, local districts on the first Tuesday after the first Monday in November of each

189 odd-numbered year for the purposes established in Section 20A-1-202.

190 (46) "Municipal legislative body" means:

191 (a) the council of the city or town in any form of municipal government; or

192 (b) the council of a metro township.

193 (47) "Municipal office" means an elective office in a municipality.

194 (48) "Municipal officers" means those municipal officers that are required by law to be

195 elected.

196 (49) "Municipal primary election" means an election held to nominate candidates for

197 municipal office.

198 (50) "Official ballot" means the ballots distributed by the election officer to the poll

199 workers to be given to voters to record their votes.

200 (51) "Official endorsement" means:

201 (a) the information on the ballot that identifies:

202 (i) the ballot as an official ballot;

203 (ii) the date of the election; and

204 (iii) (A) for a ballot prepared by an election officer other than a county clerk, the

205 facsimile signature required by Subsection 20A-6-401(1)(b)(iii); or

206 (B) for a ballot prepared by a county clerk, the words required by Subsection

207 20A-6-301(1)(c)(iii); and

208 (b) the information on the ballot stub that identifies:

209 (i) the poll worker's initials; and

210 (ii) the ballot number.

211 (52) "Official register" means the official record furnished to election officials by the

212 election officer that contains the information required by Section [20A-5-401](#).

213 (53) "Paper ballot" means a paper that contains:

214 (a) the names of offices and candidates and statements of ballot propositions to be
215 voted on; and

216 (b) spaces for the voter to record the voter's vote for each office and for or against each
217 ballot proposition.

218 (54) "Pilot project" means the election day voter registration pilot project created in
219 Section [20A-4-108](#).

220 (55) "Political party" means an organization of registered voters that has qualified to
221 participate in an election by meeting the requirements of Chapter 8, Political Party Formation
222 and Procedures.

223 (56) "Pollbook" means a record of the names of voters in the order that they appear to
224 cast votes.

225 (57) "Polling place" means the building where voting is conducted.

226 (58) (a) "Poll worker" means a person assigned by an election official to assist with an
227 election, voting, or counting votes.

228 (b) "Poll worker" includes election judges.

229 (c) "Poll worker" does not include a watcher.

230 (59) "Position" means a square, circle, rectangle, or other geometric shape on a ballot
231 in which the voter marks the voter's choice.

232 (60) "Primary convention" means the political party conventions held during the year
233 of the regular general election.

234 (61) "Protective counter" means a separate counter, which cannot be reset, that:

235 (a) is built into a voting machine; and

236 (b) records the total number of movements of the operating lever.

237 (62) "Provider election officer" means an election officer who enters into a contract or
238 interlocal agreement with a contracting election officer to conduct an election for the
239 contracting election officer's local political subdivision in accordance with Section
240 [20A-5-400.1](#).

241 (63) "Provisional ballot" means a ballot voted provisionally by a person:

242 (a) whose name is not listed on the official register at the polling place;

243 (b) whose legal right to vote is challenged as provided in this title; or

244 (c) whose identity was not sufficiently established by a poll worker.

245 (64) "Provisional ballot envelope" means an envelope printed in the form required by
246 Section [20A-6-105](#) that is used to identify provisional ballots and to provide information to
247 verify a person's legal right to vote.

248 (65) "Qualify" or "qualified" means to take the oath of office and begin performing the
249 duties of the position for which the person was elected.

250 (66) "Receiving judge" means the poll worker that checks the voter's name in the
251 official register, provides the voter with a ballot, and removes the ballot stub from the ballot
252 after the voter has voted.

253 (67) "Registration form" means a book voter registration form and a by-mail voter
254 registration form.

255 (68) "Regular ballot" means a ballot that is not a provisional ballot.

256 (69) "Regular general election" means the election held throughout the state on the first
257 Tuesday after the first Monday in November of each even-numbered year for the purposes
258 established in Section [20A-1-201](#).

259 (70) "Regular primary election" means the election on the fourth Tuesday of June of
260 each even-numbered year, to nominate candidates of political parties and candidates for
261 nonpartisan State School Board and local school board positions to advance to the regular
262 general election.

263 (71) "Resident" means a person who resides within a specific voting precinct in Utah.

264 (72) "Sample ballot" means a mock ballot similar in form to the official ballot printed
265 and distributed as provided in Section [20A-5-405](#).

266 (73) "Scratch vote" means to mark or punch the straight party ticket and then mark or
267 punch the ballot for one or more candidates who are members of different political parties or
268 who are unaffiliated.

269 (74) "Secrecy envelope" means the envelope given to a voter along with the ballot into
270 which the voter places the ballot after the voter has voted it in order to preserve the secrecy of
271 the voter's vote.

272 (75) "Special election" means an election held as authorized by Section [20A-1-203](#).

273 (76) "Spoiled ballot" means each ballot that:

- 274 (a) is spoiled by the voter;
- 275 (b) is unable to be voted because it was spoiled by the printer or a poll worker; or
- 276 (c) lacks the official endorsement.
- 277 (77) "Statewide special election" means a special election called by the governor or the
- 278 Legislature in which all registered voters in Utah may vote.
- 279 (78) "Stub" means the detachable part of each ballot.
- 280 (79) "Substitute ballots" means replacement ballots provided by an election officer to
- 281 the poll workers when the official ballots are lost or stolen.
- 282 (80) "Ticket" means each list of candidates for each political party or for each group of
- 283 petitioners.
- 284 (81) "Transfer case" means the sealed box used to transport voted ballots to the
- 285 counting center.
- 286 (82) "Vacancy" means the absence of a person to serve in any position created by
- 287 statute, whether that absence occurs because of death, disability, disqualification, resignation,
- 288 or other cause.
- 289 (83) "Valid voter identification" means:
- 290 (a) a form of identification that bears the name and photograph of the voter which may
- 291 include:
- 292 (i) a currently valid Utah driver license;
- 293 (ii) a currently valid identification card that is issued by:
- 294 (A) the state; or
- 295 (B) a branch, department, or agency of the United States;
- 296 (iii) a currently valid Utah permit to carry a concealed weapon;
- 297 (iv) a currently valid United States passport; or
- 298 (v) a currently valid United States military identification card;
- 299 (b) one of the following identification cards, whether or not the card includes a
- 300 photograph of the voter:
- 301 (i) a valid tribal identification card;
- 302 (ii) a Bureau of Indian Affairs card; or
- 303 (iii) a tribal treaty card; or
- 304 (c) two forms of identification not listed under Subsection (83)(a) or (b) but that bear

305 the name of the voter and provide evidence that the voter resides in the voting precinct, which
306 may include:

307 (i) a current utility bill or a legible copy thereof, dated within the 90 days before the
308 election;

309 (ii) a bank or other financial account statement, or a legible copy thereof;

310 (iii) a certified birth certificate;

311 (iv) a valid Social Security card;

312 (v) a check issued by the state or the federal government or a legible copy thereof;

313 (vi) a paycheck from the voter's employer, or a legible copy thereof;

314 (vii) a currently valid Utah hunting or fishing license;

315 (viii) certified naturalization documentation;

316 (ix) a currently valid license issued by an authorized agency of the United States;

317 (x) a certified copy of court records showing the voter's adoption or name change;

318 (xi) a valid Medicaid card, Medicare card, or Electronic Benefits Transfer Card;

319 (xii) a currently valid identification card issued by:

320 (A) a local government within the state;

321 (B) an employer for an employee; or

322 (C) a college, university, technical school, or professional school located within the
323 state; or

324 (xiii) a current Utah vehicle registration.

325 (84) "Valid write-in candidate" means a candidate who has qualified as a write-in
326 candidate by following the procedures and requirements of this title.

327 (85) "Voter" means a person who:

328 (a) meets the requirements for voting in an election;

329 (b) meets the requirements of election registration;

330 (c) is registered to vote; and

331 (d) is listed in the official register book.

332 (86) "Voter registration deadline" means the registration deadline provided in Section
333 [20A-2-102.5](#).

334 (87) "Voting area" means the area within six feet of the voting booths, voting
335 machines, and ballot box.

- 336 (88) "Voting booth" means:
- 337 (a) the space or compartment within a polling place that is provided for the preparation
- 338 of ballots, including the voting machine enclosure or curtain; or
- 339 (b) a voting device that is free standing.
- 340 (89) "Voting device" means:
- 341 (a) an apparatus in which ballot sheets are used in connection with a punch device for
- 342 piercing the ballots by the voter;
- 343 (b) a device for marking the ballots with ink or another substance;
- 344 (c) an electronic voting device or other device used to make selections and cast a ballot
- 345 electronically, or any component thereof;
- 346 (d) an automated voting system under Section [20A-5-302](#); or
- 347 (e) any other method for recording votes on ballots so that the ballot may be tabulated
- 348 by means of automatic tabulating equipment.
- 349 (90) "Voting machine" means a machine designed for the sole purpose of recording
- 350 and tabulating votes cast by voters at an election.
- 351 (91) "Voting poll watcher" means a person appointed as provided in this title to
- 352 witness the distribution of ballots and the voting process.
- 353 (92) "Voting precinct" means the smallest voting unit established as provided by law
- 354 within which qualified voters vote at one polling place.
- 355 (93) "Watcher" means a voting poll watcher, a counting poll watcher, an inspecting
- 356 poll watcher, and a testing watcher.
- 357 (94) "Western States Presidential Primary" means the election established in Chapter 9,
- 358 Part 8, Western States Presidential Primary.
- 359 (95) "Write-in ballot" means a ballot containing any write-in votes.
- 360 (96) "Write-in vote" means a vote cast for a person whose name is not printed on the
- 361 ballot according to the procedures established in this title.
- 362 Section 2. Section **20A-2-305** is amended to read:
- 363 **20A-2-305. Removing names from the official register -- General requirements.**
- 364 (1) The county clerk may not remove a voter's name from the official register because
- 365 the voter has failed to vote in an election.
- 366 (2) The county clerk shall remove a voter's name from the official register if:

- 367 (a) the voter dies and the requirements of Subsection (3) are met;
- 368 (b) the county clerk, after complying with the requirements of Section 20A-2-306,
- 369 receives written confirmation from the voter that the voter no longer resides within the county
- 370 clerk's county;
- 371 (c) the county clerk has:
 - 372 (i) obtained evidence that the voter's residence has changed;
 - 373 (ii) mailed notice to the voter as required by Section 20A-2-306;
 - 374 (iii) (A) received no response from the voter; or
 - 375 (B) not received information that confirms the voter's residence; and
 - 376 (iv) the voter has failed to vote or appear to vote in an election during the period
 - 377 beginning on the date of the notice described in Section 20A-2-306 and ending on the day after
 - 378 the date of the second regular general election occurring after the date of the notice;

- 392 Section 3. Section 20A-2-306 is amended to read:
- 393 **20A-2-306. Removing names from the official register -- Determining and**
- 394 **confirming change of residence.**
- 395 (1) A county clerk may not remove a voter's name from the official register on the
- 396 grounds that the voter has changed residence unless the voter:
 - 397 (a) confirms in writing that the voter has changed residence to a place outside the

398 county; or

399 (b) (i) has not voted in an election during the period beginning on the date of the notice
400 required by Subsection (3), and ending on the day after the date of the second regular general
401 election occurring after the date of the notice; and

402 (ii) has failed to respond to the notice required by Subsection (3).

403 (2) (a) When a county clerk obtains information that a voter's address has changed and
404 it appears that the voter still resides within the same county, the county clerk shall:

405 (i) change the official register to show the voter's new address; and

406 (ii) send to the voter, by forwardable mail, the notice required by Subsection (3)
407 printed on a postage prepaid, preaddressed return form.

408 (b) When a county clerk obtains information that a voter's address has changed and it

412 (3) Each county clerk shall use substantially the following form to notify voters whose

416 return this form so that we can update our voter registration records. What is your current

420 If you have not changed your residence or have moved but stayed within the same
421 county, you must complete and return this form to the county clerk so that it is received by the
422 county clerk no later than 30 days before the date of the election. If you fail to return this form
423 within that time:

424 - you may be required to show evidence of your address to the poll worker before being
425 allowed to vote in either of the next two regular general elections; or

426 - if you fail to vote at least once from the date this notice was mailed until the passing
427 of two regular general elections, you will no longer be registered to vote. If you have changed
428 your residence and have moved to a different county in Utah, you may register to vote by

429 contacting the county clerk in your county.

Signature of Voter"

432 "The portion of a voter registration form that lists a person's driver license or
433 identification card number, social security number, and email address is a private record. The
434 portion of a voter registration form that lists a person's date of birth is a private record, the use
435 of which is restricted to government officials, government employees, political parties, or
436 certain other persons.

437 If you believe that disclosure of any information contained in this voter registration
438 form to a person other than a government official or government employee is likely to put you
439 or a member of your household's life or safety at risk, or to put you or a member of your
440 household at risk of being stalked or harassed, you may apply to the lieutenant governor or your
441 county clerk to have your entire voter registration record classified as private."

442 (4) (a) Except as provided in Subsection (4)(b), the county clerk may not remove the
443 names of any voters from the official register during the 90 days before a regular primary
444 election and the 90 days before a regular general election.

445 (b) The county clerk may remove the names of voters from the official register during
446 the 90 days before a regular primary election and the 90 days before a regular general election
447 if:

448 (i) the voter requests, in writing, that the voter's name be removed; or

449 (ii) the voter has died.

450 (c) (i) After a county clerk mails a notice as required in this section, the county clerk
451 may list that voter as inactive.

452 (ii) If a county clerk receives a returned voter identification card, determines that there

907 Section 8. **Effective date.**

908 If approved by two-thirds of all the members elected to each house, this bill takes effect
909 upon approval by the governor, or the day following the constitutional time limit of Utah
910 Constitution, Article VII, Section 8, without the governor's signature, or in the case of a veto,
911 the date of veto override.
