8                   **LONG TITLE**

9                   **Committee Note:**

10                   The Retirement and Independent Entities Interim Committee recommended this bill.

11                   **General Description:**

12                   This bill modifies the Utah State Retirement and Insurance Benefit Act by amending  
13 provisions related to public information.

14                   **Highlighted Provisions:**

15                   This bill:

- 16                   ▶ requires the Utah State Retirement Systems (URS) to provide employee  
17 compensation information on its website;
- 18                   ▶ requires URS to provide advance public notice of administrative board meetings on  
19 the Utah Public Notice Website;
- 20                   ▶ requires URS to establish policies for time limits to respond to information  
21 requests; and
- 22                   ▶ makes technical changes.

34 *Be it enacted by the Legislature of the state of Utah:*

35 **Part 11. Public Information Disclosure**

36 Section 1. Section **49-11-1101** is amended to read:

37 **49-11-1101. Public financial information disclosure on website -- Exclusions.**

38 (1) The office shall provide the following financial information for the public on its  
39 website:

40 (a) administrative expense transactions from its general ledger accounting system; and

41 (b) [~~aggregated~~] employee compensation information by [~~department~~] individual  
42 employee at least annually.

43 (2) For purposes of this part, the office is not required to provide other information for  
44 public access on its website, if the disclosure of the information would conflict with the  
45 fiduciary obligations of the board, including:

46 (a) revenue transactions; and

47 (b) member and participant information.

48 Section 2. Section **49-11-1102** is enacted to read:

49 **49-11-1102. Public notice of administrative board meetings -- Posting on Utah**  
50 **Public Notice Website.**

51 (1) The office shall provide advance public notice of meetings and agendas on the Utah  
52 Public Notice Website established in Section 63F-1-701 for administrative board meetings.

53 (2) The office may post other public materials, as directed by the board, on the Utah  
54 Public Notice Website.

55 Section 3. Section **49-11-1103** is enacted to read:

56 **49-11-1103. Public information requests.**

57 The office shall establish, in policy, time limits to respond to public information  
58 requests.
