**LONG TITLE**

31 *Be it enacted by the Legislature of the state of Utah:*

32 Section 1. Section **20A-1-102** is amended to read:

33 **20A-1-102. Definitions.**

34 As used in this title:

35 (1) "Active voter" means a registered voter who has not been classified as an inactive  
36 voter by the county clerk.

37 (2) "Automatic tabulating equipment" means apparatus that automatically examines  
38 and counts votes recorded on paper ballots or ballot sheets and tabulates the results.

39 (3) (a) "Ballot" means the storage medium, whether paper, mechanical, or electronic,  
40 upon which a voter records the voter's votes.

41 (b) "Ballot" includes ballot sheets, paper ballots, electronic ballots, and secrecy  
42 envelopes.

43 (4) "Ballot label" means the cards, papers, booklet, pages, or other materials that:

44 (a) contain the names of offices and candidates and statements of ballot propositions to  
45 be voted on; and

46 (b) are used in conjunction with ballot sheets that do not display that information.

47 (5) "Ballot proposition" means a question, issue, or proposal that is submitted to voters  
48 on the ballot for their approval or rejection including:

49 (a) an opinion question specifically authorized by the Legislature;

50 (b) a constitutional amendment;

51 (c) an initiative;

52 (d) a referendum;

53 (e) a bond proposition;

54 (f) a judicial retention question;

55 (g) an incorporation of a city or town; or

56 (h) any other ballot question specifically authorized by the Legislature.

57 (6) "Ballot sheet":

58 (a) means a ballot that:

59 (i) consists of paper or a card where the voter's votes are marked or recorded; and

60 (ii) can be counted using automatic tabulating equipment; and

61 (b) includes punch card ballots and other ballots that are machine-countable.

62 (7) "Bind," "binding," or "bound" means securing more than one piece of paper  
63 together with a staple or stitch in at least three places across the top of the paper in the blank  
64 space reserved for securing the paper.

65 (8) "Board of canvassers" means the entities established by Sections [20A-4-301](#) and  
66 [20A-4-306](#) to canvass election returns.

67 (9) "Bond election" means an election held for the purpose of approving or rejecting  
68 the proposed issuance of bonds by a government entity.

69 (10) "Book voter registration form" means voter registration forms contained in a  
70 bound book that are used by election officers and registration agents to register persons to vote.

71 (11) "Business reply mail envelope" means an envelope that may be mailed free of  
72 charge by the sender.

73 (12) "By-mail voter registration form" means a voter registration form designed to be  
74 completed by the voter and mailed to the election officer.

75 (13) "Canvass" means the review of election returns and the official declaration of  
76 election results by the board of canvassers.

77 (14) "Canvassing judge" means a poll worker designated to assist in counting ballots at  
78 the canvass.

79 (15) "Contracting election officer" means an election officer who enters into a contract  
80 or interlocal agreement with a provider election officer.

81 (16) "Convention" means the political party convention at which party officers and  
82 delegates are selected.

83 (17) "Counting center" means one or more locations selected by the election officer in  
84 charge of the election for the automatic counting of ballots.

85 (18) "Counting judge" means a poll worker designated to count the ballots during  
86 election day.

87 (19) "Counting poll watcher" means a person selected as provided in Section  
88 [20A-3-201](#) to witness the counting of ballots.

89 (20) "Counting room" means a suitable and convenient private place or room,

90 immediately adjoining the place where the election is being held, for use by the poll workers  
91 and counting judges to count ballots during election day.

92 (21) "County officers" means those county officers that are required by law to be  
93 elected.

94 (22) "Date of the election" or "election day" or "day of the election":

95 (a) means the day that is specified in the calendar year as the day that the election  
96 occurs; and

97 (b) does not include:

98 (i) deadlines established for absentee voting; or

99 (ii) any early voting or early voting period as provided under Chapter 3, Part 6, Early  
100 Voting.

101 (23) "Elected official" means:

102 (a) a person elected to an office under Section 20A-1-303;

103 (b) a person who is considered to be elected to a municipal office in accordance with  
104 Subsection 20A-1-206(1)(c)(ii); or

105 (c) a person who is considered to be elected to a local district office in accordance with  
106 Subsection 20A-1-206(3)(c)(ii).

107 (24) "Election" means a regular general election, a municipal general election, a  
108 statewide special election, a local special election, a regular primary election, a municipal  
109 primary election, and a local district election.

110 (25) "Election Assistance Commission" means the commission established by [~~Public~~  
111 ~~Law 107-252, the Help America Vote Act of 2002.~~] the Help America Vote Act of 2002, Pub.  
112 L. No. 107-252.

113 (26) "Election cycle" means the period beginning on the first day persons are eligible to  
114 file declarations of candidacy and ending when the canvass is completed.

115 (27) "Election judge" means a poll worker that is assigned to:

116 (a) preside over other poll workers at a polling place;

117 (b) act as the presiding election judge; or

118 (c) serve as a canvassing judge, counting judge, or receiving judge.

119 (28) "Election officer" means:

120 (a) the lieutenant governor, for all statewide ballots and elections;

- 121 (b) the county clerk for:
- 122 (i) a county ballot and election; and
- 123 (ii) a ballot and election as a provider election officer as provided in Section
- 124 [20A-5-400.1](#) or [20A-5-400.5](#);
- 125 (c) the municipal clerk for:
- 126 (i) a municipal ballot and election; and
- 127 (ii) a ballot and election as a provider election officer as provided in Section
- 128 [20A-5-400.1](#) or [20A-5-400.5](#);
- 129 (d) the local district clerk or chief executive officer for:
- 130 (i) a local district ballot and election; and
- 131 (ii) a ballot and election as a provider election officer as provided in Section
- 132 [20A-5-400.1](#) or [20A-5-400.5](#); or
- 133 (e) the business administrator or superintendent of a school district for:
- 134 (i) a school district ballot and election; and
- 135 (ii) a ballot and election as a provider election officer as provided in Section
- 136 [20A-5-400.1](#) or [20A-5-400.5](#).
- 137 (29) "Election official" means any election officer, election judge, or poll worker.
- 138 (30) "Election results" means:
- 139 (a) for an election other than a bond election, the count of votes cast in the election and
- 140 the election returns requested by the board of canvassers; or
- 141 (b) for bond elections, the count of those votes cast for and against the bond
- 142 proposition plus any or all of the election returns that the board of canvassers may request.
- 143 (31) "Election returns" includes the pollbook, the military and overseas absentee voter
- 144 registration and voting certificates, one of the tally sheets, any unprocessed absentee ballots, all
- 145 counted ballots, all excess ballots, all unused ballots, all spoiled ballots, the ballot disposition
- 146 form, and the total votes cast form.
- 147 (32) "Electronic ballot" means a ballot that is recorded using a direct electronic voting
- 148 device or other voting device that records and stores ballot information by electronic means.
- 149 (33) "Electronic signature" means an electronic sound, symbol, or process attached to
- 150 or logically associated with a record and executed or adopted by a person with the intent to sign
- 151 the record.

152 (34) (a) "Electronic voting device" means a voting device that uses electronic ballots.

153 (b) "Electronic voting device" includes a direct recording electronic voting device.

154 (35) "Inactive voter" means a registered voter who has:

155 (a) been sent the notice required by Section 20A-2-306; and

156 (b) failed to respond to that notice.

157 (36) "Inspecting poll watcher" means a person selected as provided in this title to  
158 witness the receipt and safe deposit of voted and counted ballots.

159 (37) "Judicial office" means the office filled by any judicial officer.

160 (38) "Judicial officer" means any justice or judge of a court of record or any county  
161 court judge.

162 (39) "Local district" means a local government entity under Title 17B, Limited Purpose  
163 Local Government Entities - Local Districts, and includes a special service district under Title  
164 17D, Chapter 1, Special Service District Act.

165 (40) "Local district officers" means those local district board members that are required  
166 by law to be elected.

167 (41) "Local election" means a regular county election, a regular municipal election, a  
168 municipal primary election, a local special election, a local district election, and a bond  
169 election.

170 (42) "Local political subdivision" means a county, a municipality, a local district, or a  
171 local school district.

172 (43) "Local special election" means a special election called by the governing body of a  
173 local political subdivision in which all registered voters of the local political subdivision may  
174 vote.

175 (44) "Municipal executive" means:

176 (a) the mayor in the council-mayor form of government defined in Section 10-3b-102;

177 (b) the mayor in the council-manager form of government defined in Subsection  
178 10-3b-103(7); or

179 (c) the chair of a metro township form of government defined in Section 10-3b-102.

180 (45) "Municipal general election" means the election held in municipalities and, as  
181 applicable, local districts on the first Tuesday after the first Monday in November of each  
182 odd-numbered year for the purposes established in Section 20A-1-202.

- 183 (46) "Municipal legislative body" means:  
184 (a) the council of the city or town in any form of municipal government; or  
185 (b) the council of a metro township.
- 186 (47) "Municipal office" means an elective office in a municipality.
- 187 (48) "Municipal officers" means those municipal officers that are required by law to be  
188 elected.
- 189 (49) "Municipal primary election" means an election held to nominate candidates for  
190 municipal office.
- 191 (50) "Official ballot" means the ballots distributed by the election officer to the poll  
192 workers to be given to voters to record their votes.
- 193 (51) "Official endorsement" means:  
194 (a) the information on the ballot that identifies:  
195 (i) the ballot as an official ballot;  
196 (ii) the date of the election; and  
197 (iii) (A) for a ballot prepared by an election officer other than a county clerk, the  
198 facsimile signature required by Subsection 20A-6-401(1)(b)(iii); or  
199 (B) for a ballot prepared by a county clerk, the words required by Subsection  
200 20A-6-301(1)(c)(iii); and  
201 (b) the information on the ballot stub that identifies:  
202 (i) the poll worker's initials; and  
203 (ii) the ballot number.
- 204 (52) "Official register" means the official record furnished to election officials by the  
205 election officer that contains the information required by Section 20A-5-401.
- 206 (53) "Paper ballot" means a paper that contains:  
207 (a) the names of offices and candidates and statements of ballot propositions to be  
208 voted on; and  
209 (b) spaces for the voter to record the voter's vote for each office and for or against each  
210 ballot proposition.
- 211 (54) "Pilot project" means the election day voter registration pilot project created in  
212 Section 20A-4-108.
- 213 (55) "Political party" means an organization of registered voters that has qualified to

214 participate in an election by meeting the requirements of Chapter 8, Political Party Formation  
215 and Procedures.

216 (56) "Pollbook" means a record of the names of voters in the order that they appear to  
217 cast votes.

218 (57) "Polling place" means the building where voting is conducted.

219 (58) (a) "Poll worker" means a person assigned by an election official to assist with an  
220 election, voting, or counting votes.

221 (b) "Poll worker" includes election judges.

222 (c) "Poll worker" does not include a watcher.

223 (59) "Position" means a square, circle, rectangle, or other geometric shape on a ballot  
224 in which the voter marks the voter's choice.

225 (60) "Primary convention" means the political party conventions held during the year  
226 of the regular general election.

227 (61) "Protective counter" means a separate counter, which cannot be reset, that:

228 (a) is built into a voting machine; and

229 (b) records the total number of movements of the operating lever.

230 (62) "Provider election officer" means an election officer who enters into a contract or  
231 interlocal agreement with a contracting election officer to conduct an election for the  
232 contracting election officer's local political subdivision in accordance with Section  
233 [20A-5-400.1](#).

234 (63) "Provisional ballot" means a ballot voted provisionally by a person:

235 (a) whose name is not listed on the official register at the polling place;

236 (b) whose legal right to vote is challenged as provided in this title; or

237 (c) whose identity was not sufficiently established by a poll worker.

238 (64) "Provisional ballot envelope" means an envelope printed in the form required by  
239 Section [20A-6-105](#) that is used to identify provisional ballots and to provide information to  
240 verify a person's legal right to vote.

241 (65) "Qualify" or "qualified" means to take the oath of office and begin performing the  
242 duties of the position for which the person was elected.

243 (66) "Receiving judge" means the poll worker that checks the voter's name in the  
244 official register, provides the voter with a ballot, and removes the ballot stub from the ballot

245 after the voter has voted.

246 (67) "Registration form" means a book voter registration form and a by-mail voter  
247 registration form.

248 (68) "Regular ballot" means a ballot that is not a provisional ballot.

249 (69) "Regular general election" means the election held throughout the state on the first  
250 Tuesday after the first Monday in November of each even-numbered year for the purposes  
251 established in Section [20A-1-201](#).

252 (70) "Regular primary election" means the election on the fourth Tuesday of June of  
253 each even-numbered year, to nominate candidates of political parties and candidates for  
254 nonpartisan local school board positions to advance to the regular general election.

255 (71) "Resident" means a person who resides within a specific voting precinct in Utah.

256 (72) "Sample ballot" means a mock ballot similar in form to the official ballot printed  
257 and distributed as provided in Section [20A-5-405](#).

258 (73) "Scratch vote" means to mark or punch the straight party ticket and then mark or  
259 punch the ballot for one or more candidates who are members of different political parties or  
260 who are unaffiliated.

261 (74) "Secrecy envelope" means the envelope given to a voter along with the ballot into  
262 which the voter places the ballot after the voter has voted it in order to preserve the secrecy of  
263 the voter's vote.

264 (75) "Special election" means an election held as authorized by Section [20A-1-203](#).

265 (76) "Spoiled ballot" means each ballot that:

266 (a) is spoiled by the voter;

267 (b) is unable to be voted because it was spoiled by the printer or a poll worker; or

268 (c) lacks the official endorsement.

269 (77) "Statewide special election" means a special election called by the governor or the  
270 Legislature in which all registered voters in Utah may vote.

271 (78) "Stub" means the detachable part of each ballot.

272 (79) "Substitute ballots" means replacement ballots provided by an election officer to  
273 the poll workers when the official ballots are lost or stolen.

274 (80) "Ticket" means [~~each list of candidates for each political party or for each group~~  
275 ~~of petitioners.~~] a list of:

276 (a) political parties;

277 (b) candidates for an office; or

278 (c) ballot propositions.

279 (81) "Transfer case" means the sealed box used to transport voted ballots to the  
280 counting center.

281 (82) "Vacancy" means the absence of a person to serve in any position created by  
282 statute, whether that absence occurs because of death, disability, disqualification, resignation,  
283 or other cause.

284 (83) "Valid voter identification" means:

285 (a) a form of identification that bears the name and photograph of the voter which may  
286 include:

287 (i) a currently valid Utah driver license;

288 (ii) a currently valid identification card that is issued by:

289 (A) the state; or

290 (B) a branch, department, or agency of the United States;

291 (iii) a currently valid Utah permit to carry a concealed weapon;

292 (iv) a currently valid United States passport; or

293 (v) a currently valid United States military identification card;

294 (b) one of the following identification cards, whether or not the card includes a  
295 photograph of the voter:

296 (i) a valid tribal identification card;

297 (ii) a Bureau of Indian Affairs card; or

298 (iii) a tribal treaty card; or

299 (c) two forms of identification not listed under Subsection (83)(a) or (b) but that bear  
300 the name of the voter and provide evidence that the voter resides in the voting precinct, which  
301 may include:

302 (i) a current utility bill or a legible copy thereof, dated within the 90 days before the  
303 election;

304 (ii) a bank or other financial account statement, or a legible copy thereof;

305 (iii) a certified birth certificate;

306 (iv) a valid Social Security card;

- 307 (v) a check issued by the state or the federal government or a legible copy thereof;
- 308 (vi) a paycheck from the voter's employer, or a legible copy thereof;
- 309 (vii) a currently valid Utah hunting or fishing license;
- 310 (viii) certified naturalization documentation;
- 311 (ix) a currently valid license issued by an authorized agency of the United States;
- 312 (x) a certified copy of court records showing the voter's adoption or name change;
- 313 (xi) a valid Medicaid card, Medicare card, or Electronic Benefits Transfer Card;
- 314 (xii) a currently valid identification card issued by:
- 315 (A) a local government within the state;
- 316 (B) an employer for an employee; or
- 317 (C) a college, university, technical school, or professional school located within the
- 318 state; or
- 319 (xiii) a current Utah vehicle registration.
- 320 (84) "Valid write-in candidate" means a candidate who has qualified as a write-in
- 321 candidate by following the procedures and requirements of this title.
- 322 (85) "Voter" means a person who:
- 323 (a) meets the requirements for voting in an election;
- 324 (b) meets the requirements of election registration;
- 325 (c) is registered to vote; and
- 326 (d) is listed in the official register book.
- 327 (86) "Voter registration deadline" means the registration deadline provided in Section
- 328 [20A-2-102.5](#).
- 329 (87) "Voting area" means the area within six feet of the voting booths, voting
- 330 machines, and ballot box.
- 331 (88) "Voting booth" means:
- 332 (a) the space or compartment within a polling place that is provided for the preparation
- 333 of ballots, including the voting machine enclosure or curtain; or
- 334 (b) a voting device that is free standing.
- 335 (89) "Voting device" means:
- 336 (a) an apparatus in which ballot sheets are used in connection with a punch device for
- 337 piercing the ballots by the voter;

- 338 (b) a device for marking the ballots with ink or another substance;
- 339 (c) an electronic voting device or other device used to make selections and cast a ballot
- 340 electronically, or any component thereof;
- 341 (d) an automated voting system under Section 20A-5-302; or
- 342 (e) any other method for recording votes on ballots so that the ballot may be tabulated
- 343 by means of automatic tabulating equipment.

344 (90) "Voting machine" means a machine designed for the sole purpose of recording  
 345 and tabulating votes cast by voters at an election.

346 (91) "Voting poll watcher" means a person appointed as provided in this title to  
 347 witness the distribution of ballots and the voting process.

348 (92) "Voting precinct" means the smallest voting unit established as provided by law  
 349 within which qualified voters vote at one polling place.

350 (93) "Watcher" means a voting poll watcher, a counting poll watcher, an inspecting  
 351 poll watcher, and a testing watcher.

352 (94) "Western States Presidential Primary" means the election established in Chapter 9,  
 353 Part 8, Western States Presidential Primary.

354 (95) "Write-in ballot" means a ballot containing any write-in votes.

355 (96) "Write-in vote" means a vote cast for a person whose name is not printed on the  
 356 ballot according to the procedures established in this title.

357 Section 2. Section 20A-6-101 is amended to read:

358 **20A-6-101. General requirements for paper ballots.**

359 (1) Each election officer shall ensure that paper ballots:

- 360 [~~(a)~~] ~~are printed on only one side of the paper;~~
- 361 [~~(b)~~] (a) are printed using precisely the same quality and tint of plain white paper  
 362 through which the printing or writing cannot be seen;
- 363 [~~(c)~~] (b) are printed using precisely the same quality and kind of type;
- 364 [~~(d)~~] (c) are printed using precisely the same quality and tint of plain black ink;
- 365 [~~(e)~~] (d) are uniform in size for all the voting precincts within the election officer's  
 366 jurisdiction; and

367 [~~(f)~~] (e) include, ~~[in an election]~~ on a ticket for a race in which a voter is authorized to  
 368 cast a write-in vote and ~~[where]~~ in which a write-in candidate is qualified under Section

369 ~~20A-9-601, a [write-in column immediately adjacent to the last column on the ballot that is~~  
370 ~~long enough to contain as many written names of candidates as there are persons to be elected~~  
371 ~~with: (i) the offices to be filled printed above the blank spaces on the ticket; and (ii) the words~~  
372 ~~"Write-In Voting Column" printed at the head of the column without a 1/2 inch circle] space~~  
373 ~~for a write-in candidate immediately following the last candidate listed on that ticket.~~

374 (2) Whenever the vote for candidates is to be limited to the voters of a particular  
375 political division, the election officer shall ensure that the names of those candidates are  
376 printed only upon those ballots provided to that political division.

377 Section 3. Section **20A-6-102** is amended to read:

378 **20A-6-102. General requirements for machine counted ballots.**

379 (1) Each election officer shall ensure that ballots and ballot labels are printed:

380 (a) to a size and arrangement that fits the construction of the voting device; and

381 (b) in plain, clear type in black ink on clear white stock; or

382 (c) in plain, clear type in black ink on stock of different colors if it is necessary to:

383 (i) identify different ballots or parts of the ballot; or

384 (ii) differentiate between political parties.

385 (2) Each election officer shall ensure that:

386 (a) ballot sheets are of a size, design, and stock suitable for processing by automatic  
387 data processing machines;

388 (b) each ballot sheet has an attached perforated stub, on which is printed the words  
389 "Official Ballot, (initial) Poll Worker"; and

390 (c) ballot stubs are numbered consecutively.

391 (3) ~~[In an election]~~ For a race in which a voter is authorized to cast a write-in vote and  
392 ~~[where] in which~~ a write-in candidate is qualified under Section **20A-9-601**, the election officer  
393 shall ~~[provide a separate write-in ballot, which may be in the form of a paper ballot, a card, or a~~  
394 ~~secrecy envelope in which the voter places his ballot sheet after voting, to permit voters to~~  
395 ~~write in the title of the office and the name of the person or persons for whom the voter wishes~~  
396 ~~to cast a write-in vote]~~ include a space on the ticket for a write-in candidate immediately  
397 following the last candidate listed on that ticket.

398 (4) Notwithstanding any other provisions of this section, the election officer may  
399 authorize any ballots that are to be counted by means of electronic or electromechanical

400 devices to be printed to a size, layout, texture, and in any type of ink or combination of inks  
401 that will be suitable for use in the counting devices in which they are intended to be placed.

402 Section 4. Section **20A-6-301** is amended to read:

403 **20A-6-301. Paper ballots -- Regular general election.**

404 (1) Each election officer shall ensure that:

405 (a) all paper ballots furnished for use at the regular general election contain:

406 (i) no captions or other endorsements except as provided in this section;

407 (ii) no symbols, markings, or other descriptions of a political party or group, except for  
408 a registered political party that has chosen to nominate its candidates in accordance with  
409 Section [20A-9-403](#); and

410 (iii) no indication that a candidate for elective office has been nominated by, or has  
411 been endorsed by, or is in any way affiliated with a political party or group, unless the  
412 candidate has been nominated by a registered political party in accordance with Subsection  
413 [20A-9-202](#)(4) or Subsection [20A-9-403](#)(5).

414 (b) (i) the paper ballot contains a ballot stub at least one inch wide, placed across the  
415 top of the ballot, and divided from the rest of ballot by a perforated line;

416 (ii) the ballot number and the words "Poll Worker's Initial \_\_\_\_" are printed on the  
417 stub; and

418 (iii) ballot stubs are numbered consecutively;

419 (c) immediately below the perforated ballot stub, the following endorsements are  
420 printed in 18 point bold type:

421 (i) "Official Ballot for \_\_\_\_ County, Utah";

422 (ii) the date of the election; and

423 (iii) the words "Clerk of \_\_\_\_\_ County" or, as applicable, the name of a  
424 combined office that includes the duties of a county clerk;

425 [~~(d) each ticket is placed in a separate column on the ballot in the order specified under~~  
426 ~~Section [20A-6-305](#) with the party emblem, followed by the party name, at the head of the~~  
427 ~~column;]~~

428 (d) subject to Subsection (2), each ticket that appears on the ballot appears separately,  
429 in the following order:

430 (i) a straight party ticket, where the voter may, with one mark, vote for all candidates of

- 431 one political party;
- 432       (ii) for federal office:
- 433       (A) president and vice president of the United States;
- 434       (B) United States Senate office; and
- 435       (C) United States House of Representatives office;
- 436       (iii) for state office:
- 437       (A) governor and lieutenant governor;
- 438       (B) attorney general;
- 439       (C) state auditor;
- 440       (D) state treasurer;
- 441       (E) state Senate office;
