LONG TITLE

General Description:

This bill amends provisions of the Election Code related to selecting candidates for the State Board of Education.

Highlighted Provisions:

This bill:

- ▶ describes the criteria and requirements relating to selecting candidates for the State Board of Education;
 - ▶ modifies dates in relation to selecting candidates for the State Board of Education;
 - ▶ repeals the State Board of Education nominating procedures on January 1, 2017;
- and
- ▶ makes technical changes.

31 Section 1. Section **20A-14-104** is amended to read:

32 **20A-14-104. Becoming a candidate for membership on the State Board of**
 33 **Education -- Nominating and recruiting committee -- Membership -- Procedure -- Duties.**

34 (1) (a) Persons interested in becoming a candidate for the State Board of Education
 35 shall file a declaration of candidacy according to the procedures and requirements of Sections
 36 **20A-9-201** and **20A-9-202**.

37 (b) By May 1 of the year in which a State Board of Education member's term expires,
 38 the lieutenant governor shall submit the name of each person who has filed a declaration of
 39 candidacy for the State Board of Education to the nominating and recruiting committee for the
 40 State Board of Education.

41 (2) ~~[By November]~~ On or before March 1 of ~~[the year preceding each]~~ a regular general
 42 election year, the governor shall appoint a nominating and recruiting committee consisting of
 43 12 members, each to serve a two-year term, ~~[shall be appointed by the governor]~~ as follows:

44 (a) one member shall be appointed to represent each of the following business and
 45 industry sectors:

- 46 (i) manufacturing and mining;
- 47 (ii) transportation and public utilities;
- 48 (iii) service, trade, and information technology;

52 (b) one member shall be appointed to represent each of the following education

72 (b) The chair, or another member of the committee designated by the chair, shall
73 schedule and convene all committee meetings.

74 (c) Any formal action by the committee requires the approval of a majority of
75 committee members.

76 (d) Members of the nominating and recruiting committee shall serve without
77 compensation, but ~~[they]~~ may be reimbursed for expenses incurred in the performance of their
78 official duties as established by the Division of Finance.

79 (5) The nominating and recruiting committee shall:

80 (a) recruit potential candidates for membership on the State Board of Education prior
81 to the deadline to file a declaration of candidacy;

82 (b) interview each individual who files a declaration of candidacy for the office of
83 State Board of Education member;

85 for each state board district subject to election in that year using the qualifications under
86 Subsection (6);

89 ~~[(d)]~~ (e) ensure that the list includes appropriate background information on each
90 candidate.

92 outstanding professional qualifications relating to the powers and duties of the State Board of
93 Education, including experience in the following areas:]~~

115 into account a candidate's:

116 (a) commitment to the policies of Utah's public education system described in Section

118 (b) level and quality of experience, including experience in the following areas:

- 120 (ii) administration or management;
- 121 (iii) past service on:
- 122 (A) a local school board or a charter school governing board, or in a state education
- 123 agency; and
- 124 (B) other boards of public, private, for-profit, or nonprofit entities;
- 125 (iv) finances; and
- 126 (v) business management;
- 127 (c) knowledge and understanding of skill sets needed by Utah's citizens, including
- 128 Utah's future workforce;
- 129 (d) work ethic;
- 130 (e) financial responsibility; and
- 131 (f) ability to perform the responsibilities of a member of the State Board of Education.
- 132 (7) The nominating and recruiting committee:
- 133 (a) may not consider, nor make a selection, based on the political or educational
- 134 philosophies, viewpoints, or affiliations of an individual who files a declaration of candidacy

- 139 **20A-14-105. Becoming a candidate for membership on the State Board of**
- 140 **Education -- Selection of candidates by the governor -- Ballot placement.**
- 141 (1) ~~[By]~~ On or before August 1 of each regular general election year, the governor
- 142 shall:
- 143 (a) for each state board district subject to election in that year, select two candidates for
- 144 the State Board of Education from the lists submitted by the state board district nominating and
- 145 recruiting committee; and
- 146 (b) certify the names of the two candidates from each school board district to the
- 147 lieutenant governor.
- 148 (2) In selecting the candidates under Subsection (1)(a), the governor:
- 149 (a) shall select the most qualified of the candidates, taking into account the criteria

150 described in Subsection 20A-14-104(6);

151 (b) may not consider, nor make a selection, based on the political or educational
152 philosophies, viewpoints, or affiliations of a candidate; and

153 (c) shall, with the certification described in Subsection (1)(b), provide a written
154 statement to the lieutenant governor describing the qualifications of the candidates selected by
155 the governor.

156 ~~[(2)]~~ (3) If the governor fails to select two candidates for a state board district by
157 August 1, the nominating and recruiting committee shall:

158 (a) select the two candidates~~[-and]~~ using the same criteria, and subject to the same
159 limitations, described in Subsections (2)(a) and (b);

160 (b) notify the lieutenant governor of ~~[its]~~ the committee's selections [by] on or before
161 August 31[-]; and

162 (c) with the notification described in Subsection (3)(b), submit a written statement to
163 the lieutenant governor describing the qualifications of the candidates selected by the
164 nominating and recruiting committee.

165 ~~[(3)]~~ (4) In accordance with Section 20A-6-305, the lieutenant governor shall certify
166 the names described in Subsection (1)(b) or (3)(b), as applicable, and the order of the names, to
167 the county clerks for placement on the nonpartisan section of the ballot.

179 Section 4. **Effective date.**

180 If approved by two-thirds of all the members elected to each house, this bill takes effect

181 upon approval by the governor, or the day following the constitutional time limit of Utah
182 Constitution, Article VII, Section 8, without the governor's signature, or in the case of a veto,
183 the date of veto override.
