8	General Description:
9	This bill amends provisions of the Alcoholic Beverage Control Act related to beer.

21	Be it enacted by the Legislature of the state of Utah:
22	Section 1. Section 32B-1-102 is amended to read:
23	32B-1-102. Definitions.
24	As used in this title:
25	(1) "Airport lounge" means a business location:
26	(a) at which an alcoholic product is sold at retail for consumption on the premises; and
27	(b) that is located at an international airport with a United States Customs office on the



28	premises of the international airport.
29	(2) "Airport lounge license" means a license issued in accordance with Chapter 5,
30	Retail License Act, and Chapter 6, Part 5, Airport Lounge License.
31	(3) "Alcoholic beverage" means the following:
32	(a) beer; or
33	(b) liquor.
34	(4) (a) "Alcoholic product" means a product that:
35	(i) contains at least .5% of alcohol by volume; and
36	(ii) is obtained by fermentation, infusion, decoction, brewing, distillation, or other
37	process that uses liquid or combinations of liquids, whether drinkable or not, to create alcohol
38	in an amount equal to or greater than .5% of alcohol by volume.
39	(b) "Alcoholic product" includes an alcoholic beverage.
40	(c) "Alcoholic product" does not include any of the following common items that
41	otherwise come within the definition of an alcoholic product:
42	(i) except as provided in Subsection (4)(d), an extract;
43	(ii) vinegar;
44	(iii) preserved nonintoxicating cider;
45	(iv) essence;
46	(v) tincture;
47	(vi) food preparation; or
48	(vii) an over-the-counter medicine.
49	(d) "Alcoholic product" includes an extract containing alcohol obtained by distillation
50	when it is used as a flavoring in the manufacturing of an alcoholic product.
51	(5) "Alcohol training and education seminar" means a seminar that is:
52	(a) required by Chapter 5, Part 4, Alcohol Training and Education Act; and
53	(b) described in Section 62A-15-401.
54	(6) "Banquet" means an event:
55	(a) that is held at one or more designated locations approved by the commission in or
56	on the premises of a:
57	(i) hotel;
58	(ii) resort facility;

59	(iii) sports center; or
60	(iv) convention center;
61	(b) for which there is a contract:
62	(i) between a person operating a facility listed in Subsection (6)(a) and another person;
63	and
64	(ii) under which the person operating a facility listed in Subsection (6)(a) is required to
65	provide an alcoholic product at the event; and
66	(c) at which food and alcoholic products may be sold, offered for sale, or furnished.
67	(7) "Bar structure" means a surface or structure on a licensed premises if on or at any
68	place of the surface or structure an alcoholic product is:
69	(a) stored; or
70	(b) dispensed.
71	(8) (a) "Bar establishment license" means a license issued in accordance with Chapter
72	5, Retail License Act, and Chapter 6, Part 4, Bar Establishment License.
73	(b) "Bar establishment license" includes:
74	(i) a dining club license;
75	(ii) an equity license;
76	(iii) a fraternal license; or
77	(iv) a bar license.
78	(9) "Bar license" means a license issued in accordance with Chapter 5, Retail License
79	Act, and Chapter 6, Part 4, Bar Establishment License.
80	(10) (a) Subject to Subsection (10)(d), "beer" means a product that:
81	(i) contains at least .5% of alcohol by volume, but not more than $[4\%] 6\%$ of alcohol
82	by volume or $[3.2\%]$ 4.8% by weight; and
83	(ii) is obtained by fermentation, infusion, or decoction of malted grain.
84	(b) "Beer" may or may not contain hops or other vegetable products.
85	(c) "Beer" includes a product that:
86	(i) contains alcohol in the percentages described in Subsection (10)(a); and
87	(ii) is referred to as:
88	(A) beer;
89	(B) ale;

90	(C) porter;
91	(D) stout;
92	(E) lager; or
93	(F) a malt or malted beverage.
94	(d) "Beer" does not include a flavored malt beverage.
95	(11) "Beer-only restaurant license" means a license issued in accordance with Chapter
96	5, Retail License Act, and Chapter 6, Part 9, Beer-Only Restaurant License.
97	(12) "Beer retailer" means a business that:
98	(a) is engaged, primarily or incidentally, in the retail sale of beer to a patron, whether
99	for consumption on or off the business premises; and
100	(b) is licensed as:
101	(i) an off-premise beer retailer, in accordance with Chapter 7, Part 2, Off-Premise Beer
102	Retailer Local Authority; or
103	(ii) an on-premise beer retailer, in accordance with Chapter 5, Retail License Act, and
104	Chapter 6, Part 7, On-Premise Beer Retailer License.
105	(13) "Beer wholesaling license" means a license:
106	(a) issued in accordance with Chapter 13, Beer Wholesaling License Act; and
107	(b) to import for sale, or sell beer in wholesale or jobbing quantities to one or more
108	retail licensees or off-premise beer retailers.
109	(14) "Billboard" means a public display used to advertise, including:
110	(a) a light device;
111	(b) a painting;
112	(c) a drawing;
113	(d) a poster;
114	(e) a sign;
115	(f) a signboard; or
116	(g) a scoreboard.
117	(15) "Brewer" means a person engaged in manufacturing:
118	(a) beer;
119	(b) heavy beer; or
120	(c) a flavored malt beverage.

121	(16) "Brewery manufacturing license" means a license issued in accordance with
122	Chapter 11, Part 5, Brewery Manufacturing License.
123	(17) "Certificate of approval" means a certificate of approval obtained from the
124	department under Section 32B-11-201.
125	(18) "Chartered bus" means a passenger bus, coach, or other motor vehicle provided by
126	a bus company to a group of persons pursuant to a common purpose:
127	(a) under a single contract;
128	(b) at a fixed charge in accordance with the bus company's tariff; and
129	(c) to give the group of persons the exclusive use of the passenger bus, coach, or other
130	motor vehicle, and a driver to travel together to one or more specified destinations.
131	(19) "Church" means a building:
132	(a) set apart for worship;
133	(b) in which religious services are held;
134	(c) with which clergy is associated; and
135	(d) that is tax exempt under the laws of this state.
136	(20) "Commission" means the Alcoholic Beverage Control Commission created in
137	Section 32B-2-201.
138	(21) "Commissioner" means a member of the commission.
139	(22) "Community location" means:
140	(a) a public or private school;
141	(b) a church;
142	(c) a public library;
143	(d) a public playground; or
144	(e) a public park.
145	(23) "Community location governing authority" means:
146	(a) the governing body of the community location; or
147	(b) if the commission does not know who is the governing body of a community
148	location, a person who appears to the commission to have been given on behalf of the
149	community location the authority to prohibit an activity at the community location.
150	(24) "Container" means a receptacle that contains an alcoholic product, including:
151	(a) a bottle;

152	(b) a vessel; or
153	(c) a similar item.
154	(25) "Convention center" means a facility that is:
155	(a) in total at least 30,000 square feet; and
156	(b) otherwise defined as a "convention center" by the commission by rule.
157	(26) (a) "Counter" means a surface or structure in a dining area of a licensed premises
158	where seating is provided to a patron for service of food.
159	(b) "Counter" does not include a dispensing structure.
160	(27) "Department" means the Department of Alcoholic Beverage Control created in
161	Section 32B-2-203.
162	(28) "Department compliance officer" means an individual who is:
163	(a) an auditor or inspector; and
164	(b) employed by the department.
165	(29) "Department sample" means liquor that is placed in the possession of the
166	department for testing, analysis, and sampling.
167	(30) "Dining club license" means a license issued in accordance with Chapter 5, Retail
168	License Act, and Chapter 6, Part 4, Bar Establishment License, that is designated by the
169	commission as a dining club license.
170	(31) "Director," unless the context requires otherwise, means the director of the
171	department.
172	(32) "Disciplinary proceeding" means an adjudicative proceeding permitted under this
173	title:
174	(a) against a person subject to administrative action; and
175	(b) that is brought on the basis of a violation of this title.
176	(33) (a) Subject to Subsection (33)(b), "dispense" means:
177	(i) drawing an alcoholic product; and
178	(ii) using the alcoholic product at the location from which it was drawn to mix or
179	prepare an alcoholic product to be furnished to a patron of the retail licensee.
180	(b) The definition of "dispense" in this Subsection (33) applies only to:
181	(i) a full-service restaurant license;
182	(ii) a limited-service restaurant license;

182 (ii) a limited-service restaurant license;

183	(iii) a reception center license; and
184	(iv) a beer-only restaurant license.
185	(34) "Dispensing structure" means a surface or structure on a licensed premises:
186	(a) where an alcoholic product is dispensed; or
187	(b) from which an alcoholic product is served.
188	(35) "Distillery manufacturing license" means a license issued in accordance with
189	Chapter 11, Part 4, Distillery Manufacturing License.
190	(36) "Distressed merchandise" means an alcoholic product in the possession of the
191	department that is saleable, but for some reason is unappealing to the public.
192	(37) "Educational facility" includes:
193	(a) a nursery school;
194	(b) an infant day care center; and
195	(c) a trade and technical school.
196	(38) "Equity license" means a license issued in accordance with Chapter 5, Retail
197	License Act, and Chapter 6, Part 4, Bar Establishment License, that is designated by the
198	commission as an equity license.
199	(39) "Event permit" means:
200	(a) a single event permit; or
201	(b) a temporary beer event permit.
202	(40) "Exempt license" means a license exempt under Section 32B-1-201 from being
203	considered in determining the total number of retail licenses that the commission may issue at
204	any time.
205	(41) (a) "Flavored malt beverage" means a beverage:
206	(i) that contains at least .5% alcohol by volume;
207	(ii) that is treated by processing, filtration, or another method of manufacture that is not
208	generally recognized as a traditional process in the production of a beer as described in 27
209	C.F.R. Sec. 25.55;
210	(iii) to which is added a flavor or other ingredient containing alcohol, except for a hop
211	extract; and
212	(iv) (A) for which the producer is required to file a formula for approval with the
213	federal Alcohol and Tobacco Tax and Trade Bureau pursuant to 27 C.F.R. Sec. 25.55; or

214	(B) that is not exempt under Subdivision (f) of 27 C.F.R. Sec. 25.55.
215	(b) "Flavored malt beverage" is considered liquor for purposes of this title.
216	(42) "Fraternal license" means a license issued in accordance with Chapter 5, Retail
217	License Act, and Chapter 6, Part 4, Bar Establishment License, that is designated by the
218	commission as a fraternal license.
219	(43) "Full-service restaurant license" means a license issued in accordance with
220	Chapter 5, Retail License Act, and Chapter 6, Part 2, Full-Service Restaurant License.
221	(44) (a) "Furnish" means by any means to provide with, supply, or give an individual
222	an alcoholic product, by sale or otherwise.
223	(b) "Furnish" includes to:
224	(i) serve;
225	(ii) deliver; or
226	(iii) otherwise make available.
227	(45) "Guest" means an individual who meets the requirements of Subsection
228	32B-6-407(9).
229	(46) "Hard cider" means the same as that term is defined in 26 U.S.C. Sec. 5041.
230	(47) "Health care practitioner" means:
231	(a) a podiatrist licensed under Title 58, Chapter 5a, Podiatric Physician Licensing Act;
232	(b) an optometrist licensed under Title 58, Chapter 16a, Utah Optometry Practice Act;
233	(c) a pharmacist licensed under Title 58, Chapter 17b, Pharmacy Practice Act;
234	(d) a physical therapist licensed under Title 58, Chapter 24b, Physical Therapy Practice
235	Act;
236	(e) a nurse or advanced practice registered nurse licensed under Title 58, Chapter 31b,
237	Nurse Practice Act;
238	(f) a recreational therapist licensed under Title 58, Chapter 40, Recreational Therapy
239	Practice Act;
240	(g) an occupational therapist licensed under Title 58, Chapter 42a, Occupational
241	Therapy Practice Act;
242	(h) a nurse midwife licensed under Title 58, Chapter 44a, Nurse Midwife Practice Act;
243	(i) a mental health professional licensed under Title 58, Chapter 60, Mental Health
244	Professional Practice Act;

245	(j) a physician licensed under Title 58, Chapter 67, Utah Medical Practice Act;
246	(k) an osteopath licensed under Title 58, Chapter 68, Utah Osteopathic Medical
247	Practice Act;
248	(1) a dentist or dental hygienist licensed under Title 58, Chapter 69, Dentist and Dental
249	Hygienist Practice Act; and
250	(m) a physician assistant licensed under Title 58, Chapter 70a, Physician Assistant Act.
251	(48) (a) "Heavy beer" means a product that:
252	(i) contains more than $[4\%] 6\%$ alcohol by volume; and
253	(ii) is obtained by fermentation, infusion, or decoction of malted grain.
254	(b) "Heavy beer" is considered liquor for the purposes of this title.
255	(49) "Hotel" is as defined by the commission by rule.
256	(50) "Hotel license" means a license issued in accordance with Chapter 5, Retail
257	License Act, and Chapter 8b, Hotel License Act.
258	(51) "Identification card" means an identification card issued under Title 53, Chapter 3,
259	Part 8, Identification Card Act.
260	(52) "Industry representative" means an individual who is compensated by salary,
261	commission, or other means for representing and selling an alcoholic product of a
262	manufacturer, supplier, or importer of liquor.
263	(53) "Industry representative sample" means liquor that is placed in the possession of
264	the department for testing, analysis, and sampling by a local industry representative on the
265	premises of the department to educate the local industry representative of the quality and
266	characteristics of the product.
267	(54) "Interdicted person" means a person to whom the sale, offer for sale, or furnishing
268	of an alcoholic product is prohibited by:
269	(a) law; or
270	(b) court order.
271	(55) "Intoxicated" means that a person:
272	(a) is significantly impaired as to the person's mental or physical functions as a result of
273	the use of:
274	(i) an alcoholic product;
275	(ii) a controlled substance;

276	(iii) a substance having the property of releasing toxic vapors; or
277	(iv) a combination of Subsections (55)(a)(i) through (iii); and
278	(b) exhibits plain and easily observed outward manifestations of behavior or physical
279	signs produced by the overconsumption of an alcoholic product.
280	(56) "Investigator" means an individual who is:
281	(a) a department compliance officer; or
282	(b) a nondepartment enforcement officer.
283	(57) "Invitee" means the same as that term is defined in Section $32B-8-102$.
284	(58) "License" means:
285	(a) a retail license;
286	(b) a license issued in accordance with Chapter 11, Manufacturing and Related
287	Licenses Act;
288	(c) a license issued in accordance with Chapter 12, Liquor Warehousing License Act;
289	or
290	(d) a license issued in accordance with Chapter 13, Beer Wholesaling License Act.
291	(59) "Licensee" means a person who holds a license.
292	(60) "Limited-service restaurant license" means a license issued in accordance with
293	Chapter 5, Retail License Act, and Chapter 6, Part 3, Limited-Service Restaurant License.
294	(61) "Limousine" means a motor vehicle licensed by the state or a local authority, other
295	than a bus or taxicab:
296	(a) in which the driver and a passenger are separated by a partition, glass, or other
297	barrier;
298	(b) that is provided by a business entity to one or more individuals at a fixed charge in
299	accordance with the business entity's tariff; and
300	(c) to give the one or more individuals the exclusive use of the limousine and a driver
301	to travel to one or more specified destinations.
302	(62) (a) (i) "Liquor" means a liquid that:
303	(A) is:
304	(I) alcohol;
305	(II) an alcoholic, spirituous, vinous, fermented, malt, or other liquid;
306	(III) a combination of liquids a part of which is spirituous, vinous, or fermented; or

307	(IV) other drink or drinkable liquid; and
308	(B) (I) contains at least .5% alcohol by volume; and
309	(II) is suitable to use for beverage purposes.
310	(ii) "Liquor" includes:
311	(A) heavy beer;
312	(B) wine; and
313	(C) a flavored malt beverage.
314	(b) "Liquor" does not include beer.
315	(63) "Liquor Control Fund" means the enterprise fund created by Section 32B-2-301.
316	(64) "Liquor warehousing license" means a license that is issued:
317	(a) in accordance with Chapter 12, Liquor Warehousing License Act; and
318	(b) to a person, other than a licensed manufacturer, who engages in the importation for
319	storage, sale, or distribution of liquor regardless of amount.
320	(65) "Local authority" means:
321	(a) for premises that are located in an unincorporated area of a county, the governing
322	body of a county; or
323	(b) for premises that are located in an incorporated city, town, or metro township, the
324	governing body of the city, town, or metro township.
325	(66) "Lounge or bar area" is as defined by rule made by the commission.
326	(67) "Manufacture" means to distill, brew, rectify, mix, compound, process, ferment, or
327	otherwise make an alcoholic product for personal use or for sale or distribution to others.
328	(68) "Member" means an individual who, after paying regular dues, has full privileges
329	in an equity licensee or fraternal licensee.
330	(69) (a) "Military installation" means a base, air field, camp, post, station, yard, center,
331	or homeport facility for a ship:
332	(i) (A) under the control of the United States Department of Defense; or
333	(B) of the National Guard;
334	(ii) that is located within the state; and
335	(iii) including a leased facility.
336	(b) "Military installation" does not include a facility used primarily for:
337	(i) civil works;

338	(ii) a rivers and harbors project; or
339	(iii) a flood control project.
340	(70) "Minor" means an individual under the age of 21 years.
341	(71) "Nondepartment enforcement agency" means an agency that:
342	(a) (i) is a state agency other than the department; or
343	(ii) is an agency of a county, city, town, or metro township; and
344	(b) has a responsibility to enforce one or more provisions of this title.
345	(72) "Nondepartment enforcement officer" means an individual who is:
346	(a) a peace officer, examiner, or investigator; and
347	(b) employed by a nondepartment enforcement agency.
348	(73) (a) "Off-premise beer retailer" means a beer retailer who is:
349	(i) licensed in accordance with Chapter 7, Off-premise Beer Retailer Act; and
350	(ii) engaged in the retail sale of beer to a patron for consumption off the beer retailer's
351	premises.
352	(b) "Off-premise beer retailer" does not include an on-premise beer retailer.
353	(74) "Off-premise beer retailer state license" means a state license issued in accordance
354	with Chapter 7, Part 4, Off-premise Beer Retailer State License.
355	(75) "On-premise banquet license" means a license issued in accordance with Chapter
356	5, Retail License Act, and Chapter 6, Part 6, On-Premise Banquet License.
357	(76) "On-premise beer retailer" means a beer retailer who is:
358	(a) authorized to sell, offer for sale, or furnish beer under a license issued in
359	accordance with Chapter 5, Retail License Act, and Chapter 6, Part 7, On-Premise Beer
360	Retailer License; and
361	(b) engaged in the sale of beer to a patron for consumption on the beer retailer's
362	premises:
363	(i) regardless of whether the beer retailer sells beer for consumption off the licensed
364	premises; and
365	(ii) on and after March 1, 2012, operating:
366	(A) as a tavern; or
367	(B) in a manner that meets the requirements of Subsection $32B-6-703(2)(e)(i)$.
368	(77) "Opaque" means impenetrable to sight.

369	(78) "Package agency" means a retail liquor location operated:
370	(a) under an agreement with the department; and
371	(b) by a person:
372	(i) other than the state; and
373	(ii) who is authorized by the commission in accordance with Chapter 2, Part 6, Package
374	Agency, to sell packaged liquor for consumption off the premises of the package agency.
375	(79) "Package agent" means a person who holds a package agency.
376	(80) "Patron" means an individual to whom food, beverages, or services are sold,
377	offered for sale, or furnished, or who consumes an alcoholic product including:
378	(a) a customer;
379	(b) a member;
380	(c) a guest;
381	(d) an attendee of a banquet or event;
382	(e) an individual who receives room service;
383	(f) a resident of a resort;
384	(g) a public customer under a resort spa sublicense, as defined in Section 32B-8-102;
385	or
386	(h) an invitee.
387	(81) "Permittee" means a person issued a permit under:
388	(a) Chapter 9, Event Permit Act; or
389	(b) Chapter 10, Special Use Permit Act.
390	(82) "Person subject to administrative action" means:
391	(a) a licensee;
392	(b) a permittee;
393	(c) a manufacturer;
394	(d) a supplier;
395	(e) an importer;
396	(f) one of the following holding a certificate of approval:
397	(i) an out-of-state brewer;
398	(ii) an out-of-state importer of beer, heavy beer, or flavored malt beverages; or
399	(iii) an out-of-state supplier of beer, heavy beer, or flavored malt beverages; or

400	(g) staff of:
401	(i) a person listed in Subsections (82)(a) through (f); or
402	(ii) a package agent.
403	(83) "Premises" means a building, enclosure, or room used in connection with the
404	storage, sale, furnishing, consumption, manufacture, or distribution, of an alcoholic product,
405	unless otherwise defined in this title or rules made by the commission.
406	(84) "Prescription" means an order issued by a health care practitioner when:
407	(a) the health care practitioner is licensed under Title 58, Occupations and Professions,
408	to prescribe a controlled substance, other drug, or device for medicinal purposes;
409	(b) the order is made in the course of that health care practitioner's professional
410	practice; and
411	(c) the order is made for obtaining an alcoholic product for medicinal purposes only.
412	(85) (a) "Private event" means a specific social, business, or recreational event:
413	(i) for which an entire room, area, or hall is leased or rented in advance by an identified
414	group; and
415	(ii) that is limited in attendance to people who are specifically designated and their
416	guests.
417	(b) "Private event" does not include an event to which the general public is invited,
418	whether for an admission fee or not.
419	(86) (a) "Proof of age" means:
420	(i) an identification card;
421	(ii) an identification that:
422	(A) is substantially similar to an identification card;
423	(B) is issued in accordance with the laws of a state other than Utah in which the
424	identification is issued;
425	(C) includes date of birth; and
426	(D) has a picture affixed;
427	(iii) a valid driver license certificate that:
428	(A) includes date of birth;
429	(B) has a picture affixed; and
430	(C) is issued:

431	(I) under Title 53, Chapter 3, Uniform Driver License Act; or
432	(II) in accordance with the laws of the state in which it is issued;
433	(iv) a military identification card that:
434	(A) includes date of birth; and
435	(B) has a picture affixed; or
436	(v) a valid passport.
437	(b) "Proof of age" does not include a driving privilege card issued in accordance with
438	Section 53-3-207.
439	(87) (a) "Public building" means a building or permanent structure that is:
440	(i) owned or leased by:
441	(A) the state; or
442	(B) a local government entity; and
443	(ii) used for:
444	(A) public education;
445	(B) transacting public business; or
446	(C) regularly conducting government activities.
447	(b) "Public building" does not include a building owned by the state or a local
448	government entity when the building is used by a person, in whole or in part, for a proprietary
449	function.
450	(88) "Public conveyance" means a conveyance that the public or a portion of the public
451	has access to and a right to use for transportation, including an airline, railroad, bus, boat, or
452	other public conveyance.
453	(89) "Reception center" means a business that:
454	(a) operates facilities that are at least 5,000 square feet; and
455	(b) has as its primary purpose the leasing of the facilities described in Subsection
456	(89)(a) to a third party for the third party's event.
457	(90) "Reception center license" means a license issued in accordance with Chapter 5,
458	Retail License Act, and Chapter 6, Part 8, Reception Center License.
459	(91) (a) "Record" means information that is:
460	(i) inscribed on a tangible medium; or
461	(ii) stored in an electronic or other medium and is retrievable in a perceivable form.

462	(b) "Record" includes:
463	(i) a book;
464	(ii) a book of account;
465	(iii) a paper;
466	(iv) a contract;
467	(v) an agreement;
468	(vi) a document; or
469	(vii) a recording in any medium.
470	(92) "Residence" means a person's principal place of abode within Utah.
471	(93) "Resident," in relation to a resort, means the same as that term is defined in
472	Section 32B-8-102.
473	(94) "Resort" means the same as that term is defined in Section 32B-8-102.
474	(95) "Resort facility" is as defined by the commission by rule.
475	(96) "Resort license" means a license issued in accordance with Chapter 5, Retail
476	License Act, and Chapter 8, Resort License Act.
477	(97) "Responsible alcohol service plan" means a written set of policies and procedures
478	that outlines measures to prevent employees from:
479	(a) over-serving alcoholic beverages to customers;
480	(b) serving alcoholic beverages to customers who are actually, apparently, or obviously
481	intoxicated; and
