26	Section 1. Section 76-5-107.1 is enacted to read:
27	<u>76-5-107.1.</u> Threats against schools.
28	(1) As used in this section, "school" means a preschool or a public or private
29	elementary or secondary school.
30	(2) An individual is guilty of making a threat against a school if the individual
31	threatens in person or via electronic means, either with real intent or as an intentional hoax, to
32	commit any offense involving bodily injury, death, or substantial property damage, and:
33	(a) threatens the use of a firearm or weapon or hoax weapon of mass destruction, as
34	defined in Section 76-10-401;
35	(b) acts with intent to:
36	(i) disrupt the regular schedule of the school or influence or affect the conduct of
37	students, employees, or the general public at the school;
38	(ii) prevent or interrupt the occupancy of the school or a portion of the school, or a
39	facility or vehicle used by the school; or
40	(iii) intimidate or coerce students or employees of the school; or
41	(c) causes an official or volunteer agency organized to deal with emergencies to take
42	action due to the risk to the school or general public.
43	(3) (a) A violation of Subsection (2)(a), (b)(i), or (b)(iii) is a class A misdemeanor.
