9	General Description:
10	This resolution calls on the federal government to return full oversight of the
11	accreditation process for public higher education institutions to the states.
12	Highlighted Provisions:
13	This resolution:
14	 declares that oversight of accreditation for institutions of higher education should be
15	solely under the purview of states; and
16	 calls on the federal government to return that responsibility to the states.
17	Special Clauses:

19 20	Be it resolved by the Legislature of the state of Utah:
21	WHEREAS, education is a state level issue, and each state should have full control
22	over its public education systems, including higher education;
23	WHEREAS, because of undue federal oversight, Utah currently lacks full control over
24	the accreditation process for public institutions of higher education in the state;
25	WHEREAS, accreditation is a review process for higher education institutions and
26	specific programs within an institution;
27	WHEREAS, higher education institutions and programs may request an accreditation

28 review from accrediting bodies, which are private educational associations; 29 WHEREAS, accrediting bodies develop evaluation criteria and grant accreditation to 30 the institutions and programs that meet the accrediting bodies' criteria: 31 WHEREAS, the United States Department of Education (USDE) does not accredit 32 individual institutions of higher education, but approves accrediting agencies that meet USDE's 33 criteria; 34 WHEREAS, to receive federal student aid, students must attend an institution 35 accredited by an agency approved by USDE and institutions must be accredited by an agency 36 approved by USDE to receive federal assistance, including research grants; 37 WHEREAS, all of Utah's public institutions of higher education are accredited by 38 federally-approved accrediting bodies; 39 WHEREAS, accreditation of higher education institutions is a state issue and should be 40 under the full purview of each individual state: WHEREAS, states that fully oversee the accreditation process for public higher 41 education institutions should have access to federal funding, including federal student aid and 42 43 research grants; and 44 WHEREAS, the federal government's mandate that public higher education institutions 45 comply with an accreditation process dictated by USDE to receive federal funding is an affront 46 to states' rights: 47 NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah 48 declares that all states, including the state of Utah, should have the ability to fully oversee the 49 accreditation process for public institutions of higher education in each respective state without 50 federal oversight or interference while maintaining access to federal funds. 51 BE IT FURTHER RESOLVED that the Legislature calls on the federal government to 52 recognize each individual state's rights and return full control of the accreditation process for 53 public higher education institutions to the states.
