This publication has been created with the input and review of each respective organization and reflects organizational structures as of July 1, 2021.

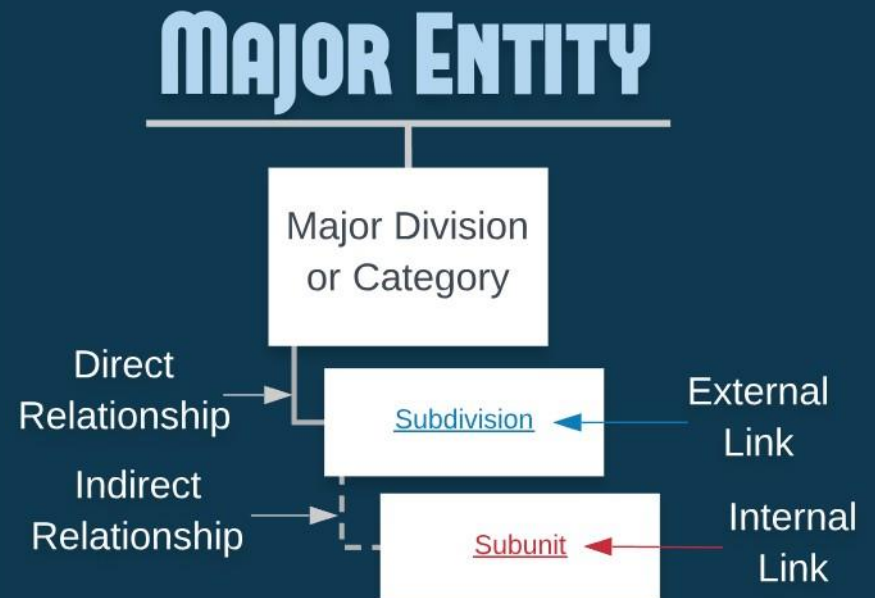
