Background

This document compiles statutory provisions that are scheduled to repeal between January 2022 and January 2023. Provisions under Title 63I, Chapter 1, Legislative Oversight and Sunset Act, are subject to a review by an interim committee. Provisions under Title 63I, Chapter 2, Repeal Dates by Title Act, do not require a review. Without legislative action in the 2022 General Session, the provisions listed below will repeal on the date specified.
