#### INTERIM LEGISLATIVE MEETINGS

Meetings were held May 19, 2010 or as noted.

#### Administrative Rules Review Committee

April 08, 2010

## **Department of Administrative Services Modifications**

Discussed the impact of H.B. 402, "Department of Administrative Services Modifications" (2010 General Session), on the department, including the Division of Administrative Rules.

#### **Tourism-oriented Directional Signs**

Discussed, at the request of the Utah Department of Transportation (UDOT), whether UDOT should draft an administrative rule governing the placement of tourism-oriented directional signs.

Action: Recommended that UDOT postpone rulemaking for 36 months and work with affected industries to resolve concerns, and also send a letter to the Privatization Policy Board requesting that it review the issue.

#### **Incorporation by Reference in Statutes and Rules**

Received a committee staff report on the different ways in which state statutes and agency administrative rules incorporate other documents by reference.

#### **Local Health Department Rulemaking**

Discussed the relationship of local health department rules to state statutes and the administrative rules written by the Utah Department of Health.

#### Statutes and Rules Governing Lobbying

Discussed state statutes and administrative rules governing lobbying, including the definitions of "lobbying" and "lobbyist," and the relation of these terms to an individual defined as a "government officer."

#### **Business and Labor**

#### **Assessment on Title Insurance Agencies or Insurers**

Received a presentation from the Insurance

Department, the Title and Escrow Commission, and the Utah Land Title Association regarding the assessment and the uses of the assessment revenue.

Action: Directed the Insurance Department to provide recommendations regarding the assessment structure and the cap on the amount of revenue from the assessment that may be collected.

### **Catastrophic Coverage for Mental Health**

Action: Voted to remove Utah Code Section 31A-22-625, Catastrophic Coverage of Mental Health Conditions, from the Sunset Act and to make certain conforming amendments.

### **Revisions to the Alcoholic Beverage Control Act**

Received a presentation from committee staff regarding possible changes to the Alcoholic Beverage Control Act. During the enrolling process for S.B. 167, "Alcoholic Beverage Control Act Recodification" (2010 General Session), certain technical issues were found that require correction by legislative action. Reviewed recommendations for legislative language.

Action: Voted to direct staff to draft legislation incorporating recommended changes to the Alcoholic Beverage Control Act.

#### Single Event Alcholic Beverage Permits

Received a presentation from the Department of Alcoholic Beverage Control regarding a proposed change to an administrative rule governing single event permits and temporary beer permits.

#### **Utah Common Interest Ownership Act**

Received information from a legislator regarding the proposed "Common Interest Ownership Act."
Received public comments regarding some of the significant issues, including judicial versus non-judicial liens, the rights of a homeowners' association to initiate modified non-judicial foreclosure processes, insurance provided by the homeowners' association, real party in interest

#### **Education**

### **Athletic Eligibility for Transfer Students**

Received a briefing from committee staff on current and proposed policies affecting eligibility of high school athletes when they transfer schools, and examples of policies in other states. Also received information from the Utah High School Activities Association, which administers the policies, and discussed the proposed changes.

#### **School Funding and Equalization**

Received a briefing from committee staff on how, and to what extent, Utah's current school finance system equalizes funding for schools and how equalization could be modified. Reviewed options to further equalize funding across the state.

#### **Ethics**

#### **Code of Conduct**

Received a presentation from Legislative General Counsel about the Legislature's "Code of Conduct" from the Rules of the 58th Legislature and possible amendment options.

## Government Operations and Political Subdivisions

#### **Agriculture Sustainability Fund**

Received a request from a legislator to study whether counties should create an Agriculture Sustainability Fund to protect agricultural land. Under the proposal, a county would deposit rollback taxes into the fund and appoint committee members to administer the fund to purchase agricultural easements.

#### **Election Code Changes and Federal Law**

Action: Directed staff to open a bill file and begin working with the Office of the Lieutenant Governor

to amend Utah's Election Code to conform with the federal Military and Overseas Voter Empowerment Act, which is intended to ensure that absent voters who are in the military service and overseas are aware of their voting rights and to ensure their votes are counted.

### **Municipal Elections With Unopposed Candidates**

Action: Directed staff to open a bill file and begin working with the Office of the Lieutenant Governor on the issue of whether an election should be required for a municipal candidate who is unopposed.

#### **Utah Procurement Code Revisions**

Received briefings from the Office of the Attorney General and the Division of Purchasing and General Services explaining the need to update the Utah Procurement Code, which was enacted in 1980. The Office of the Attorney General and the Division of Purchasing have established a working group to update Utah's Procurement Code, using as a starting point the Model Procurement Code for State and Local Governments developed by the American Bar Association.

### Water Banking

Received a request from a legislator to study whether local districts should employ water banking strategies within their respective jurisdictions.

#### **Health and Human Services**

#### H1N1 Update

Received a written evaluation and oral presentation from the Department of Health on the Utah's response to the H1N1 flu pandemic.

#### **Healthcare Reform**

Received a demonstration by the Utah Health Information Network on how hospitals and medical clinicians are able to access patient information using Utah's standardized electronic exchange of clinical health information. Received a report from the Department of Health on how the federal Patient Protection and Affordable Care Act (PPACA) will affect state funding of Medicaid. Received a recommendation from the Utah Health Policy Project that the state work with the federal government to implement PPACA.

## **Health System Reform Task Force**

April 23, 2010

#### **Health Care Reform and Disruptive Innovation**

Received a report from Dr. Clayton M. Christensen, Harvard Business School professor, summarizing many of his ideas on disruptive innovation and their application to health care. He referred to a book he coauthored, "The Innovator's Prescription: A Disruptive Solution for Health Care." Following his comments, task force members assembled in groups to develop suggestions for applying disruptive innovation theories to health care in Utah. Several groups then presented their ideas and Dr. Christensen commented on and facilitated group discussion about the ideas.

May 19, 2010

#### **Electronic Clinical Health Information Exchange**

Received a report from the Utah Health Information Network (UHIN) that eight hospitals representing each of the major hospital systems have connected with one another or are working to connect with one another using new standards developed by Utah for the electronic exchange of clinical health information. UHIN highlighted two policy issues related to Electronic Clinical Health Information Exchange (cHIE) data and reported that Utah entities have been awarded \$7.2 million in federal funding for cHIE-related activities.

#### **Electronic Personal Health Records**

Received a report from MediConnect Global, a medical record retrieval and delivery company that has gathered, digitized, and extracted millions of medical records, stating that it would like to integrate data from the Utah's new all payer database with the existing medical records database as part of an attempt to help people take greater interest in their health before they become ill and to also help them when they are sick.

#### **Payment and Delivery Reform Projects**

Received a report from HealthInsight stating that by August it should have data from the obstetrics demonstration project it is helping to develop. It also reported that it has been awarded a \$15.8 million federal Beacon Community Grant. The grant will be used in part for the state's diabetes demonstration project.

#### **Uniform Insurance Application Form**

Received a report from America's Health Insurance Plans (AHIP) indicating that it would not oppose the Utah Insurance Department's removing from a proposed uniform insurance application form a question that could require applicants to disclose the use of over-the-counter medications.

## Judiciary, Law Enforcement, and Criminal Justice

#### **Budget Cuts in the Department of Public Safety**

Received a report from the Department of Public Safety on the effects of budget cuts in the department. The cuts in general funds available to the department averaged 12 percent overall for fiscal years 2009, 2010, and 2011.

#### **Inmate Population Growth**

Received a report from the Utah Department of Corrections, stating that the state prison system is approaching maximum capacity and that this may occur as early as July 2010. When maximum inmate capacity is met, the Board of Pardons and Parole will be required to release one inmate for each person who enters the state prison system. Thirty percent of the current inmates are sex offenders.

#### **Renewing Judgments by Motion**

Considered issues and potential amendments to draft legislation, "Renewal of Judgment Act," which establishes a \$35 fee for renewal of a judgment in a court of record when the motion is filed before the eight-year statute of limitations on the original judgment expires.

#### **Utah Sentencing Commission**

Received a presentation from the Sentencing Commission and a request that its sunset reviews be discontinued.

Action: Recommended extending the current sunset date and also removing the Sentencing Commission from the sunset process.

## Natural Resources, Agriculture, and Environment

#### **Endangered Species Act**

Received a report from the Department of Natural Resources and the Division of Wildlife Resources on state efforts to manage those plants and animals that are currently listed, or have the potential to be listed, as endangered or threatened in Utah under the federal Endangered Species Act.

#### **Federal Land Use Policies**

Received a report from the Governor's Balanced Resource Council on recent meetings with the U.S. Department of Interior Secretary on federal land use policies affecting Utah.

#### **Utah Water Resources Update**

Received a report from the Division of Water Resources on the current snow pack and water reservoir levels in Utah.

## **Public Utilities and Technology**

#### **Department of Technology Services**

Discussed the services provided by the Department of Technology Services, the related 2009 report by the legislative auditor, and the possibility of a pilot request for proposal program to allow state agencies such as the Department of Public Safety to purchase private sector technology services. *Action:* Directed staff to identify and analyze business plan approvals by the Department of Technology Services, which authorizes the private sector purchase of technology services.

#### **Net Metering**

Discussed the implications of the rapid growth of self-generation or net metering upon the publicly regulated carriers and ratepayers. Rocky Mountain Power presented information indicating that over the last two years the number of self-generators doubled to over 600 and that related subsidized costs have also increased.

#### **Petroleum Industry**

Received information from committee staff on the petroleum industry and related taxes, including a comparison of Utah gas prices with the U.S. average and those of surrounding states.

#### **School Funding and Property Taxes**

Received a report from committee staff on property taxes and school funding in Utah, including a review of school property tax bases, rates, revenues, and current funding equalization programs.

#### **UTOPIA Update**

Received information on the Utah Telecommunications Open Infrastructure Agency (UTOPIA), including the agency's history and current financial status. Information was provided by committee staff and UTOPIA.

#### **Senate Judicial Confirmation Committee**

#### Judicial Confirmation

Action: Recommended that the Senate confirm the appointment of Michelle M. Christiansen to the Utah Court of Appeals.

(The Senate confirmed the appointment of Michelle M. Christiansen on May 19, 2010 in an extraordinary session held for that purpose.)

### **Transportation**

#### Class B and Class C Road Funding

Received a staff presentation on Class B and Class C road funding. Received comments stating that funds are insufficient to maintain and build county and city roads. Discussed provisions that require a city or county to put certain local road projects out for bid, and modifications to these provisions that would allow a private contractor to be more competitive in the bidding process.

#### Impoundment of Motor Vehicles

Studied the effects of H.B. 151, "Motor Vehicle Revisions" (2008 General Session), and found that 1,298 vehicles were impounded in 2009 because the operator did not have proof of motor vehicle insurance. The Utah Highway Patrol commented that it makes great effort to determine that the operator does not have insurance before the vehicle is impounded.

#### **Special Group License Plates**

Received a committee staff presentation on special group license plates (SGLP) and found that Utah has over 50 SGLPs, 30 of which are issued for fewer than 500 vehicles.
