34 (3) (a) The state treasurer shall invest money in the account according to Title 51,
35 Chapter 7, State Money Management Act.

36 (b) The Division of Finance shall deposit interest or other earnings derived from
37 investment of account money into the General Fund.

55 development in the state;

56 (v) 1.66% of the deposits to the Water Research Laboratory at Utah State University, to
57 be used for water development in the state;

58 (vi) 11% of the deposits to the Constitutional Defense Restricted Account created in
59 Section 63C-4a-402;

60 (vii) 1% of the deposits to the Geological Survey, to be used for test wells[;] and other
61 hydrologic studies[~~], and air quality monitoring~~] in the West Desert; and

62 (viii) 3% of the deposits to the Permanent Community Impact Fund created in Section
63 35A-8-303, to be used for grants to political subdivisions of the state to mitigate the impacts

64 resulting from the development or use of school and institutional trust lands.

65 (5) The administration shall make recommendations to the Permanent Community
66 Impact Fund Board for ~~its~~ the Permanent Community Impact Fund Board's consideration
67 when awarding the grants described in Subsection (4)(b)(viii).
