337	(e) support offered by the division to complete a grant application.

342	(c) send a grant application to the governor or the governor's designee for evaluation

352	expenses that are normally provided for by legislative appropriation.
353	(10) The governor or the governor's designee may authorize the expenditure of fund
354	money in accordance with this section.
355	(11) The governor shall make an annual report to the Legislature regarding the status of
356	the fund, including a report on the contributions received, expenditures made, and programs
357	and services funded.
