102 (c) Subsection 63N-7-101(1), which defines "board," is repealed;

103 (d) Subsection 63N-7-102(3)(c), which requires the Utah Office of Tourism to receive  
104 approval from the Board of Tourism Development, is repealed; and

105 (e) Title 63N, Chapter 7, Part 2, Board of Tourism Development, is repealed.

106 [~~32~~] (29) Subsection 63N-8-103(3)(c), which allows the Governor's Office of  
107 Economic Opportunity to issue an amount of tax credit certificates only for rural productions,  
108 is repealed on July 1, 2024.

109 Section 2. **Effective date.**

110 This bill takes effect on May 1, 2024.
