#### 7. Statutorily Required Report: Fuel Storage Reserve Study 2:25 - 2:35PM

<u>Section 79-6-406</u> requires the OED to conduct a study analyzing the potential benefits, risks, feasibility, and requirements of establishing a Utah transportation, heating, and electricity-generating fuel storage reserve. OED is required to report on the progress of the study.

<u>Section 79-6-408</u> requires the Decommissioned Asset Disposition Authority to conduct a study, in consultation with OED, to evaluate issues associated with the state's air quality implementation plan as it relates to continued operation of assets intended for decommissioning, establishing a fair market value, and evaluate potential sale of the facilities to new owners. The authority is required to report the progress and results of the study to the PUET committee.
