64	(a) "Lifeguard certification training" means a training and certification program for a
65	student who is at least 15 years old and that is certified by the American Red Cross or
66	an equivalent program approved by the Department of Health and Human Services
67	that:
68	(i) a certified lifeguard instructor teaches at a public or private facility;
69	(ii) a student may take to satisfy credit requirements or other requirements for
70	physical education; and
71	(iii) offers an opportunity for a student to enter the work force as a lifeguard after
72	certification.
73	(b)(i) "Swim instruction" means swim lessons from a certified swim instructor that
74	instruct a student in knowing how to:
75	(A) enter and exit water that is over the head;
