4 **General Description:**

5 This bill addresses federal benefits for minors who are in the custody of the Department of

97	(c) If good cause exists to not use an ABLE account for a minor beneficiary, or if a
98	minor beneficiary is not eligible for an ABLE account, the department shall
99	determine and use the type of account that will best preserve the minor beneficiary's

101	(i) a 529 savings account, as that term is defined in Section 35A-9-601;
102	(ii) a special needs trust; or
103	(iii) another type of tax-advantaged account that the department can administer in

130	(c) At the time the department transfers the minor beneficiary's account pursuant to
131	Subsection (5)(a), the department shall offer financial literacy training to the minor or
132	the successor payee.
133	(d) The department may work with other state agencies, departments, or offices to
134	provide the training described in Subsection (5)(c).
135	(6) The department shall make rules in accordance with Title 63G, Chapter 3, Utah
136	Administrative Rulemaking Act, to implement the requirements of this section and to
137	provide for the accounting and protection of federal benefits for minor beneficiaries in
138	the division's custody, including:
139	(a) criteria for the preservation and disbursement of a minor beneficiary's federal
140	benefits;
141	(b) defining what constitutes good cause for the use of an account other than an ABLE
142	account, as described in Subsection (4)(b);
143	(c) safeguards to prevent the mismanagement of and protect against theft, loss, or

150	(b) the types of federal benefits received by minor beneficiaries in the custody of the
151	department;
152	(c) a description of the department's policies or procedures for managing minor
153	beneficiaries' federal benefits in accordance with the requirements of this section; and
154	(d) the total amount of federal benefits received and expended on behalf of minor
155	beneficiaries in the custody of the department.
