

Val L. Peterson proposes the following substitute bill:

Special Group License Plate Amendments

2025 GENERAL SESSION

STATE OF UTAH

Senate Sponsor:

LONG TITLE

General Description:

This bill changes the allocation of money from a historical support special group license plate.

Highlighted Provisions:

This bill:

- provides the allocation of money from the voluntary contribution for a historical support special group license plate, allocating revenue to the sponsoring agency and to the Transportation Investment Fund of 2005;
- requires the Motor Vehicle Division to provide notice regarding the allocation of the money from the historical support special group license plate;
- requires a one-time transfer of funds related to the support special group license plate;
- provides that a vintage vehicle is not required to make the voluntary contribution to obtain the historical support special group license plate;
- amends the definition of a vintage vehicle to exclude the requirement regarding the type of license plate to be displayed; and
- makes technical changes.

Money Appropriated in this Bill:

This bill appropriates \$3,500,000 in expendable funds and accounts for fiscal year 2026, all of which is from the General Fund.

Other Special Clauses:

This bill provides a special effective date.

32 Section 1. Section **41-1a-418** is amended to read:

33 **41-1a-418 . Authorized special group license plates.**

34 (1) In accordance with this chapter, the division shall issue to an eligible applicant a special
35 group license plate in one of the following categories:

36 (a) a disability special group license plate issued in accordance with Section 41-1a-420;

37 (b) a special group license plate issued for a:

38 (i) vintage vehicle;

39 (ii) farm truck; or

40 (iii) special group license plate described in Section 41-1a-1602.

52 (1) An applicant for a sponsored special group license plate shall submit to the division:

53 (a) in a form and manner that the division prescribes, a complete application;

54 (b) payment of the fee for the issuance of the sponsored special group license plate
55 established under Subsection (4)(a)(i);

56 (c) the required contribution for the sponsored special group license plate, unless the
57 applicant previously paid the required contribution as part of a preorder application
58 described in Subsection [~~(4)~~] (3); and

93 Section 41-1a-419 is \$25 which the division shall allocate as follows:
- 94 (a) \$2 to the Utah State Historical Society as the sponsoring organization; and
95 (b) \$23 into the Transportation Investment Fund of 2005 created in Section 72-2-124.
- 96 (7) For a fiscal year beginning on July 1, 2025, only, the division shall transfer into the

97 General Fund \$3,500,000 from the Sponsored Special Group License Plate Fund created

167 The following sums of money are appropriated for the fiscal year beginning July 1,
168 2025, and ending June 30, 2026. These are additions to amounts previously appropriated for
169 fiscal year 2026.

170 Subsection 4(a). **Expendable Funds and Accounts**

171 The Legislature has reviewed the following expendable funds. The Legislature
172 authorizes the State Division of Finance to transfer amounts between funds and accounts as
173 indicated. Outlays and expenditures from the funds or accounts to which the money is
174 transferred may be made without further legislative action, in accordance with statutory
175 provisions relating to the funds or accounts.
