State Custody Amendments

Representative **Karianne Lisonbee** proposes the following amendments:

1. *Line 350 through 360:*

350 dosage of treatment and successfully completes the program within three months.

(15) "Puberty inhibition drug treatment" means administering, prescribing, or supplying for effectuating or facilitating an individual's attempted sex change, any of the following alone or in combination with aromatase inhibitors:

(a) gonadotropin-releasing hormone agonists; or

(b) androgen receptor inhibitors.

3. *Line 380 through 382:*

380 (iv) family counseling.

382 the division to provide youth services.

4. *Line 385 through 389:*

385 (1) The division may not initiate any of the following procedures or treatments for a minor:

386 (a) **puberty inhibition drug treatment;**

(b) a cross-sex hormone treatment;

388 {~~(c)~~} **(d)** a secondary sex characteristic surgical procedure.
