- 27 Section 1. Section **53B-2-104** is amended to read:
- 28 53B-2-104. Degree-granting institution board of trustees -- Membership -- Terms -- Vacancies -- Oath -- Officers -- Bylaws -- Quorum -- Committees -- Compensation.
- 28 (1) As used in this section  $[\frac{1}{2}]$ :
- 29 (a) ["board] Board of trustees" means the board of trustees for a degree-granting institution.
- 31 (b) "Service area" means the geographic area, {described in Section 53B-2a-201} as board policy determines, where a degree-granting institution has primary responsibility for providing educational programs and services.
- 34 (2)
  - (a) The board of trustees of a degree-granting institution consists of the following:
- 35 (i) except as provided in Subsection [(2)(e)] (2)(d), eight individuals who are residents of Utah, appointed by the governor with the advice and consent of the Senate in accordance with Title 63G, Chapter 24, Part 2, Vacancies; and
- 38 (ii) two ex officio members who are the president of the institution's alumni association, and the president of the associated students of the institution.
