- 1741 (ii) state or federal judge of an appellate, district, justice, or juvenile court, or court commissioner;
- 1743 (iii) judge authorized by Title 39A, Chapter 5, Utah Code of Military Justice;
- 1744 (iv) judge authorized by Armed Forces, Title 10, United States Code;
- 1745 (v) federal prosecutor;
- (vi) prosecutor appointed pursuant to Armed Forces, Title 10, United States Code;
- 1747 (vii) law enforcement official as defined in Section 53-5-711;
- 1748 (viii) prosecutor authorized by Title 39A, Chapter 5, Utah Code of Military Justice; or
- 1749 (ix) state or local government employee who, because of the unique nature of the employee's regular work assignments or because of one or more recent credible threats directed to or against the
