### LONG TITLE

#### General Description:

This bill amends restrictions on a newly licensed driver that is younger than 18 years old.

#### Highlighted Provisions:

This bill:

- ▶ allows a newly licensed driver who is younger than 18 years old to drive one passenger {who} that is {not an immediate family member;} younger than 18 years old; and
- ▶ allows an individual with a learner permit who is younger than 18 years old to drive with an adult other than a parent, in certain circumstances.

- 22 Section 1. Section **41-8-3** is amended to read:
- 23 **41-8-3. Operation of vehicle by persons under 16 and six months -- Passenger limitations --**  
**Exceptions -- Penalties.**
- 22 (1) In addition to the provisions of Title 53, Chapter 3, Uniform Driver License Act, a person, whether resident or nonresident of this state, may not operate a motor vehicle upon any highway of this state with [any] more than one passenger who is [not an immediate family member of the driver] younger than 18 years old until the earlier of:
- 26 (a) six months from the date the [person's] individual's driver license was issued; or
- 27 (b) the [person] individual reaches 18 years [of age] old.

shall cover the topic of major causes of traffic related deaths as identified in statistics published by  
the Highway Safety Office.
