Be it enacted by the Legislature of the state of Utah:

Section 1. Section **1** is enacted to read:

Part 1. SNAP Benefits Waiver

35A-17-101. Definitions.

As used in this section:

{~~(a)~~} {~~"Candy" means a preparation of sugar, honey, or other natural or artificial sweeteners in combination with chocolate, fruit, nuts, or other ingredients or flavorings in the form of bars, drops, or pieces, and does not require refrigeration.~~} }

{~~(b)~~} {~~"Candy" does not include a protein bar with no added sugar.~~} }

{~~(2)~~} (1) "SNAP" means the federal Supplemental Nutrition Assistance Program, 7 U.S.C. Chapter 51.

{~~(3)~~} (2) "SNAP benefit" means a financial benefit, coupon, or privilege available under SNAP.

(a) "Soft drink" means a nonalcoholic beverage that is made with carbonated water and that is flavored and sweetened with sugar or artificial sweeteners.

(b) "Soft drink" does not include a beverage that contains milk, milk products, soy, rice, or other milk substitutes, or that is greater than 50% vegetable or fruit juice by volume.
