\_\_\_\_\_(i) [the six public trustees are from different counties and are residents of the state] among the six public trustees, no more than two are from the same county and all are residents of the state; and

(ii) [not] except as provided in Subsection 67-1-2.5(15)(a), no more than three of the public trustees are members of the same political party.".
