LONG TITLE

General Description:

This bill modifies provisions relating to elections.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ requires a county clerk to coordinate with local post offices to ensure the optimal handling of ballots;
- ▶ provides that a poll watcher may observe the signature-verification process for ~~{petitions}~~ a petition to qualify a candidate for a primary election ballot (candidate petition) or for a written request to remove a signature from a candidate petition;
- ▶ makes it unlawful for a poll watcher to reveal certain information observed during the process described in the preceding paragraph;
- ▶ requires an election officer to conduct an audit of signature comparisons made for ~~{petitions to qualify}~~ a candidate ~~{for a primary election ballot}~~ petition;

requires an election officer who engages in the signature-verification process for {petitions to qualify} a candidate {for a primary election ballot} petition to certify a certain percentage of signatures submitted beyond the required signature-gathering threshold;
