- Except as provided in Subsection (2), a bicycle, electric assisted bicycle, mini-motorcycle, motor assisted scooter, or moped may not be used to carry more persons at one time than the number for which it is designed or equipped.
- 436 (2) An adult rider may carry a child securely attached to the adult rider's person in a back pack or sling.
- 439 Section 3. Section **41-6a-1106** is amended to read:
- 440 **41-6a-1106.** Bicycles, electric assisted bicycles, mini-motorcycles, motor assisted scooters, or moped to yield right-of-way to pedestrians on sidewalks, paths, or trails -- Uses prohibited --Negligent collision prohibited -- Speed restrictions -- Rights and duties same as pedestrians.
- 443 [(1) A person operating a bicycle or a vehicle or device propelled by human power shall:]
- 444 [(a) yield the right-of-way to any pedestrian; and]
- 445 [(b) give an audible signal before overtaking and passing a pedestrian.]
- 446 [(2) A person 18 years of age or older may not operate a bicycle or a vehicle or device propelled by human power on a sidewalk, path, or trail, or across a roadway in a crosswalk, where prohibited by a traffic-control device or ordinance.]
- 449 [(3) A person may not operate a bicycle or a vehicle or device propelled by human power in a negligent manner so as to collide with a:]

- (1) A person under the age of 21 may not operate or ride any of the following on a highway unless the person is wearing protective headgear that complies with specifications adopted under Subsection (3):
- 492 (a) a motorcycle;
- 493 (b) a motor-driven cycle;
- 494 (c) [a class 3-] an electric assisted bicycle; or
- 495 (d) an autocycle that is not fully enclosed.
- 496 (2) This section does not apply to persons riding within an enclosed cab.
- 497 (3) The following standards and specifications for protective headgear are adopted:
- 498 (a) 49 C.F.R. 571.218 related to protective headgear for motorcycles; and

- (b) 16 C.F.R. Part 1203 related to protective headgear for bicycles, motor assisted scooters, and electric personal assistive mobility devices.
