Section **57-14-102** is amended to read: **57-14-102** . Definitions. 22 23 As used in this chapter: 24 (1) "Charge" means the admission price or fee asked in return for permission to enter or go 25 upon the land. 26 (2) "Child" means an individual who is 16 years old or younger. 27 (3)(a) "Land" means any land within the state boundaries. 28 (b) "Land" includes roads, railway corridors, water, water courses, private ways and 29 buildings, structures, and machinery or equipment when attached to the realty. 30 (4) "Owner" means the possessor of any interest in the land, whether public or private land,

including a tenant, a lessor, a lessee, an occupant, or person in control of the land.

32 (5) "Person" includes any [person] <u>individual</u>, regardless of age, maturity, or experience,

- who enters upon or uses land for recreational purposes.
