1 **LONG TITLE**

2 **General Description:**

3 This bill modifies resident district payments to a nonresident district under certain

17 **53G-6-405**, as last amended by Laws of Utah 2023, Chapter 252

18 *Be it enacted by the Legislature of the state of Utah:*

19 Section 1. Section **53G-6-405** is amended to read:

20 **53G-6-405 . Funding.**

21 (1) A student who enrolls in a nonresident district is considered a resident of that district for
22 purposes of state funding.

23 (2) The state board shall adopt rules providing that:

24 (a) except as provided in Subsection (2)(b):

25 (i) the resident district pay the nonresident district, for each of the resident district's
26 students who enroll in the nonresident district, 1/2 of the amount by which the
27 resident district's per student expenditure exceeds the value of the state's
28 contribution; and

29 ~~[(b)]~~ (ii) if a student is enrolled in a nonresident district for less than a full year, the

- 31 resident district shall pay a portion of the amount specified in this Subsection
32 (2)(a) based on the percentage of school days the student is enrolled in the
33 nonresident district~~[-]~~ ; and
34 (b) the payment requirements under Subsection (2)(a) do not apply to students enrolled
35 in an online school within the nonresident district.
36 (3)(a) Except as provided in this Subsection (3), the parent of a nonresident student shall
37 arrange for the student's own transportation to and from school.
38 (b) The state board may adopt rules under which a nonresident student may be
39 transported to the student's school of attendance if:
40 (i) transportation relieves overcrowding or other serious problems in the district of
41 residence;
42 (ii) the district of residence lacks sufficient transportation services;
43 (iii) the costs of transportation are reasonable;
44 (iv) there is available space on an approved route within the student's school of
45 attendance; or
46 (v) the Legislature has granted an adequate specific appropriation for that purpose.
47 (c) Nothing in this section shall be construed as prohibiting the resident district or the
48 receiving district from providing bus transportation on any approved route.
49 (d) Except as provided in Subsection (3)(b), the district of residence may not claim any
50 state transportation costs for students enrolled in other school districts.

51 **Section 2. Effective Date.**

52 This bill takes effect on July 1, 2025.
