 3 **LONG TITLE**

4 **General Description:**

5 This bill amends provisions regarding the Volunteer Emergency Medical Service Personnel
 6 Insurance Program.

17 **53-2d-703**, as last amended by Laws of Utah 2024, Chapters 138, 240

19 *Be it enacted by the Legislature of the state of Utah:*

20 Section 1. Section **53-2d-703** is amended to read:

21 **53-2d-703 . Volunteer Emergency Medical Service Personnel Insurance Program**

22 **-- Creation -- Administration -- Eligibility -- Benefits -- Rulemaking -- Advisory board.**

23 (1) As used in this section:

24 (a) "Basic life insurance benefit" means the standard group life insurance benefit offered
 25 by PEHP that combines basic life, line-of-duty, accidental death and disability, and
 26 dependent coverage into one benefit package.

27 (b) "Basic long-term disability benefit" means a \$1,000 monthly benefit arising from a
 28 disability determined in accordance with Title 49, Chapter 21, Public [Employee's
 29 Long-term] Employees' Long-Term Disability Act, and excluding any coverage
 30 offered on a pilot basis.

31 (c) "Dental plan" means the same as that term is defined in Section 31A-22-646.

- 32 (d) "Health benefit plan" means the same as that term is defined in Section 31A-1-301.
- 33 (e) "Local government entity" means a political subdivision that:
- 34 (i) is licensed as a ground ambulance provider under Part 5, Ambulance and
- 35 Paramedic Providers; and
- 36 (ii) does not offer health insurance benefits to volunteer emergency medical service
- 37 personnel.
- 38 (f) "PEHP" means the Public Employees' Benefit and Insurance Program created in
- 39 Section 49-20-103.
- 40 (g) "Political subdivision" means a county, a municipality, a limited purpose government
- 41 entity described in Title 17B, Limited Purpose Local Government Entities - Special
- 42 Districts, or Title 17D, Limited Purpose Local Government Entities - Other Entities,
- 43 or an entity created by an interlocal agreement under Title 11, Chapter 13, Interlocal
- 44 Cooperation Act.
- 45 (h) "Qualifying association" means an association that represents two or more political
- 46 subdivisions in the state.
- 47 ~~[(i) "Qualifying community" means a city or community that:]~~
- 48 ~~[(i) has a population less than or equal to 3,000; and]~~
- 49 ~~[(ii) is located within a county of the second class.]~~
- 50 (i) "Qualifying community" means any of the following located in a county of the
- 51 second class:
- 52 (i) a city of the fifth class; or
- 53 (ii) a town.
- 54 (2) The Volunteer Emergency Medical Service Personnel Insurance Program shall promote
- 55 recruitment and retention of volunteer emergency medical service personnel by making
- 56 insurance available to volunteer emergency medical service personnel in accordance
- 57 with this section.
- 58 (3)(a) The bureau shall contract with a qualifying association to create, implement, and
- 59 administer the Volunteer Emergency Medical Service Personnel Insurance Program
- 60 described in this section.
- 61 (b) The qualifying association will create promotional campaigns for the Volunteer
- 62 Emergency Medical Service Personnel Insurance Program and volunteer emergency
- 63 medical service recruitment and retention including outreach to local government
- 64 entities through social media, video production, and other media platforms.
- 65 (4) Participation in the program is limited to any individual who:

- 66 (a) is licensed under Section 53-2d-402 as an emergency medical technician, an
67 advanced emergency medical technician, or a paramedic;
- 68 (b) is able to perform all necessary functions associated with the license;
- 69 (c) provides emergency medical services under the direction of a local governmental
70 entity:
- 71 (i) by responding to 20% of calls for emergency medical services in a rolling
72 twelve-month period; and
- 73 (ii) within a qualifying community or a county of the third, fourth, fifth, or sixth class
74 by responding to the number of calls described in Subsection (4)(c)(i); and
- 75 (iii)(A) as a volunteer under the Fair Labor Standards Act, in accordance with 29
76 C.F.R. Sec. 553.106; or
- 77 (B) as a part-time unbenefited employee, as classified by the employing local
78 government entity;
- 79 (d) if seeking health insurance:
- 80 (i)(A) is not eligible for a health benefit plan through an employer or a spouse's
81 employer; and
- 82 (B) is not eligible for medical coverage under a government sponsored healthcare
83 program; or
- 84 (ii) the individual's premium cost for individual, double, or family coverage through
85 another source exceeds 20% or greater of the premium cost of the program created
86 by this section;
- 87 (e) if seeking dental insurance:
- 88 (i)(A) is not eligible for a dental plan through an employer or a spouse's employer;
89 and
- 90 (B) is not eligible for dental coverage under a government sponsored healthcare
91 program; or
- 92 (ii) the individual's premium cost for individual, double, or family coverage exceeds
93 20% or greater of the premium cost of the program created by this section; and
- 94 (f) resides in the state.
- 95 (5)(a) A participant in the program is eligible to participate in PEHP in accordance with
96 Subsection (5)(b) and Subsection 49-20-201(3).
- 97 (b) Health and dental benefits available to program participants under PEHP are limited
98 to health insurance and dental insurance that:
- 99 (i) covers the program participant and the program participant's eligible dependents

- 100 on a July 1 plan year;
- 101 (ii) accepts enrollment during an open enrollment period or for a special enrollment
102 event, including the initial eligibility of a program participant;
- 103 (iii) if the program participant is no longer eligible for benefits, terminates on the last
104 day of the last month for which the individual is a participant in the Volunteer
105 Emergency Medical Service Personnel Insurance Program; and
- 106 (iv) is not subject to continuation rights under state or federal law.
- 107 (c) Within existing appropriations, the Volunteer Emergency Medical Service Personnel
108 Insurance Program may offer basic life insurance and long-term disability insurance
109 to participants to enhance recruitment and retention efforts.
- 110 (6)(a) The bureau may make rules in accordance with Title 63G, Chapter 3, Utah
111 Administrative Rulemaking Act, to define additional criteria regarding benefit
112 design, eligibility for the program, and to implement this section.
- 113 (b) The bureau shall convene an advisory board:
- 114 (i) to advise the bureau on making rules under Subsection (6)(a); and
115 (ii) that includes representation from at least the following entities:
- 116 (A) the qualifying association that receives the contract under Subsection (3); and
117 (B) PEHP.
- 118 (7) For purposes of this section, the qualifying association that receives the contract under
119 Subsection (3) shall be considered the public agency for whom the program participant
120 is volunteering under 29 C.F.R. Sec. 553.101.

121 **Section 2. Effective Date.**
