10	statute, for 60 calendar days immediately preceding the general election.

12	This resolution directs the lieutenant governor to submit this proposal to voters.

- 32 The revision or amendment of an entire article or the addition of a new article to this
- 33 Constitution may be proposed as a single amendment and may be submitted to the electors as a
- 34 single question or proposition. Such amendment may relate to one subject, or any number of
- 35 subjects, and may modify, or repeal provisions contained in other articles of the Constitution,
- 36 if such provisions are germane to the subject matter of the article being revised, amended or
- 37 being proposed as a new article.
- 38 Section 2. Submittal to voters.
- 39 The lieutenant governor is directed to submit this proposed amendment to the voters of
- 40 the state at the next regular general election in the manner provided by law.

41 Section 3. Contingent effective date.

- 42 If the amendment proposed by this joint resolution is approved by a majority of those
- 43 voting on it at the next regular general election, the amendment shall take effect on January 1,
