68	possesses a physical or mental impairment that substantially affects the
69	individual's ability to:
70	(A) provide personal protection;
71	(B) provide necessities such as food, shelter, clothing, or medical or other health
72	care;
73	(C) obtain services necessary for health, safety, or welfare;
74	(D) carry out the activities of daily living;
75	(E) manage the adult's own resources; or
76	(F) comprehend the nature and consequences of remaining in a situation of abuse,
77	neglect, or exploitation.
78	(b) Terms defined in Section 76-1-101.5 apply to this section.
79	(2) An actor commits care provider sexual relations with a vulnerable adult if:
80	(a)(i) the actor is employed by, volunteers for, or otherwise assists a health care
81	facility or human services program; or
82	(ii) the actor is a health care provider;
83	(b)(i) the actor has sexual intercourse with a vulnerable adult; or
84	(ii) the actor with the intent to cause substantial emotional or bodily pain to any
85	individual or with the intent to arouse or gratify the sexual desire of any individual
86	(A) touches the anus, buttocks, pubic area, or any part of the genitals of a
87	vulnerable adult;
88	(B) touches the breast of a vulnerable adult if the vulnerable adult is female; or
89	(C) otherwise takes indecent liberties with a vulnerable adult;
90	(c) the vulnerable adult described in Subsection (2)(b) is:
91	(i) currently under the care or responsibility of the actor; or
92	(ii) currently a patient of, or receiving services from, the health care facility or human
93	services program where the actor is employed, volunteers, or otherwise assists; and
94	(d) the actor knows, or should have known, that at the time the actor committed the acts
95	described in Subsection (2)(b) against the vulnerable adult, the individual was under
96	the care or responsibility of:
97	(i) the actor; or
98	(ii) the health care facility or human services program where the actor is employed,
99	volunteers, or otherwise assists.

100	(3) A violation of Subsection (2) is a class A misdemeanor.
101	(4) Consent of a vulnerable adult to an act described in Subsection (2)(b) is not a defense to
102	prosecution under this section.
103	(5) This section does not apply if the actor is married to, cohabiting with, or has a
104	pre-existing consensual sexual relationship with the vulnerable adult before the
105	vulnerable adult:
106	(a) is placed under the care or responsibility of the actor; or
107	(b) becomes a patient of, or receives services from, the health care facility or human
108	services program where the actor is employed, volunteers, or otherwise assists.
109	Section 2. Effective date.
110	This bill takes effect on May 7, 2025.
