32	72-10-134 . Restrictions on release of chemicals for weather geoengineering
33	Criminal penalty.
34	(1) As used in this section:
35	(a) "Solar radiation management" means the release, injection, or dispersing of
36	chemicals to artificially reduce the amount of solar radiation reaching the Earth's
37	lower atmosphere or surface.
38	(b)(i) "Weather geoengineering" means the modification of the composition,
39	behavior, or dynamics of the Earth's atmosphere by solar radiation management.
40	(ii) "Weather geoengineering" does not include activities described in Title 73,
41	Chapter 15, Modification of Weather.
42	(2)(a) It is unlawful for an owner or operator of an aircraft to use or authorize the use of
43	the aircraft in this state with the intent to cause weather geoengineering.
44	(b) A violation of Subsection (2)(a) is a third degree felony.
45	(3) The department shall:
46	(a) provide a means for a member of the public to electronically submit information
47	regarding suspected weather geoengineering activity; and
48	(b) report a credible instance of suspected geoengineering activity to the Office of the
49	Attorney General.
50	Section 3. Effective Date.
51	This bill takes effect on May 7, 2025.
