LONG TITLE

General Description:

This bill addresses issues related to estate planning.

Highlighted Provisions:

This bill:

- ▶ creates and amends definitions related to estate planning;
- ▶ addresses the requirements for making a will, including the requirements for testamentary capacity;
- ▶ amends the rule against perpetuities for a power of appointment;
- ▶ clarifies the legal standard of proof for a guardianship;
- ▶ removes the requirement that a person alleged to be incapacitated be present at the guardianship hearing;
- ▶ allows a trustee to decant a trust in certain circumstances;
- ▶ addresses the capacity to make a power of attorney;
- ▶ addresses the capacity to appoint an agent for purposes of an advanced health care directive;
- ▶ modifies the capacity required for a custodian for Title 75A, Chapter 8, Uniform Transfers to Minors Act;
- ▶ recodifies Title 75B, Chapter 1, Part 3, Asset Protection Trust;
- ▶ defines asset protection trust to include an irrevocable trust for which the settlor may be made a beneficiary by the act or action of another person;
- ▶ provides that an affidavit of solvency for an asset protection trust is discretionary;
- ▶ provides that a person may only bring a cause of action or claim for relief regarding a fraudulent or voidable transfer for assets transferred to the asset protection trust within the limitations period;
- ▶ provides that, if a trustee makes multiple transfers to an asset protection trust, a

- 29 distribution is considered to be made from the most recent transfer;
- 30 ▸ allows a trustee to convey property held in the asset protection trust to the settlor or
- 31 beneficiary to secure financing;
- 32 ▸ provides that the property has to be reconveyed to the trustee within a certain time period
- 33 to not be considered a transfer for purposes of the limitations period;
- 34 ▸ includes a coordination clause to address a technical conflict with a cross-reference
- 35 change if this bill and H.B. 334, Guardianships and Supported Decision-Making
- 36 Agreements Amendments, both pass and become law;
- 37 ▸ includes a coordination clause to coordinate technical and substantive changes if this bill
- 38 and S.B. 100, Estate Planning Recodification, both pass and become law; and
- 39 ▸ makes technical and conforming changes.

Be it enacted by the Legislature of the state of Utah:

The following section is affected by a coordination clause at the end of this bill.

Section 1. Section **7-5-1** is amended to read:

7-5-1 . Definitions -- Allowable trust companies -- Exceptions.

(1) As used in this chapter:

- (a) "Business trust" means an entity engaged in a trade or business that is created by a declaration of trust that transfers property to trustees, to be held and managed by them for the benefit of persons holding certificates representing the beneficial interest in the trust estate and assets.
- (b) "Trust business" means, except as provided in Subsection (1)(c), a business in which one acts in any agency or fiduciary capacity, including that of personal representative, executor, administrator, conservator, guardian, assignee, receiver, depositary, or trustee under appointment as trustee for any purpose permitted by law[; ~~including the definition of "trust" set forth in Subsection 75-1-201(55)].~~
- (c) "Trust business" does not include the following means of holding money, assets, or other property:
 - (i) money held in a client trust account by an attorney authorized to practice law in this state;
 - (ii) money held in connection with the purchase or sale of real estate by a person licensed as a principal broker in accordance with Title 61, Chapter 2f, Real Estate Licensing and Practices Act;
 - (iii) money or other assets held in escrow by a person authorized by the department in accordance with Chapter 22, Regulation of Independent Escrow Agents, or by the Utah Insurance Department to act as an escrow agent in this state;
 - (iv) money held by a homeowners' association or similar organization to pay maintenance and other related costs for commonly owned property;
 - (v) money held in connection with the collection of debts or payments on loans by a person acting solely as the agent or representative or otherwise at the sole direction of the person to which the debt or payment is owed, including money held by an escrow agent for payment of taxes or insurance;
 - (vi) money and other assets held in trust on an occasional or isolated basis by a person who does not represent that the person is engaged in the trust business in Utah;

- 131 (vii) money or other assets found by a court to be held in an implied, resulting, or
132 constructive trust;
- 133 (viii) money or other assets held by a court appointed conservator, guardian, receiver,
134 trustee, or other fiduciary if:
- 135 (A) the conservator, receiver, guardian, trustee, or other fiduciary is responsible to
136 the court in the same manner as a personal representative under Title 75,
137 Chapter 3, Part 5, Supervised Administration, or as a receiver under Rule 66,
138 Utah Rules of Civil Procedure; and
- 139 (B) the conservator, trustee, or other fiduciary is a certified public accountant or
140 has qualified for and received a designation as a certified financial planner,
141 chartered financial consultant, certified financial analyst, or similar designation
142 suitable to the court, that evidences the conservator's, trustee's, or other
143 fiduciary's professional competence to manage financial matters;
- 144 (ix) money or other assets held by a credit services organization operating in
145 compliance with Title 13, Chapter 21, Credit Services Organizations Act;
- 146 (x) money, securities, or other assets held in a customer account in connection with
147 the purchase or sale of securities by a regulated securities broker, dealer, or
148 transfer agent; or
- 149 (xi) money, assets, and other property held in a business trust for the benefit of
150 holders of certificates of beneficial interest if the fiduciary activities of the
151 business trust are merely incidental to conducting business in the business trust
152 form.
- 153 (d) "Trust company" means an institution authorized to engage in the trust business
154 under this chapter. Only the following may be a trust company:
- 155 (i) a Utah depository institution or its wholly owned subsidiary;
- 156 (ii) an out-of-state depository institution authorized to engage in business as a
157 depository institution in Utah or its wholly owned subsidiary;
- 158 (iii) a corporation, including a credit union service organization, owned entirely by
159 one or more federally insured depository institutions as defined in Subsection
160 7-1-103(8);
- 161 (iv) a direct or indirect subsidiary of a depository institution holding company that
162 also has a direct or indirect subsidiary authorized to engage in business as a
163 depository institution in Utah; and
- 164 (v) any other corporation continuously and lawfully engaged in the trust business in

165 this state since before July 1, 1981.

166 (2) Only a trust company may engage in the trust business in this state.

167 (3) The requirements of this chapter do not apply to:

168 (a) an institution authorized to engage in a trust business in another state that is engaged
169 in trust activities in this state solely to fulfill its duties as a trustee of a trust created
170 and administered in another state;

171 (b) a national bank, federal savings bank, federal savings and loan association, or federal
172 credit union authorized to engage in business as a depository institution in Utah, or
173 any wholly owned subsidiary of any of these, to the extent the institution is
174 authorized by its primary federal regulator to engage in the trust business in this state;
175 or

176 (c) a state agency that is otherwise authorized by statute to act as a conservator, receiver,
177 guardian, trustee, or in any other fiduciary capacity.

178 Section 2. Section **75-1-201** is amended to read:

179 **75-1-201 . Title definitions.**

180 As used in this title:

181 (1) "Agent" includes an attorney-in-fact under a durable or nondurable power of attorney,
182 an individual authorized to make decisions concerning another's health care, and an
183 individual authorized to make decisions for another under a natural death act.

184 (2) "Application" means a written request to the registrar for an order of informal probate or
185 appointment under Chapter 3, Part 3, Informal Probate and Appointment Proceedings.

186 (3)(a) "Beneficiary," as it relates to trust beneficiaries, includes:

187 (i) a person who has any present or future interest, vested or contingent; and

188 (ii) the owner of an interest by assignment or other transfer.

189 (b) "Beneficiary," as it relates to a charitable trust, includes any person entitled to
190 enforce the trust.

191 (c) "Beneficiary," as it relates to a beneficiary of a beneficiary designation, means a
192 beneficiary of:

193 (i) an insurance or annuity policy;

194 (ii) an account with POD designation;

195 (iii) a security registered in beneficiary form (TOD);

196 (iv) a pension, profit-sharing, retirement, or similar benefit plan; or

197 (v) other nonprobate transfer at death.

198 (d) "Beneficiary," as it relates to a beneficiary designated in a governing instrument,

- 199 includes:
- 200 (i) a grantee of a deed, a devisee, a trust beneficiary, a beneficiary of a beneficiary
201 designation, a donee, appointee, or taker in default of a power of appointment; and
202 (ii) a person in whose favor a power of attorney or a power held in any individual,
203 fiduciary, or representative capacity is exercised.
- 204 (4) "Beneficiary designation" means a governing instrument naming a beneficiary of an
205 insurance or annuity policy, of an account with POD designation, of a security registered
206 in beneficiary form (TOD), or of a pension, profit-sharing, retirement, or similar benefit
207 plan, or other nonprobate transfer at death.
- 208 (5)(a) "Child" includes any individual entitled to take as a child under this title by
209 intestate succession from the parent whose relationship is involved.
- 210 (b) "Child" does not include an individual who is only a stepchild, a foster child, a
211 grandchild, or any more remote descendant.
- 212 (6)(a) "Claims," in respect to estates of decedents and protected persons, includes
213 liabilities of the decedent or protected person, whether arising in contract, in tort, or
214 otherwise, and liabilities of the estate which arise at or after the death of the decedent
215 or after the appointment of a conservator, including funeral expenses and expenses of
216 administration.
- 217 (b) "Claims" does not include estate or inheritance taxes, or demands or disputes
218 regarding title of a decedent or protected person to specific assets alleged to be
219 included in the estate.
- 220 (7) "Community property with a right of survivorship" means joint tenants with the right of
221 survivorship.
- 222 (8) "Conservator" means a person who is appointed by a court to manage the estate of a
223 protected person.
- 224 (9) "Court" means any of the courts of record in this state having jurisdiction in matters
225 relating to the affairs of decedents.
- 226 (10) "Descendant" means all of an individual's descendants of all generations, with the
227 relationship of parent and child at each generation being determined by the definition of
228 child and parent contained in this title.
- 229 (11) "Devise," when used as a noun, means a testamentary disposition of real or personal
230 property and, when used as a verb, means to dispose of real or personal property by will.
- 231 (12) "Devisee" means any person designated in a will to receive a devise. For the purposes
232 of Chapter 3, Probate of Wills and Administration, in the case of a devise to an existing

233 trust or trustee, or to a trustee in trust described by will, the trust or trustee is the devisee,
234 and the beneficiaries are not devisees.

235 (13) "Disability" means cause for a protective order as described by Section 75-5-401.

236 (14) "Distributee" means any person who has received property of a decedent from his
237 personal representative other than as a creditor or purchaser. A testamentary trustee is a
238 distributee only to the extent of distributed assets or increment thereto remaining in his
239 hands. A beneficiary of a testamentary trust to whom the trustee has distributed
240 property received from a personal representative is a distributee of the personal
241 representative. For purposes of this provision, "testamentary trustee" includes a trustee
242 to whom assets are transferred by will, to the extent of the devised assets.

243 (15) "Estate" includes the property of the decedent, trust, or other person whose affairs are
244 subject to this title as originally constituted and as it exists from time to time during
245 administration.

246 (16) "Exempt property" means that property of a decedent's estate which is described in
247 Section 75-2-403.

248 (17) "Fiduciary" includes a personal representative, guardian, conservator, and trustee.

249 (18) "Foreign personal representative" means a personal representative of another
250 jurisdiction.

251 (19) "Formal proceedings" means proceedings conducted before a judge with notice to
252 interested persons.

253 (20) "General personal representative" does not include a special administrator.

254 (21) "General power of appointment" means the same as that term is defined in Section
255 75A-4-102.

256 [~~(21)~~] (22) "Governing instrument" means a deed, will, trust, insurance or annuity policy,
257 account with POD designation, security registered in beneficiary form (TOD), pension,
258 profit-sharing, retirement, or similar benefit plan, instrument creating or exercising a
259 power of appointment or a power of attorney, or a dispositive, appointive, or nominative
260 instrument of any similar type.

262 incapacitated person pursuant to testamentary or court appointment, or by written

270 to the extent that the individual lacks the ability, even with appropriate technological

272 safety, or self-care:

273 (a) receive and evaluate information;

274 (b) make and communicate decisions; or

275 (c) provide for necessities such as food, shelter, clothing, health care, or safety.

287 representative, other fiduciaries representing interested persons, a settlor of a trust, if
288 living, or the settlor's legal representative, if any, if the settlor is living but
289 incapacitated.

291 ~~[(29)]~~ (30)(a) "Joint tenants with the right of survivorship" includes coowners of property
292 held under circumstances that entitle one or more to the whole of the property on the
293 death of the other.

294 (b) "Joint tenants with the right of survivorship" does not include forms of coownership
295 registration in which the underlying ownership of each party is in proportion to that
296 party's contribution.

297 ~~[(30)]~~ (31) "Lease" includes an oil, gas, or other mineral lease.

298 ~~[(31)]~~ (32) "Letters" includes letters testamentary, letters of guardianship, letters of
299 administration, and letters of conservatorship.

300 ~~[(32)]~~ (33) "Minor" means a person who is under 18 years old.

301 [~~(33)~~] (34) "Minor protected person" means a minor for whom a conservator has been
302 appointed because of minority.

303 [~~(34)~~] (35) "Minor ward" means a minor for whom a guardian has been appointed solely
304 because of minority.

305 [~~(35)~~] (36) "Mortgage" means any conveyance, agreement, or arrangement in which
306 property is used as security.

307 (37) "Nongeneral power of appointment" means the same as that term is defined in Section
308 75A-4-102.

310 jurisdiction at the time of the decedent's death.

311 [~~(37)~~] (39) "Organization" includes a corporation, limited liability company, business trust,
312 estate, trust, partnership, joint venture, association, government or governmental
313 subdivision or agency, or any other legal or commercial entity.

315 take if the child died without a will, as a parent under this title by intestate succession

339 or in payments out of production under such a title or lease, collateral trust certificate,
340 transferable share, voting trust certificate, and, in general, any interest or instrument
341 commonly known as a security, or any certificate of interest or participation, any

1928 association dues, maintenance expenses, or other similar expenses on the property; or
1929 (d) pay income tax on income attributable to the portion of property held in the trust, of
1930 which the settlor is considered to be the owner under 26 U.S.C. Secs. 671 through
1931 678, which payments will not be considered additional transfers to the trust for
1932 purposes of this part.

1933 Section 31. Section **75B-1-305** is enacted to read:

1934 **75B-1-305 . Illusory agreement.**

1935 An agreement or understanding, express or implied, between a settlor and a trustee of an
1936 asset protection trust is void if that agreement or understanding attempts to grant or permit the
1937 retention by the settlor of greater rights or authority than is stated in the trust instrument.

1938 Section 32. Section **75B-1-306** is enacted to read:

1939 **75B-1-306 . Affidavit of solvency.**

1940 With respect to a transfer of assets to an asset protection trust, a settlor may sign a sworn
1941 affidavit stating that at the time of the transfer of the assets to the trust:

1942 (1) the settlor has full right, title, and authority to transfer the assets to the trust;

1943 (2) the transfer of the assets to the trust will not render the settlor insolvent;

1944 (3) the settlor does not intend to hinder, delay, or defraud a known creditor by transferring
1945 the assets to the trust;

1946 (4) there is no pending or threatened court action against the settlor, except for a court
1947 action identified by the settlor on an attachment to the affidavit;

1948 (5) the settlor is not involved in an administrative proceeding that is reasonably expected to
1949 have a material adverse effect on the financial condition of the settlor, except an
1950 administrative proceeding identified on an attachment to the affidavit;

1951 (6) at the time of the transfer of the assets to the trust, the settlor is not in default of a
1952 domestic support obligation;

1953 (7) the settlor does not contemplate filing for relief under the provisions of United States
1954 Code, Title 11, Bankruptcy; and

1955 (8) the assets being transferred to the trust were not derived from unlawful activities.

1956 Section 33. Section **75B-1-307** is enacted to read:

1957 **75B-1-307 . Limitations on cause of action for asset protection trust.**

1958 (1)(a) Except as provided in Subsection (1)(b), a cause of action or claim for relief under
1959 this part is not a cause of action or claim for relief under Title 25, Chapter 6, Uniform
1960 Voidable Transfers Act.

1961 (b) A cause of action or claim for relief under Subsections 75B-1-303(5)(a) and (6)(a) is
1962 a cause of action or claim for relief under Section 25-6-202 or 25-6-203.

1963 (c) A person, including a creditor, may only bring a cause of action under Subsection
1964 78B-1-303(5)(a) or (6)(a) with regard to the portion of the assets transferred to the
1965 trustee of the asset protection trust within the time period described in Subsection (2).

1966 (2) Notwithstanding Section 25-6-305, a cause of action or claim for relief regarding a

- 1967 fraudulent conveyance or other voidable transfer of a settlor's assets under this part is
1968 extinguished unless the action is brought by a creditor of the settlor who was a creditor
1969 of the settlor before the assets in question were transferred to the asset protection trust
1970 and the action is brought within the earlier of:
- 1971 (a) the later of two years after the transfer is made, or one year after the transfer is or
1972 reasonably could have been discovered by the creditor if the creditor:
- 1973 (i) can demonstrate, by clear and convincing evidence, that the creditor asserted a
1974 specific claim against the settlor before the transfer; or
- 1975 (ii) files another action, other than an action alleging a fraudulent conveyance or
1976 other voidable transfer against the settlor that asserts a claim based on an act or
1977 omission of the settlor that occurred before the transfer, and the action described
1978 in this Subsection (2) is filed within two years after the transfer; or
- 1979 (b)(i) with respect to a creditor known to the settlor, 120 days after the date on which
1980 notice of the transfer is mailed to the creditor; or
- 1981 (ii) with respect to a creditor not known to the settlor, 120 days after the date on
1982 which notice of the transfer is first published in a newspaper of general circulation
1983 in the county in which the settlor then resides, or is published on a public legal
1984 notice website as defined in Section 45-1-101.
- 1985 (3) A notice described in Subsection (2)(b)(i) shall:
- 1986 (a) state the name and address of the settlor or the settlor's representative;
1987 (b) state the name and address of the trustee or the trustee's representative;
1988 (c) describe the assets that were transferred, except that the notice does not need to state
1989 the value of the assets if the assets are other than cash; and
- 1990 (d) inform the creditor that the creditor is required to bring the creditor's cause of action
1991 or claim for relief against the settlor and the trustee within 120 days from the mailing
1992 of the notice or be forever barred.
- 1993 (4) A notice described in Subsection (2)(b)(ii) shall:
- 1994 (a) state the name and address of the settlor or the settlor's representative;

 2010 Spendthrift and Discretionary Trusts.

2011 (2) With respect to an irrevocable trust that is not subject to this part, a claim brought by a
 2012 creditor of a beneficiary who is the settlor is subject to the provisions of Subsection
 2013 75-7-505(2).

2014 Section 35. Section **75B-1-309** is enacted to read:

2015 **75B-1-309 . Liability of participant in asset protection trust.**

2016 (1) If the settlor signs an affidavit described in Section 75B-1-306, a person, including a
 2017 creditor, may not assert a cause of action or claim for relief against a trustee of the asset
 2018 protection trust, or against a person that was involved in the counseling, drafting,
 2019 preparation, execution, or funding of the asset protection trust, for:

2020 (a) conspiracy to engage in a voidable transfer;

2021 (b) aiding and abetting a voidable transfer;

2022 (c) participation in the trust transaction; or

2023 (d) a similar cause of action or claim for relief described in Subsections (1)(a) through
 2024 (c).

2025 (2) For purposes of Subsection (1), the counseling, drafting, preparation, execution, or

- 2038 (2) A trustee of an asset protection trust may convey property that is held in trust to a
 2039 beneficiary of the trust, including the settlor, for the beneficiary to secure financing with
 2040 a lien or other encumbrance against the property.
- 2041 (3) If the property described in Subsection (2) is reconveyed to the trustee of the asset
 2042 protection trust within 60 days after the day on which the lien or other encumbrance is
