3 **LONG TITLE**

4 **General Description:**

5 This resolution supports contracting for beds for state inmates at the Juab County  
6 correctional facility.

7 **Highlighted Provisions:**

8 This resolution:

9 ▶ supports jail expansion as beneficial to both the state and the counties through a contract  
10 with the Department of Corrections; and

11 ▶ approves contracting for additional beds dedicated to housing state inmates in Juab  
12 County.

18 *Be it resolved by the Legislature of the state of Utah:*

19 WHEREAS, counties in Utah contract with the Department of Corrections to provide  
20 prison beds for state prisoners;

21 WHEREAS, this contracting arrangement has proved beneficial to both the state and the  
22 counties by saving taxpayers from the burden of building new state correctional facilities  
23 while, at the same time, assisting counties to meet their own correctional space needs;

24 WHEREAS, in accordance with Utah Code Subsection 64-13e-103(6), the Department of  
25 Corrections may not enter into a contract with a county to house state inmates unless the  
26 Legislature has previously passed a joint resolution that includes the approximate number of  
27 beds to be contracted, the approximate amount of a county's long-term debt, and the repayment

28 time of the debt for the facility where inmates are to be housed;

29 WHEREAS, the Department of Corrections is authorized to contract for 205 beds in  
30 addition to the current 15 beds in Juab County;

31 WHEREAS, the correctional facility that will house the inmates in Juab County has  
32 \$60,000,000 in facility debt, and the repayment time for the debt for the facility is a 30-year  
33 period;

34 WHEREAS, Juab County will have sufficient facilities and beds to accommodate the  
35 additional state inmates and has met the requirements of Utah Code Subsection 64-13e-103(6);  
36 and

37 WHEREAS, contracting with the Department of Corrections for additional jail bed space  
38 would assist the state in addressing projected bed space, rehabilitation, and security needs:

39 NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah approves  
40 contracting for beds in the correctional facility located in Juab County in the amount specified  
41 in this resolution.

42 BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Juab County  
43 Commission and the Department of Corrections.
