104	manage the infrastructure.

108	(17) The division shall complete an analysis to determine the infrastructure and engineering

112	management of both native and invasive plant species.
113	(19) This chapter may not be interpreted to override, supersede, or modify any water right
114	within the state, or the role and authority of the state engineer.
115	Section 2. Effective Date.
116	This bill takes effect:
