LONG TITLE

This bill modifies provisions relating to the Utah Supreme Court.

Highlighted Provisions:

General Description:

This bill:

- modifies provisions governing the membership and internal management of the Utah
- 9 Supreme Court;
- 10 provides that the governor shall appoint a chief justice of the Utah Supreme Court (chief justice) when a vacancy in the office occurs; 11
- 12 requires that a governor's selection for chief justice is subject to the advice and consent of the Senate; 13
 - modifies the term of office for chief justice;
 - modifies provisions related to an interim chief justice and appointment procedures; and
 - makes technical and conforming changes.

Section 3. Revisor instructions.

preparing the Utah Code database for publication, replace the phrase "the effective date of this
bill" with the actual effective date of the bill.
