**LONG TITLE**

**General Description:**

This bill creates a minimum credit hour requirement rather than a day or instructional hour requirement for certain grades in the public education system.

*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **53F-2-102** is amended to read:

**53F-2-102 . Definitions.**

As used in this chapter:

(1) "Attendance-validated program" means an educational program where:

- (a) student participation is measured by physical or virtual attendance at scheduled instructional periods; and

29 (b) a student receives direct teacher interaction and instruction for the course or program  
 30 the student is enrolled in.

31 ~~[(1)]~~ (2) "Basic state-supported school program," "basic program," or "basic school  
 32 program" means public education programs for kindergarten, elementary, and secondary  
 33 school students that are operated and maintained for the amount derived by multiplying  
 34 the number of weighted pupil units for each school district or charter school by the value  
 35 established each year in the enacted public education budget, except as otherwise  
 36 provided in this chapter.

37 ~~[(2)]~~ (3) "LEA governing board" means a local school board or charter school governing  
 38 board.

39 ~~[(3)]~~ (4) "Pupil in average daily membership" or "ADM" means a full-day equivalent pupil.

40 ~~[(4)]~~ (5)(a) "Minimum School Program" means the state-supported public school  
 41 programs for kindergarten, elementary, and secondary schools as described in this  
 42 Subsection ~~[(4)]~~ (5).

43 (b) The Minimum School Program established in school districts and charter schools  
 44 shall include the equivalent of a school term of nine months as determined by the  
 45 state board.

46 (c)(i) The state board shall establish[-] :

47 (A) except as provided in Subsection (5)(c)(i)(B), the number of days or  
 48 equivalent instructional hours that school is held for an academic school year[-] ,  
 49 allowing flexibility for elementary, middle, and junior high schools to adapt  
 50 schedules to align with high schools described in Subsection (5)(c)(i)(B); and  
 51 (B) for grades 9 through 12 that use an attendance-validated program, the number  
 52 of credits required to graduate high school based on one credit representing at  
 53 least 83 class hours, in lieu of a requirement of days or instructional hours.

54 (ii) Education, enhanced by utilization of technologically enriched delivery systems,  
 55 when approved by an LEA governing board, shall receive full support by the state  
 56 board as it pertains to fulfilling the attendance requirements, excluding time spent  
 57 viewing commercial advertising.

58 (d)(i) An LEA governing board may reallocate up to 32 instructional hours or four  
 59 school days established under Subsection ~~[(4)(e)]~~ (5)(c) for teacher preparation  
 60 time or teacher professional development.

61 (ii) A reallocation of instructional hours or school days under Subsection ~~[(4)(d)(i)]~~

- 64 (A) at which a quorum of the LEA governing board is present; and

- 77 (e) The Minimum School Program includes a program or allocation funded by a line

- 80 (ii) Related to Basic Programs;
- 81 (iii) Voted and Board Levy Programs; or
- 82 (iv) Minimum School Program.
- 83 [~~(5)~~] (6) "Weighted pupil unit[~~-or units~~] " or "WPU[~~-or WPUs~~]" means the unit of measure of
- 84 factors that is computed in accordance with this chapter for the purpose of determining
- 85 the costs of a program on a uniform basis for each school district or charter school.
- 86 Section 2. Section **53G-6-705** is amended to read:
- 87 **53G-6-705 . Online students' participation in extracurricular activities.**
- 88 (1) As used in this section:
- 89 (a) "Association" means the same as that term is defined in Section 53G-7-1101.
- 90 (b) "Extracurricular activity" means the same as that term is defined in Section
- 91 53G-7-501.
- 92 (c) "Initial establishment of eligibility requirements" means the same as that term is
- 93 defined in Section 53G-6-703.
- 94 (d) "Online education" means the use of information and communication technologies to
- 95 deliver educational opportunities to a student in a location other than a school.
- 96 (e) "Online student" means a student who:

- 97 (i) participates in an online education program sponsored or supported by the state  
98 board, a school district, or a charter school; and
- 99 (ii) generates funding for the school district or the school [~~pursuant to~~] in accordance  
100 with Subsection [53F-2-102(4)] 53F-2-102(5) and rules of the state board.
- 101 (2) An online student is eligible to participate in an extracurricular activity at:
- 102 (a) the school with attendance boundaries within which the student's custodial parent  
103 resides, if, for an interscholastic competition of athletic teams, the student did not  
104 initially establish the student's eligibility at another public school in grade 9 or 10; or
- 105 (b) the public school from which the student withdrew for the purpose of participating in  
106 an online education program.
- 107 (3) A public school other than a school described in Subsection (2) may allow an online  
108 student to participate in an extracurricular activity that the public school sponsors and  
109 supports if:
- 110 (a) for interschool competitions of athletic teams sponsored and supported by a public  
111 school, the online school student meets the initial establishment of eligibility  
112 requirements;
- 113 (b) for interschool contests or competitions for music, drama, or forensic groups or  
114 teams sponsored and supported by a public school, the online school student meets  
115 the entry requirements for participation;
- 116 (c) the online school student meets the eligibility requirements under this section; and
- 117 (d) the online school student meets the enrollment requirements for public school in  
118 accordance with Part 4, School District Enrollment.
- 119 (4) An online student is eligible to participate in an extracurricular activity at a public  
120 school consistent with eligibility standards as applied to full-time students of the public  
121 school.
- 122 (5) A school district or public school may not impose additional requirements on an online  
123 school student to participate in an extracurricular activity that are not imposed on  
124 full-time students of the public school.
- 125 (6)(a) The state board shall make rules establishing fees for an online school student's  
126 participation in an extracurricular activity at school district schools.
- 127 (b) The rules shall provide that:
- 128 (i) online school students pay the same fees as other students to participate in an  
129 extracurricular activity;
- 130 (ii) online school students are eligible for fee waivers pursuant to Section 53G-7-504;

131 (iii) for each online school student who participates in an extracurricular activity at a  
132 school district school, the online school shall pay a share of the school district's  
133 costs for the extracurricular activity; and

134 (iv) an online school's share of the costs of an extracurricular activity shall reflect  
135 state and local tax revenues expended, except capital facilities expenditures, for an  
136 extracurricular activity in a school district or school divided by total student  
137 enrollment of the school district or school.

138 (c) In determining an online school's share of the costs of an extracurricular activity  
139 under Subsections (6)(b)(iii) and (iv), the state board may establish uniform fees  
140 statewide based on average costs statewide or average costs within a sample of  
141 school districts.

142 (7) When selection to participate in an extracurricular activity at a public school is made on  
143 a competitive basis, an online student is eligible to try out for and participate in the  
144 activity as provided in this section.
