59 Section 1. Section **4-2-108** is amended to read:

60 **4-2-108 (Effective 05/06/26) (Repealed 07/01/28). Agricultural Advisory Board**  
61 **created -- Composition -- Responsibility -- Terms of office -- Compensation -- Executive**

62 **committee.**

63 (1) There is created the Agricultural Advisory Board composed of the following 21  
64 members:

65 (a) the dean of the [~~College of Agriculture and Applied Science from Utah State~~  
66 ~~University]~~ S.J. and Jessie E. Quinney College of Agriculture and Natural Resources  
67 at Utah State University; and

68 (b) the following appointed by the commissioner:

69 (i) two representatives of associations representing interests of farmers, selected from  
70 a list of nominees submitted by at least two associations representing farmers;

71 (ii) [a] one representative of an association representing cattlemen, selected from a list  
72 of nominees submitted by at least one association representing cattlemen;

73 (iii) one representative of an association representing wool growers, selected from a  
74 list of nominees submitted by at least one association representing wool growers;

75 (iv) one representative of an association representing dairies, selected from a list of  
76 nominees submitted by at least one association representing dairies;

77 (v) one representative of an association representing pork producers, selected from a  
78 list of nominees submitted by at least one association representing pork producers;

79 (vi) one representative of egg and poultry producers;

80 (vii) one representative of an association representing veterinarians, selected from a  
81 list of nominees submitted by at least one association representing veterinarians;

82 (viii) one representative of an association representing livestock auctions, selected  
83 from a list of nominees submitted by at least one association representing  
84 livestock auctions;

85 (ix) one representative of an association representing conservation districts, selected  
86 from a list of nominees submitted by at least one association representing  
87 conservation districts;

88 (x) one representative of the Utah horse industry;

89 (xi) one representative of the food processing industry;

90 (xii) one representative of the fruit and vegetable industry;

91 (xiii) one representative of the turkey industry;

92 (xiv) one representative of manufacturers of food supplements;

93 (xv) one representative of a consumer affairs group;

94 (xvi) one representative of urban and small farmers;

95 (xvii) one representative of an association representing elk breeders, selected from a

- 96 list of nominees submitted by at least one association representing elk breeders;  
97 (xviii) one representative of an association representing beekeepers, selected from a  
98 list of nominees submitted by at least one association representing beekeepers; and  
99 (xix) one representative of fur breeders, selected from a list of nominees submitted by  
100 at least one association representing fur breeders.
- 101 (2) The Agricultural Advisory Board shall:
- 102 (a) advise the commissioner regarding:
- 103 (i) the planning, implementation, and administration of the department's programs;  
104 and  
105 (ii) the establishment of standards governing the care of livestock and poultry,  
106 including consideration of:
- 107 (A) food safety;  
108 (B) local availability and affordability of food; and  
109 (C) acceptable practices for livestock and farm management; and
- 110 (b) adopt best management practices for sheep, swine, cattle, and poultry industries in  
111 the state.
- 112 (3) The Agricultural Advisory Board may adopt best management practices for  
113 domesticated elk, mink, apiaries, and other agricultural industries in the state.
- 114 (4) For purposes of this section, "best management practices" means practices used by  
115 agriculture in the production of food and fiber that are commonly accepted practices, or  
116 that are at least as effective as commonly accepted practices, and that:
- 117 (a) protect the environment;  
118 (b) protect human health; and  
119 (c) promote the financial viability of agricultural production.
- 120 (5)(a) Except as required by Subsection (1)(a) or (5)(b), members of the Agricultural  
121 Advisory Board are appointed by the commissioner to four-year terms of office.
- 122 (b) Notwithstanding the requirements of Subsection (5)(a), the commissioner shall, at  
123 the time of appointment or reappointment, adjust the length of terms to ensure that  
124 the terms of board members are staggered so that approximately half of the board is  
125 appointed every two years.
- 126 (c) A member may be removed at the discretion of the commissioner upon the request of  
127 the group the member represents.
- 128 (d) When a vacancy occurs in the membership for any reason, the commissioner shall  
129 appoint a replacement for the unexpired term.

- 130 (6) The Agricultural Advisory Board shall elect one member to serve as chair of the  
131 Agricultural Advisory Board for a term of one year.
- 132 (7)(a) The Agricultural Advisory Board shall meet twice a year, but may meet more  
133 often at the discretion of the chair.
- 134 (b) Attendance of 11 members at a duly called meeting of the Agricultural Advisory  
135 Board constitutes a quorum for the transaction of official business.
- 136 (8) A member of the Agricultural Advisory Board may not receive compensation or  
137 benefits for the member's service, but may receive per diem and travel expenses in  
138 accordance with:
- 139 (a) Section 63A-3-106;  
140 (b) Section 63A-3-107; and  
141 (c) rules made by the Division of Finance pursuant to Sections 63A-3-106 and  
142 63A-3-107.
- 143 (9)(a) There is created an executive committee of the Agricultural Advisory Board  
144 consisting of the following seven members selected from members of the  
145 Agricultural Advisory Board:
- 146 (i) the two representatives appointed under Subsection (1)(b)(i);  
147 (ii) the representative appointed under Subsection (1)(b)(ix); and  
148 (iii) four members selected from the Agricultural Advisory Board as follows:
- 149 (A) for the initial members of the executive committee, by the commissioner; and  
150 (B) after the initial members of the executive committee are selected, by the  
151 executive committee.
- 152 (b)(i) A member of the executive committee shall serve a term of four years on the  
153 executive committee.
- 154 (ii) A member of the executive committee may serve for more than one term on the  
155 executive committee.
- 156 (iii) When a vacancy occurs in the membership of the executive committee for any  
157 reason, the replacement shall be selected in the same manner as under Subsection

 170 **Equipment Fund.**

- 171 (1) There is created an expendable special revenue fund known as the ["Department of  
 172 Agriculture and Food Laboratory Equipment Fund,[" which is referred to in this section  
 173 as the "fund."
- 174 (2) The fund consists of:
- 175 (a) collections the Division of Laboratories within the department receives under this  
 176 title that are not expended during the previous fiscal year;
- 177 (b) appropriations from the Legislature; and
- 178 (c) interest and earnings on the fund.
- 179 (3) The state treasurer shall invest the money in the fund according to Title 51, Chapter 7,  
 180 State Money Management Act, except that interest or other earnings derived from those  
 181 investments shall be deposited into the fund.
- 182 (4)~~(a)~~ The department may use money in the fund only to pay for the repair,  
 183 replacement, or upgrade of laboratory equipment in accordance with this section.
- 184 (5) The state chemist or the commissioner shall approve expenditures from the fund for  
 185 laboratory equipment repair, replacement, or upgrade as follows:
- 186 (a) the state chemist may approve using money in the fund to repair, replace, or upgrade  
 187 laboratory equipment if the amount to be expended is less than \$10,000; and
- 188 (b) the state chemist shall obtain the approval of the commissioner for using money in  
 189 the fund to repair, replace, or upgrade laboratory equipment if the amount to be  
 190 expended equals or exceeds \$10,000.
- 191 (6)(a) Subject to the other provisions of this Subsection (6), the Division of Finance  
 192 shall deposit into the fund the collections that the Division of Laboratories receives  
 193 under this title that are not expended during a fiscal year.
- 194 (b) The fund may not exceed \$500,000 at the end of a fiscal year.
- 195 (c) If the fund exceeds \$500,000 at the end of the fiscal year, the Division of Finance  
 196 shall deposit into the General Fund the money in excess of the amount necessary to  
 197 maintain the fund balance at \$500,000.

199 **4-9-119 (Effective 05/06/26). Weights and Measures Fund.**

200 (1) There is created an expendable special revenue fund known as the Weights and  
201 Measures Fund.

202 (2) The fund consists of:

203 (a) the revenue from fees for the inspection of weights and measures that the department  
204 collects under this chapter;

205 (b) appropriations from the Legislature; and

206 (c) interest and earnings on money in the fund.

207 (3)(a) The state treasurer shall invest the money in the fund in accordance with Title 51,  
208 Chapter 7, State Money Management Act.

209 (b) The state treasurer shall deposit interest and other earnings derived from investment  
210 of expendable special revenue fund money into the fund.

211 (4) The department may use money in the fund for the maintenance, repair, and purchase of  
212 equipment used in administering the requirements of this chapter, including:

213 (a) specialized vehicles;

214 (b) cranes and lifts;

215 (c) weight carts; and

216 (d) field, metrology, and fuel laboratory equipment.

217 (5)(a) Except as provided in Subsection (5)(c), the Division of Finance shall deposit into  
218 the fund the revenue that the department receives under this chapter that the  
219 department does not expend during a fiscal year.

220 (b) The fund may not exceed \$1,000,000 at the end of a fiscal year.

221 (c) Notwithstanding Subsection (5)(a), the Division of Finance shall deposit into the

225 **4-18-106 (Effective 05/06/26). Agriculture Resource Development Fund --**

226 **Contents -- Use of fund money -- Advisory board.**

227 (1) As used in this section:

228 (a) "Disaster" means an extraordinary circumstance, including a flood, drought, or fire,  
229 that results in:

230 (i) the president of the United States declaring an emergency or major disaster in the  
231 state;

- 232 (ii) the governor declaring a state of emergency under Title 53, Chapter 2a, Part 2,  
 233 Disaster Response and Recovery Act; or
- 234 (iii) the chief executive officer of a local government declaring a local emergency  
 235 under Title 53, Chapter 2a, Part 2, Disaster Response and Recovery Act.
- 236 (b) "Fund" means the Agriculture Resource Development Fund created in this section.
- 237 (c) "Local government" means the same as that term is defined in Section 53-2a-602.
- 238 (2) There is created a revolving loan fund known as the ["Agriculture Resource  
 239 Development Fund.["]
- 240 (3) The fund shall consist of:
- 241 (a) money appropriated to the fund by the Legislature;
- 242 (b) money received for the repayment of loans made from the fund;
- 243 (c) money from a preferential user to reimburse the commission for loans made from the  
 244 fund in accordance with Title 73, Chapter 3d, Part 4, Compensation;
- 245 (d) money made available to the state for agriculture resource development or for a  
 246 temporary water shortage emergency, as defined in Section 73-3d-101, from any  
 247 source; and
- 248 (e) interest earned on the fund.
- 249 (4) The commission may make loans from the fund for:
- 250 (a) a rangeland improvement and management project;
- 251 (b) a watershed protection or flood prevention project;
- 252 (c) a soil and water conservation project;
- 253 (d) a program designed to promote energy efficient farming practices;
- 254 (e) an improvement program for agriculture product storage or program designed to  
 255 protect a crop or animal resource;
- 256 (f) a hydroponic or aquaponic system, including a hydroponic fodder production system;
- 257 (g) a project or program to improve water quality;
- 258 (h) a project to address other environmental issues;
- 259 (i) subject to Subsection (5), a disaster relief program designed to aid the sustainability  
 260 of agriculture during and immediately following a disaster; or
- 261 (j) subject to Subsection (6), authorized for temporary water shortage emergencies as  
 262 provided in Title 73, Chapter 3d, Part 4, Compensation.
- 263 (5)(a) Except as provided in Subsection (5)(b), the department shall limit loans for  
 264 disaster relief programs under Subsection (4)(i) to no more than 10% of the total  
 265 amount of:

- 266           (i) the balance of money in the fund; and
- 267           (ii) the outstanding loans issued from the fund.
- 268       ~~[(a) Loans made through a disaster relief program described in Subsection (4)(i) may not~~  
 269           ~~comprise more than 10% of the funds appropriated by the Legislature to the fund.]~~
- 270       (b) Notwithstanding Subsection (5)(a), the department may use the money appropriated  
 271           to the fund by the Legislature or another source, without limitation, if the money is  
 272           appropriated specifically for use in a disaster relief program.
- 273       (c)(i) Until December 31, 2024, the department is authorized to borrow up to  
 274           \$3,000,000 of General Fund appropriations from the Agricultural Water  
 275           Optimization Account created in Section 73-10g-204 to be used in making loans  
 276           through a disaster relief program described in Subsection (4)(i).
- 277           (ii) If the department borrows from the Agricultural Water Optimization Account  
 278           under Subsection (5)(c)(i), the department shall deposit the repayment of principal

- 295       (1) "Brand" means an identifiable mark ~~[-, including a tattoo or cutting and shaping of the~~  
 296           ~~ears or brisket area, applied to livestock]~~ applied to livestock, including a cutting and  
 297           shaping of the ears or brisket area, that is intended to show ownership and the mark's  
 298           location.
- 299       (2) "Carcass" means any part of the body of an animal, including entrails and edible meats.

- 300 (3) "Domesticated elk" means the same as that term is defined in Section 4-39-102.
- 301 (4) "Hide" means any skins or wool removed from livestock.
- 302 (5) "Livestock" means cattle, calves, horses, mules, or sheep.
- 303 (6)(a) "Livestock market" means a public market place consisting of pens or other  
 304 enclosures where cattle, calves, horses, or mules are received on consignment and  
 305 kept for subsequent sale, either through public auction or private sale.
- 306 (b) "Livestock market" does not mean:
- 307 (i) a place used solely for liquidation of livestock by a farmer, dairyman, livestock  
 308 breeder, or feeder who is going out of business; or
- 309 (ii) a place where an association of livestock breeders under the association's own  
 310 management:
- 311 (A) offers registered livestock or breeding sires for sale;
- 312 (B) assumes the responsibility for the sale;
- 313 (C) guarantees title to the livestock or sires sold; and
- 314 (D) arranges with the department for brand inspection of the animals sold.
- 315 (7) "Open range" means land upon which cattle, sheep, or other domestic animals are  
 316 grazed or permitted to roam by custom, license, lease, or permit.
- 317 (8) "Slaughterhouse" means a building, plant, or establishment where animals are  
 318 harvested, dressed, or processed and the animals' meat or meat products produced for  
 319 human consumption.
- 320 Section 6. Section **17D-3-301** is amended to read:
- 321 **17D-3-301 (Effective 05/06/26). Board of supervisors -- Number -- Term -- Chair**  
 322 **and officers -- Quorum -- Compensation.**
- 323 (1) A board of supervisors shall govern a conservation district.
- 324 (2) The board of supervisors of a conservation district consists of five members appointed  
 325 as provided in this part, at least three of whom shall be private agricultural land  
 326 operators.
- 327 (3)(a) Subject to Subsection (3)(c), the term of office of a member of a board of  
 328 supervisors is four years.
- 329 (b) Notwithstanding Subsection (3)(a), if multiple conservation districts are consolidated  
 330 or a single conservation district divided or dissolved under Part 2, Creation,  
 331 Consolidation, Division, and Dissolution of Conservation Districts:
- 332 (i) the term of each member of the board of supervisors of the consolidated  
 333 conservation districts or the divided or dissolved conservation district terminates

- 334 immediately upon consolidation, division, or dissolution; and

- 358 (1) The conservation commission may issue a grant described in Subsection 73-10g-204(3)
- 359 in accordance with the procedures in this section.
- 360 (2)(a) The committee shall establish funding application periods during which a person
- 361 may apply for a grant under this part.
- 362 (b) During a funding application period, a person may file a funding application with the
- 363 department for preliminary screening of eligibility to receive a grant under this part,
- 364 including requisite water savings.
- 365 (c) The department shall screen the funding applications for eligibility.
- 366 (d) If the department determines that an applicant meets eligibility requirements and
- 367 proposes water savings, the department shall provide the applicant preliminary

- 368 approval.
- 369 (e) After receiving preliminary approval under Subsection (2)(d), the applicant [~~shall~~  
370 may engage in a pre-filing consultation with the Division of Water Rights under  
371 Subsection 73-3-3(2) to determine whether a change application is required to  
372 accomplish the project proposed in the funding application or to quantify saved water[-].
- 373 (f) Once the Division of Water Rights determines whether the person is required to file a  
374 change application, the person may complete the funding application process and file  
375 the completed funding application with the committee.

378 receive a grant under this part for the relevant funding application period.
