33 Section 1. Section **26B-1-202** is amended to read:

34 **26B-1-202 . Department authority and duties.**

- 35 (1) As used in this section, "public funds" means the same as that term is defined in Section  
 36 26B-5-101.
- 37 (2) The department may, subject to applicable restrictions in state law and in addition to all  
 38 other authority and responsibility granted to the department by law:
- 39 (a) adopt rules, in accordance with Title 63G, Chapter 3, Utah Administrative  
 40 Rulemaking Act, and not inconsistent with law, as the department may consider  
 41 necessary or desirable for providing health and social services to the people of this  
 42 state;
  - 43 (b) establish and manage client trust accounts in the department's institutions and  
 44 community programs, at the request of the client or the client's legal guardian or  
 45 representative, or in accordance with federal law;
  - 46 (c) purchase, as authorized or required by law, services that the department is  
 47 responsible to provide for legally eligible persons;
  - 48 (d) conduct adjudicative proceedings for clients and providers in accordance with the  
 49 procedures of Title 63G, Chapter 4, Administrative Procedures Act;
  - 50 (e) establish eligibility standards for the department's programs, not inconsistent with  
 51 state or federal law or regulations;
  - 52 (f) take necessary steps, including legal action, to recover money or the monetary value  
 53 of services provided to a recipient who was not eligible;
  - 54 (g) set and collect fees for the department's services;
  - 55 (h) license agencies, facilities, and programs, except as otherwise allowed, prohibited, or  
 56 limited by law;
  - 57 (i) acquire, manage, and dispose of any real or personal property needed or owned by  
 58 the department, not inconsistent with state law;
  - 59 (j) receive gifts, grants, devises, and donations; gifts, grants, devises, donations, or the  
 60 proceeds thereof, may be credited to the program designated by the donor, and may  
 61 be used for the purposes requested by the donor, as long as the request conforms to

- 62 state and federal policy; all donated funds shall be considered private, nonlapsing  
63 funds and may be invested under guidelines established by the state treasurer;
- 64 (k) accept and employ volunteer labor or services; the department is authorized to  
65 reimburse volunteers for necessary expenses, when the department considers that  
66 reimbursement to be appropriate;
- 67 (l) carry out the responsibility assigned in the workforce services plan by the State  
68 Workforce Development Board;
- 69 (m) carry out the responsibility assigned by Section 26B-1-430 with respect to  
70 coordination of services for students with a disability;
- 71 (n) provide training and educational opportunities for the department's staff;
- 72 (o) collect child support payments and any other money due to the department;
- 73 (p) apply the provisions of Title 81, Chapter 6, Child Support, and Title 81, Chapter 7,  
74 Payment and Enforcement of Spousal and Child Support, to parents whose child lives  
75 out of the home in a department licensed or certified setting;
- 76 (q) establish policy and procedures, within appropriations authorized by the Legislature,  
77 in cases where the Division of Child and Family Services or the Division of Juvenile  
78 Justice and Youth Services is given custody of a minor by the juvenile court under  
79 Title 80, Utah Juvenile Code, or the department is ordered to prepare an attainment  
80 plan for a minor found not competent to proceed under Section 80-6-403, including:
- 81 (i) designation of interagency teams for each juvenile court district in the state;  
82 (ii) delineation of assessment criteria and procedures;  
83 (iii) minimum requirements, and timeframes, for the development and  
84 implementation of a collaborative service plan for each minor placed in  
85 department custody; and
- 86 (iv) provisions for submittal of the plan and periodic progress reports to the court;
- 87 (r) carry out the responsibilities assigned to the department by statute;
- 88 (s) as further provided in Subsection (3), examine and audit the expenditures of any  
89 public funds provided to a local health department, a local substance abuse authority,  
90 a local mental health authority, a local area agency on aging, and any person, agency,  
91 or organization that contracts with or receives funds from those authorities or  
92 agencies;
- 93 (t) in accordance with Subsection [~~26B-2-104(1)(d)~~] 26B-2-902(1)(d), accredit one or  
94 more agencies and persons to provide intercountry adoption services;
- 95 (u) within legislative appropriations, promote and develop a system of care and

- 96 stabilization services:
- 97 (i) in compliance with Title 63G, Chapter 6a, Utah Procurement Code; and
- 98 (ii) that encompasses the department, department contractors, and the divisions,
- 99 offices, or institutions within the department, to:
- 100 (A) navigate services, funding resources, and relationships to the benefit of the
- 101 children and families whom the department serves;
- 102 (B) centralize department operations, including procurement and contracting;
- 103 (C) develop policies that govern business operations and that facilitate a system of
- 104 care approach to service delivery;
- 105 (D) allocate resources that may be used for the children and families served by the
- 106 department or the divisions, offices, or institutions within the department,
- 107 subject to the restrictions in Section 63J-1-206;
- 108 (E) create performance-based measures for the provision of services; and
- 109 (F) centralize other business operations, including data matching and sharing
- 110 among the department's divisions, offices, and institutions;
- 111 (v) ensure that any training or certification required of a public official or public
- 112 employee, as those terms are defined in Section 63G-22-102, complies with Title
- 113 63G, Chapter 22, State Training and Certification Requirements, if the training or
- 114 certification is required:
- 115 (i) under this title;
- 116 (ii) by the department; or
- 117 (iii) by an agency or division within the department;
- 118 (w) enter into cooperative agreements with the Department of Environmental Quality to
- 119 delineate specific responsibilities to assure that assessment and management of risk
- 120 to human health from the environment are properly administered;
- 121 (x) consult with the Department of Environmental Quality and enter into cooperative
- 122 agreements, as needed, to ensure efficient use of resources and effective response to
- 123 potential health and safety threats from the environment, and to prevent gaps in
- 124 protection from potential risks from the environment to specific individuals or
- 125 population groups;
- 126 (y) to the extent authorized under state law or required by federal law, promote and
- 127 protect the health and wellness of the people within the state;
- 128 (z) establish, maintain, and enforce rules authorized under state law or required by
- 129 federal law to promote and protect the public health or to prevent disease and illness;

- 130 (aa) investigate the causes of epidemic, infectious, communicable, and other diseases  
131 affecting the public health;
- 132 (bb) provide for the detection and reporting of communicable, infectious, acute, chronic,  
133 or any other disease or health hazard which the department considers to be  
134 dangerous, important, or likely to affect the public health;
- 135 (cc) collect and report information on causes of injury, sickness, death, and disability  
136 and the risk factors that contribute to the causes of injury, sickness, death, and  
137 disability within the state;
- 138 (dd) collect, prepare, publish, and disseminate information to inform the public  
139 concerning the health and wellness of the population, specific hazards, and risks that  
140 may affect the health and wellness of the population and specific activities which  
141 may promote and protect the health and wellness of the population;
- 142 (ee) abate nuisances when necessary to eliminate sources of filth and infectious and  
143 communicable diseases affecting the public health;
- 144 (ff) make necessary sanitary and health investigations and inspections in cooperation  
145 with local health departments as to any matters affecting the public health;
- 146 (gg) establish laboratory services necessary to support public health programs and  
147 medical services in the state;
- 148 (hh) establish and enforce standards for laboratory services which are provided by any  
149 laboratory in the state when the purpose of the services is to protect the public health;
- 150 (ii) cooperate with the Labor Commission to conduct studies of occupational health  
151 hazards and occupational diseases arising in and out of employment in industry, and  
152 make recommendations for elimination or reduction of the hazards;
- 153 (jj) cooperate with the local health departments, the Department of Corrections, the  
154 Administrative Office of the Courts, the Division of Juvenile Justice and Youth  
155 Services, and the Utah Office for Victims of Crime to conduct testing for HIV  
156 infection of alleged sexual offenders, convicted sexual offenders, and any victims of  
157 a sexual offense;
- 158 (kk) investigate the causes of maternal and infant mortality;
- 159 (ll) establish, maintain, and enforce a procedure requiring the blood of adult pedestrians  
160 and drivers of motor vehicles killed in highway accidents be examined for the  
161 presence and concentration of alcohol, and provide the Commissioner of Public  
162 Safety with monthly statistics reflecting the results of these examinations, with  
163 necessary safeguards so that information derived from the examinations is not used

- 164 for a purpose other than the compilation of these statistics;
- 165 (mm) establish a uniform public health program throughout the state which includes
- 166 continuous service, employment of qualified employees, and a basic program of
- 167 disease control, vital and health statistics, sanitation, public health nursing, and other
- 168 preventive health programs necessary or desirable for the protection of public health;
- 169 (nn) conduct health planning for the state;
- 170 (oo) monitor the costs of health care in the state and foster price competition in the
- 171 health care delivery system;
- 172 (pp) establish methods or measures for health care providers, public health entities, and
- 173 health care insurers to coordinate among themselves to verify the identity of the
- 174 individuals the providers serve;
- 175 (qq) designate Alzheimer's disease and related dementia as a public health issue and,
- 176 within budgetary limitations, implement a state plan for Alzheimer's disease and
- 177 related dementia by incorporating the plan into the department's strategic planning
- 178 and budgetary process;
- 179 (rr) coordinate with other state agencies and other organizations to implement the state
- 180 plan for Alzheimer's disease and related dementia;
- 181 (ss) ensure that any training or certification required of a public official or public
- 182 employee, as those terms are defined in Section 63G-22-102, complies with Title
- 183 63G, Chapter 22, State Training and Certification Requirements, if the training or
- 184 certification is required by the agency or under this Title 26B, Utah Health and
- 185 Human Services Code;
- 186 (tt) oversee public education vision screening as described in Section 53G-9-404;
- 187 (uu) issue code blue alerts in accordance with Title 35A, Chapter 16, Part 7, Code Blue
- 188 Alert; and
- 189 (vv) as allowed by state and federal law, share data with the Office of Families that is
- 190 relevant to the duties described in Subsection 26B-1-243(4), which may include, to
- 191 the extent available:
- 192 (i) demographic data concerning family structures in the state; and
- 193 (ii) data regarding the family structure associated with:
- 194 (A) suicide, depression, or anxiety; and
- 195 (B) various health outcomes.
- 196 (3)(a) Under Subsection (2)(s), those local departments, local authorities, area agencies,
- 197 and any person or entity that contracts with or receives funds from those departments,

198 authorities, or area agencies, shall provide the department with any information the  
199 department considers necessary.

200 (b) The department is further authorized to issue directives resulting from any  
201 examination or audit to a local department, local authority, an area agency, and  
202 persons or entities that contract with or receive funds from those departments,  
203 authorities, or agencies with regard to any public funds.

204 (c) If the department determines that it is necessary to withhold funds from a local health  
205 department, local mental health authority, or local substance abuse authority based on  
206 failure to comply with state or federal law, policy, or contract provisions, the  
207 department may take steps necessary to ensure continuity of services.

208 Section 2. Section **26B-2-101** is amended to read:

209 **26B-2-101 . Definitions.**

210 As used in this part:

211 (1) "Abuse" means the same as that term is defined in Section 80-1-102.

212 (2) "Adoption services" means the same as that term is defined in Section 80-2-801.

213 (3) "Adult day care" means nonresidential care and supervision:

214 (a) for three or more adults for at least four but less than 24 hours a day; and

215 (b) that meets the needs of functionally impaired adults through a comprehensive  
216 program that provides a variety of health, social, recreational, and related support  
217 services in a protective setting.

218 (4) "Applicant" means a person that applies for an initial license or a license renewal under  
219 this part.

220 (5)~~(a) "Associated with the licensee" means that an individual is:]~~

221 ~~[(i) affiliated with a licensee as an owner, director, member of the governing body,~~  
222 ~~employee, agent, provider of care, department contractor, or volunteer; or]~~

223 ~~[(ii) applying to become affiliated with a licensee in a capacity described in~~  
224 ~~Subsection (5)(a)(i).]~~

225 ~~[(b)]~~ (a) "Associated with the licensee" means an individual who, regardless of title,  
226 holds or held a position of management, control, or significant influence over the  
227 licensee's operations or compliance as demonstrated by being:

228 (i) an owner, partner, corporate officer, director, or member of the governing body;

229 (ii) a managerial or supervisory employee with responsibility for the licensee's daily  
230 operations or compliance with governing rules;

231 (iii) an individual who exercises significant control over the management, policies, or

- 232 operations of the licensee, whether through financial interest, contract, familial  
233 relationship, or other formal arrangement; or
- 234 (iv) an individual applying to be in a capacity described in this Subsection (5)(a).
- 235 (b) "Associated with the licensee" does not include:
- 236 (i) service on the following bodies, unless that service includes direct access to a  
237 child or a vulnerable adult:
- 238 (A) a local mental health authority described in Section 17-77-301;  
239 (B) a local substance abuse authority described in Section 17-77-201; or  
240 (C) a board of an organization operating under a contract to provide mental health  
241 or substance use programs, or services for the local mental health authority or  
242 substance abuse authority; or
- 243 (ii) a guest or visitor whose access to a child or a vulnerable adult is directly  
244 supervised at all times.
- 245 (6) "Behavioral health receiving center" means a 23-hour non-secure program or facility  
246 that is responsible for, and provides mental health crisis services to, an individual  
247 experiencing a mental health crisis.
- 248 (7)(a) "Boarding school" means a private school that:
- 249 (i) uses a regionally accredited education program;
- 250 (ii) provides a residence to the school's students:
- 251 (A) for the purpose of enabling the school's students to attend classes at the  
252 school; and
- 253 (B) as an ancillary service to educating the students at the school;
- 254 (iii) has the primary purpose of providing the school's students with an education, as  
255 defined in Subsection (7)(b)(i); and
- 256 (iv)(A) does not provide the treatment or services described in Subsection (49)(a);  
257 or
- 258 (B) provides the treatment or services described in Subsection (49)(a) on a limited  
259 basis, as described in Subsection (7)(b)(ii).
- 260 (b)(i) For purposes of Subsection (7)(a)(iii), "education" means a course of study for  
261 one or more grades from kindergarten through grade 12.
- 262 (ii) For purposes of Subsection (7)(a)(iv)(B), a private school provides the treatment  
263 or services described in Subsection (49)(a) on a limited basis if:
- 264 (A) the treatment or services described in Subsection (49)(a) are provided only as  
265 an incidental service to a student; and

- 266 (B) the school does not:
- 267 (I) specifically solicit a student for the purpose of providing the treatment or
- 268 services described in Subsection (49)(a); or
- 269 (II) have a primary purpose of providing the treatment or services described in
- 270 Subsection (49)(a).
- 271 (c) "Boarding school" does not include a therapeutic school.
- 272 (8) "Certification" means a less restrictive level of licensure issued by the department.
- 273 (9) "Child" means an individual under 18 years old.
- 274 (10) "Child placing" means receiving, accepting, or providing custody or care for any child,
- 275 temporarily or permanently, for the purpose of:
- 276 (a) finding a person to adopt the child;
- 277 (b) placing the child in a home for adoption; or
- 278 (c) foster home placement.
- 279 (11) "Child-placing agency" means a person that engages in child placing.
- 280 (12) "Client" means an individual who receives or has received services from a licensee.
- 281 (13)(a) "Congregate care program" means any of the following that provide services to a
- 282 child:
- 283 (i) an outdoor youth program;
- 284 (ii) a residential support program;
- 285 (iii) a residential treatment program; or
- 286 (iv) a therapeutic school.
- 287 (b) "Congregate care program" does not include a human services program that:
- 288 (i) is licensed to serve adults; and
- 289 (ii) is approved by the office to service a child for a limited time.
- 290 (14)(a) "Day treatment" means specialized treatment that is provided to:
- 291 ~~[(a)]~~ (i) a client less than 24 hours a day; and
- 292 ~~[(b)]~~ (ii) four or more persons who are receiving services individually or in a group
- 293 setting during any 30-day period and who:
- 294 ~~[(i)]~~ (A) are unrelated to the owner or provider; and
- 295 ~~[(ii)]~~ (B) have emotional, psychological, developmental, physical, or behavioral
- 296 dysfunctions, impairments, or chemical dependencies.
- 297 (b) A person providing Applied Behavior Analysis to clients as described in Subsection
- 298 (14)(a) is presumed to be providing day treatment unless the person is able to
- 299 demonstrate to the office that the services meet the definition of outpatient treatment

- 300            described in Subsection (42).
- 301        (15) "Department contractor" means an individual who:
- 302            (a) provides services under a contract with the department; and
- 303            (b) due to the contract with the department, has or will likely have direct access to a
- 304            child or vulnerable adult.
- 305        (16) "Direct access" means that an individual has, or likely will have:
- 306            (a) contact with or access to a child or vulnerable adult that provides the individual with
- 307            an opportunity for personal communication or touch; or
- 308            (b) an opportunity to view medical, financial, or other confidential personal identifying
- 309            information of the child, the child's parents or legal guardians, or the vulnerable adult.
- 310        (17) "Directly supervised" means that an individual is being supervised under the
- 311            uninterrupted visual and auditory surveillance of another individual who has a current
- 312            background check approval issued by the office.
- 313        (18) "Director" means the director of the office.
- 314        (19) "Division" means the Division of Licensing and Background Checks created under
- 315            Section [~~26B-2-103~~] 26B-2-901.
- 316        (20) "Domestic violence" means the same as that term is defined in Section 77-36-1.
- 317        (21) "Domestic violence treatment program" means a nonresidential program designed to
- 318            provide psychological treatment and educational services to perpetrators and victims of
- 319            domestic violence.
- 320        (22) "Elder adult" means a person 65 years old or older.
- 321        (23) "Emergency safety intervention" means a tactic used to protect staff or a client from
- 322            being physically injured, utilized by an appropriately trained direct care staff and only
- 323            performed in accordance with a nationally or regionally recognized curriculum in the
- 324            least restrictive manner to restore staff or client safety.
- 325        (24) "Foster home" means a residence that is licensed or certified by the office for the
- 326            full-time substitute care of a child.
- 327        (25) "Harm" means the same as that term is defined in Section 80-1-102.
- 328        (26) "Health benefit plan" means the same as that term is defined in Section 31A-1-301.
- 329        (27) "Health care provider" means the same as that term is defined in Section 78B-3-403.
- 330        (28) "Health insurer" means:
- 331            (a) an insurer who offers health care insurance as that term is defined in Section
- 332            31A-1-301;
- 333            (b) health benefits offered to state employees under Section 49-20-202; and

- 334 (c) a workers' compensation insurer:
- 335 (i) authorized to provide workers' compensation insurance in the state; or
- 336 (ii) that is a self-insured employer as defined in Section 34A-2-201.5.
- 337 (29)(a) "Human services program" means:
- 338 (i) a foster home;
- 339 (ii) a therapeutic school;
- 340 (iii) a youth program;
- 341 (iv) an outdoor youth program;
- 342 (v) a residential treatment program;
- 343 (vi) a residential support program;
- 344 (vii) a resource family home;
- 345 (viii) a recovery residence;
- 346 (ix) a behavioral health receiving center; or
- 347 (x) a facility or program that provides:
- 348 (A) adult day care;
- 349 (B) day treatment;
- 350 (C) outpatient treatment;
- 351 (D) domestic violence treatment;
- 352 (E) child-placing services;
- 353 (F) social detoxification; or
- 354 (G) any other human services that are required by contract with the department to
- 355 be licensed with the department.
- 356 (b) "Human services program" does not include:
- 357 (i) a boarding school;
- 358 (ii) a residential vocational or life skills program, as defined in Section 13-53-102; or
- 359 (iii) a short-term relief care provider.
- 360 (30) "Indian child" means the same as that term is defined in 25 U.S.C. Sec. 1903.
- 361 (31) "Indian country" means the same as that term is defined in 18 U.S.C. Sec. 1151.
- 362 (32) "Indian tribe" means the same as that term is defined in 25 U.S.C. Sec. 1903.
- 363 (33) "Intermediate secure treatment" means 24-hour specialized residential treatment or
- 364 care for an individual who:
- 365 (a) cannot live independently or in a less restrictive environment; and
- 366 (b) requires, without the individual's consent or control, the use of locked doors to care
- 367 for the individual.

- 368 (34) "Licensee" means an individual or a human services program licensed by the office.  
369 (35) "Local government" means a city, town, or county.  
370 (36) "Mental health treatment program" means a program that:  
371 (a) is a structured intervention; and  
372 (b) is used to improve mental health, prevent mental disorders, and treat mental health  
373 conditions.  
374 (37) "Medication assisted treatment" means the use of a prescribed medication approved by  
375 the United States Food and Drug Administration, such as buprenorphine, methadone, or  
376 naltrexone, to treat substance use withdrawal symptoms or a substance use disorder.  
377 (38) "Minor" means child.  
378 (39) "Office" means, except as provided in Section 26B-2-120, the Office of Licensing  
379 within the department.  
380 (40) "Ombudsman" means the congregate care ombudsman created in Section 26B-2-124.2.  
381 (41) "Outdoor youth program" means a program that provides:  
382 (a) services to a child who has:  
383 (i) a chemical dependency; or  
384 (ii) a dysfunction or impairment that is emotional, psychological, developmental,  
385 physical, or behavioral;  
386 (b) a 24-hour outdoor group living environment; and  
387 (c)(i) regular therapy, including group, individual, or supportive family therapy; or  
388 (ii) informal therapy or similar services, including wilderness therapy, adventure  
389 therapy, or outdoor behavioral healthcare.  
390 (42) "Outpatient treatment" means individual, family, or group therapy or counseling  
391 designed to improve and enhance social or psychological functioning for those whose  
392 physical and emotional status allows them to continue functioning in their usual living  
393 environment.  
394 (43) "Practice group" or "group practice" means two or more health care providers legally  
395 organized as a partnership, professional corporation, or similar association, for which:  
396 (a) substantially all of the services of the health care providers who are members of the  
397 group are provided through the group and are billed in the name of the group and  
398 amounts received are treated as receipts of the group; and  
399 (b) the overhead expenses of and the income from the practice are distributed in  
400 accordance with methods previously determined by members of the group.  
401 (44) "Private-placement child" means a child whose parent or guardian enters into a

- 402 contract with a congregate care program for the child to receive services.
- 403 (45) "Qualifying residential treatment program" means a residential treatment program that  
404 is licensed under this part and:
- 405 (a) is operated as a nonprofit corporation or foreign nonprofit corporation, as those terms  
406 are defined in Section 16-6a-102; or
- 407 (b) receives any local, state, or federal government funding, government grant money, or  
408 any other form of government assistance to operate or provide services or training in  
409 the ordinary course of business.
- 410 (46) "Qualifying recovery residence" means a recovery residence that is licensed under this  
411 part and:
- 412 (a) is operated as a nonprofit corporation or foreign nonprofit corporation, as those terms  
413 are defined in Section 16-6a-102; or
- 414 (b) receives any local, state, or federal government funding, government grant money, or  
415 any other form of government assistance to operate or provide services or training in  
416 the ordinary course of business.
- 417 (47)(a) "Recovery residence" means a home, residence, or facility that meets at least two  
418 of the following requirements:
- 419 (i) provides a supervised living environment for individuals recovering from a  
420 substance use disorder;
- 421 (ii) provides a living environment in which more than half of the individuals in the  
422 residence are recovering from a substance use disorder;
- 423 (iii) provides or arranges for residents to receive services related to the resident's

- 870 (g) the number of different child welfare caseworkers who have been assigned to the

- 872 (4) For child protective services cases, the Management Information System shall:
- 873 (a) monitor the compliance of each case with:
- 874 (i) division rule;
- 875 (ii) state law; and
- 876 (iii) federal law and regulation; and
- 877 (b) include the age and date of birth of the alleged perpetrator at the time the abuse or

- 878 neglect is alleged to have occurred, in order to ensure accuracy regarding the  
879 identification of the alleged perpetrator.
- 880 (5) Information or a record contained in the Management Information System is:
- 881 (a) a private, controlled, or protected record under Title 63G, Chapter 2, Government  
882 Records Access and Management Act; and

903 to have limited access to the Management Information System.

905 person who is currently receiving services from the specific contract provider or
