LONG TITLE

General Description:

This bill addresses provisions related to correctional facilities.

Highlighted Provisions:

This bill:

- amends provisions related to direct supervision;
- amends the criminal offense of unlawful operation of an unmanned aircraft near a correctional facility by prohibiting an individual from removing any item from inside the property of a correctional facility;
- removes unpaid probation and parole supervision fees from an offender's criminal accounts receivable and requires the Department of Corrections to turn any unpaid supervision fees to the Office of State Debt Collection; and
- makes technical and conforming changes.

33 Section 1. Section **64-13-1** is amended to read:

34 **64-13-1 . Definitions.**

35 As used in this chapter:

- 36 (1) "Behavioral health transition facility" means a nonsecure correctional facility operated
 37 by the department for the purpose of providing a therapeutic environment for offenders
 38 receiving mental health services.
- 39 (2) "Case action plan" means a document developed by the Department of Corrections that
 40 identifies:
- 41 (a) the program priorities for the treatment of the offender, including the criminal risk
 42 factors as determined by risk, needs, and responsivity assessments conducted by the
 43 department; and
- 44 (b) clearly defined completion requirements.
- 45 (3) "Community correctional center" means a nonsecure correctional facility operated by
 46 the department, but does not include a behavioral health transition facility for the
 47 purposes of Section 64-13f-103.
- 48 (4) "Correctional facility" means any facility operated to house offenders in a secure or
 49 nonsecure setting:
- 50 (a) by the department; or
- 51 (b) under a contract with the department.
- 52 (5) "Criminal risk factors" means an individual's characteristics and behaviors that:
- 53 (a) affect the individual's risk of engaging in criminal behavior; and
- 54 (b) are diminished when addressed by effective treatment, supervision, and other support

105 **64-13-6 . Department duties.**

106 (1) The department shall:

- 107 (a) protect the public through institutional care and confinement, and supervision in the
 108 community of offenders where appropriate;
- 109 (b) implement court-ordered punishment of offenders;
- 110 (c) provide evidence-based and evidence-informed program opportunities for offenders
 111 designed to reduce offenders' criminogenic and recidivism risks, including
 112 behavioral, cognitive, educational, and career-readiness program opportunities;
- 113 (d) ensure that offender participation in all program opportunities described in
 114 Subsection (1)(c) is voluntary;
- 115 (e) where appropriate, utilize offender volunteers as mentors in the program
 116 opportunities described in Subsection (1)(c);
- 117 (f) provide treatment for sex offenders who are found to be treatable based upon criteria
 118 developed by the department;
- 119 (g) provide the results of ongoing clinical assessment of sex offenders and objective

- 247 (1) The department shall maintain and operate secure correctional facilities for the
 248 incarceration of offenders.
- 249 (2) For each compound of secure correctional facilities, as established by the executive
 250 director, wardens shall be appointed as the chief administrative officers by the executive
 251 director.
- 252 (3) The department may transfer offenders from one correctional facility to another and
 253 may, with the consent of the sheriff, transfer any offender to a county jail.
- 254 (4) Where new or modified facilities are designed appropriately, the department ~~[shall]~~ may

300 (1) To assure the safe and professional operation of correctional programs, the
 301 department shall establish policies setting minimum standards for the basic training of
 302 all staff upon employment, and the subsequent regular training of staff, including
 303 training on ~~direct~~ appropriate supervision and trauma-informed care.

304 (2) [-]The training standards of correctional officers who are designated as peace officers
 305 shall be not less than those established by the Peace Officer Standards and Training
 306 Council.

307 Section 5. Section **64-14-204** is amended to read:

308 **64-14-204 . Supervision of sentenced offenders placed in community --**
 309 **Rulemaking -- POST certified parole or probation officers and peace officers -- Duties --**
 310 **Supervision fee -- Coordination with local mental health authority.**

311 (1)(a) The division, except as otherwise provided by law, shall supervise a sentenced
 312 offender placed in the community if the offender:

313 (i)(A) is placed on probation by a court;

314 (B) is released on parole by the Board of Pardons and Parole; or

315 (C) is accepted for supervision under the terms of the Interstate Compact for the
 316 Supervision of Parolees and Probationers; and

317 (ii) has been convicted of:

318 (A) a felony;

319 (B) a class A misdemeanor when an element of the offense is the use or attempted
 320 use of physical force against an individual or property; or

321 (C) notwithstanding Subsection (1)(a)(ii)(B), a class A misdemeanor if the
 322 division is ordered by a court to supervise the offender under Section 77-18-105.

323 (b) If a sentenced offender participates in substance use treatment or a residential
 324 vocational or life skills program, as defined in Section 13-53-102, while under
 325 supervision on probation or parole, the division shall monitor the offender's

328 (i) the supervision of offenders in accordance with the adult sentencing and
 329 supervision length guidelines, as defined in Section 63M-7-401.1, giving priority,
 330 based on available resources, to felony offenders and offenders sentenced under

343 adult sentencing and supervision length guidelines, as defined in Section 63M-7-401.1
344 to facilitate the department's prompt and appropriate response to an offender's:
- 345 (a) compliance with the terms of probation or parole; or
 - 346 (b) positive conduct that exceeds those terms.
- 347 (4)(a) The department shall, in collaboration with the State Commission on Criminal and
348 Juvenile Justice and the Division of Substance Use and Mental Health, create
349 standards and procedures for the collection of information, including cost savings
350 related to recidivism reduction and the reduction in the number of inmates, related to
351 the use of the graduated and evidence-based responses and graduated incentives, and
352 offenders' outcomes.
- 353 (b) The collected information shall be provided to the State Commission on Criminal
354 and Juvenile Justice not less frequently than annually on or before August 31.
- 355 (5) Employees of the division who are POST certified as law enforcement officers or
356 correctional officers and who are designated as parole and probation officers by the
357 executive director have the following duties:
- 358 (a) monitoring, investigating, and supervising a parolee's or probationer's compliance

374 substantial hardship, the division shall consider the financial resources of the
375 offender and the burden that the fee would impose, with regard to the offender's

379 dedicated credit to be used to cover costs incurred in the collection of the fee and in
