# LONG TITLE

### **General Description:**

This bill creates the Division of Housing and Community Development within the Governor's Office of Economic Opportunity.

## Highlighted Provisions:

This bill:

- creates the Division of Housing and Community Development (HCD) within the Governor's Office of Economic Opportunity {Division of Housing} by enacting, renumbering, and amending certain {affordable-housing-related} provisions from the Housing and Community Development Division within the Department of Workforce Services and the Governor's Office of Planning and Budget to {the Division of Housing} HCD;

- ▶ defines terms;

- creates the deputy director position within {the Division of Housing} HCD, who is appointed by the governor with the advice and consent of the Senate;

renames the Housing and Community Development Division within the Department of Workforce Services to the {Community Development Division} Division of Community Services within the Department of Workforce Services;

- 23      ▶ {allows the Department of Transportation to dispose of certain surplus property for certain purposes;}

- 21      ▶ repeals certain sections of code to consolidate with other code sections;
- 26      ▶ repeals the Commission on Housing Affordability;
- 27      ▶ requires coordination between the deputy director of {the Division of Housing} HCD and the Utah Housing Corporation (UHC) under certain circumstances;
- 29      ▶ amends the required fields of expertise of public trustees appointed to the UHC board of trustees; {and}
- 27      ▶ moves the Homeless Housing and Services Grant Program from the Office of Homeless Services into HCD; and
- 31      ▶ makes technical and conforming changes.

### Money Appropriated in this Bill:

- 31      ▶ **This bill transfers funds from the Governor's Office - Governor's Office Operations to the Governor's Office of Economic Opportunity, Division of Housing and Community Development in the amount of \$345,000 for fiscal year 2027.**
