### **General Description:**

This bill ~~prohibits~~ addresses public funding for certain transgender medical treatments and procedures.

## **Highlighted Provisions:**

This bill:

- ▶ subject to a limited exception, prohibits the use of public funds to pay for the performance of certain transgender medical treatments or procedures; {and}
- ▶ requires a government entity that, before May 6, 2026, via insurance coverage, paid or reimbursed for a procedure to transition an individual from the individual's biological sex, to offer the same type and amount of insurance coverage for a procedure to restore that individual, to the extent possible, to that individual's biological sex; and

- ▶ makes technical changes.

3. Limitations on Use of Public Funds

A governmental entity may not expend public funds to pay or otherwise reimburse, either directly or indirectly, any person for the performance of:

66 {(1) {hormonal transgender treatment as defined in Section 58-1-603;}}  
67 {(2){(a)} a primary sex characteristic surgical procedure as defined in Section 58-67-102; or  
68 {(3){(b)} a secondary sex change characteristic surgical procedure as defined in Section 58-67-102.  
75 (2) A government entity that, before May 6, 2026, via insurance coverage, paid or otherwise reimbursed a person, either directly or indirectly, for the treatment or a surgical procedure described in Subsection (1) that was performed before May 6, 2026, to transition an individual from the individual's biological sex, the government entity shall offer the same type and amount of insurance coverage for treatment or a surgical procedure to restore that individual, to the extent possible, to that individual's biological sex.
