LONG TITLE

General Description:

This bill amends provisions relating to voting.

Highlighted Provisions:

This bill:

- defines terms;
- provides a process for an election officer to independently determine whether a registered voter is a citizen of the United States;
- provides a process to challenge a determination described in the preceding paragraph;
- prohibits an individual from voting if an election officer independently determines that the voter is not a citizen of the United States and the individual does not successfully dispute the determination;
- creates a {phased-in,} bifurcated ballot system where, for an election held on or after November 2026:
 - a voter chooses whether to provide documentary proof of United States citizenship when registering to vote or before voting; and

a voter who does not provide documentary proof of United States citizenship may only vote in races for federal office;

- 20 ▶ modifies voter registration forms and requirements consistent with the bifurcated ballot system;
- 22 ▶ establishes procedures for administration of the bifurcated ballot system;
- 24 ▶ **establishes or modifies deadlines to cure a ballot or to provide proof of citizenship, as needed, for a rejected ballot or a provisional ballot;**

- 23 ▶ modifies voter registration list requirements in relation to the bifurcated ballot system; and
- 24 ▶ makes technical and conforming changes.
