unauthorized practice of law before the court;

12 ▶ establishes a criminal penalty for the unauthorized practice of law;

13 ▶ clarifies that the statutory provisions regarding the unauthorized practice of law do not limit the  
Supreme Court's authority to regulate the practice of law;

15 ▶ provides a three-year statute of limitations for a civil action for the unauthorized practice of law  
and the exceptions to the statute of limitations;

17 ▶ reorganizes the three-year statute of limitations for certain actions; and

18 ▶ makes technical and conforming changes.

30 Section 1. Section **78A-9-103** is amended to read:

31 **78A-9-103. Unauthorized practice of law -- Action by court -- Civil action -- Criminal  
penalty.**

33 **(1) As used in this section:**

34 **(a) "Board"** means the Board of Commissioners for the Utah State Bar.

35 **(b) "Client"** means a person that is provided, or has been provided, a service constituting the practice of  
law.

36 **(b)(c) "Practice of law"** means the same as that term is defined in Utah Code of Judicial Administration,  
Rule 14-802.

37 **(c)(d) "Unauthorized practice of law"** means conduct that is a violation of Subsection (2).

38 **[¶] (2) Unless otherwise provided by law or court rule, [an individual] a person** may not practice law  
or assume to act or hold [himself or herself] oneself out to the public as **[an individual] a person**  
qualified to practice law within this state if **[that individual] the person**:

41 (a) is not admitted and licensed to practice law within this state;

42 (b) has been disbarred or suspended from the practice of law; or

43 (c) is prohibited from practicing law by court order entered pursuant to the courts' inherent powers or  
published court rule.

(a) If a court determines, by a preponderance of the evidence, that {an individual} a person engaged in the unauthorized practice of law in a proceeding before the court:

50 (i) the court shall award attorney fees and costs incurred by any party as a result of the {individual's} person's unauthorized practice of law; and

52 (ii) the court may:

53 (A) strike any filing by the {individual} person;

54 (B) issue an injunction enjoining the {individual} person from engaging in the unauthorized practice of law before the court; or

56 (C) refer the matter to the board for civil action or to a prosecuting attorney for criminal action.

### 78B-2-305. Actions with a statute of limitations of three years -- Exceptions.

113 (a) Except as otherwise provided in this Subsection (1), an action may only be brought within three  
114 years:  
116 (i) for waste, trespass upon, or injury to real property;  
117 (ii) for taking, detaining, or injuring personal property, including actions for specific recovery;  
119 (iii) for relief on the ground of fraud or mistake;  
121 (iv) for liability created by statutes of this state other than for a penalty or forfeiture under the laws  
124 of this state; or  
127 (v) to enforce liability imposed by Section 78B-3-603 or for damages under Section 78B-6-1701.

121 (b) An action under Subsection (1)(a)(i) does not accrue until the discovery by the aggrieved party  
of the facts constituting the waste or trespass if the waste or trespass is committed by means of  
underground works upon any mining claim.

127 (i) An action described in Subsection (1)(a)(ii) does not accrue until the owner has actual knowledge  
of facts that would put a reasonable person upon inquiry as to the possession of the animal by the  
defendant if:

the time of the animal's loss has a recorded mark or brand; and  
131 (B) the animal strayed or was stolen from the true owner without the owner's fault.

(a){(ii)} {As used in this section, "unauthorized"} "Unauthorized" practice of law" means the same as that term is defined in Section 78A-9-103.

(i) The Board of Commissioners for the Utah State Bar may only bring an action for the unauthorized practice of law described in Subsection 78B-9-103(4) within three years after the day on which the {individual} person engaged in the unauthorized practice of law.

147 (ii) If {an individual} a person engages in continuous conduct that constitutes the unauthorized practice of law, the day on which the limitation period described in Subsection (2)(b) begins when the {individual} person ceases to engage in the unauthorized practice of law.

151 (c) A {person} client may only bring an action for the unauthorized practice of law described in Subsection 78B-9-103(5) within three years after the day on which the {person} client discovers, or through the use of reasonable diligence should have discovered, that the {individual} person engaged in the unauthorized practice of law.
