This bill amends provisions regarding electric assisted bicycles and other devices.

- requires that {individuals} an individual under {21} 16 years old {shall wear helmets} must wear a helmet while operating {electric assisted bicycles} certain devices on a highway;
- creates a safety course for the operation of certain electric devices on a highway and describes circumstances under which the course is required; and
- makes technical changes.
